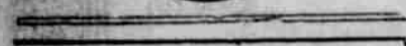

BEN FRANKLIN AND THE COAL STRIKE.

BEN FRANKLIN was a wise old man. When in Paris he gave the following opinion on Democracy:

By equality we do not mean a literal individual equality, for men are born with diverse attainments and powers. We do mean an equality of opportunity, the free play of natural abilities. The most able men rise to the top, the least able men, naturally gravitate to the bottom, but their mutual relation must not be that of master and servant, but of coworkers of different station, working alike for the common weal, and between whom a real bond of sympathy and understanding exists. Such a society means progress, contentment and happiness for all. This arrangement is not only better for the average man, but for those who by character and capacity are above or below.

If such a philosophy of Democracy had been maintained since Franklin's time, the present situation in the coal industry would never have come about. For this situation can be directly traced to the absence of "sympathy and understanding" between the forces of labor and capital.

Both sides are dominated by extremists who care everything for selfish advantage and nothing for the common weal.

On the labor side we have men like B. M. Jewell, who frankly declares that in time of depression labor should not accept its share of the economic burden. Wages can only go one way,—up. Capital must hold the sack even to the extent of eliminating all capital profits.

On the capital side we have a vast majority of the mine operators who, seeing a great strategic advantage in the present business depression, are determined to destroy organized labor in the coal fields. They are willing to go broke a few years, if they can break the union forever.

Both views are essentially wrong, and impossible. No element in a democratic society can share its benefits without sharing its burdens, no other element can indulge the right of organization and deny that right to any group of fellow countrymen.

This sort of thing isn't Democracy, it is autocracy of the plainest kind, a dictatorship by labor on one hand, a dictatorship by capital on the other, resulting not in peace and contentment, but conflict and discontent.

The only solution, of course, is a return to the first simple principles of Democracy as outlined by Franklin so many years ago. It is not an easy road, though the fundamental principle is simplicity itself. But the road must be found and the man who can lead the people along it must be produced, if American institutions are to endure.

Ex-Medford Girl Writes on Music and the Movies

The following article appears in the Town Crier, official organ of the Fine Arts Society, San Francisco, written by Jueneuse Butler formerly of Medford:

To "break into print" is the primal tendency of the reformer or the "man with a mission." The fact that "The pen is mightier than the sword" seems to be so fixed in the human mind that the individual responds intuitively to that silent conviction, and gives his message to the world with such confidence in the world's response, that often his expectations are realized and effort is crowned with result. Self-appointed tasks frequently involve so little self-interest, and indicate such sincerity of purpose, that the looker-on hesitates to doubt their impelling motive, it is not at once perceiving the "why and wherefore" of their existence.

There is an idea afloat, fallacious but familiar, that when a novelty merges into utility, its days, so to speak, are over. The automobile is no longer classified as a novelty, but its possession is none-the-less coveted, along with the telephone, electric lights and manifold inventions which have passed from the miraculous to their accustomed places in the public thought. Progress demands improvements, not displacement.

If the theory of the "survival of the fittest," which is the actuating motive of the standardization, holds good, then the picture-player, who will retain the interest of his audience, become the modern molder of musical appreciation, uphold the dignity which is his to establish or cast down is the one who is now or willing to be awakened to his responsibilities. The disastrous prophecies of human calculations are seldom fulfilled, even through the "show-me" spirit of the pessimistic mentality is more prevalent than the faith of the optimist.
