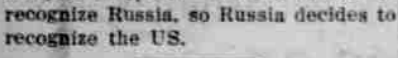

BE GENTLE WITH ELECTRICITY.

NO POWER TO INQUIRE.

ONE of the most curious things connected with the coal strike is the way the government's hands are tied as regards official effort to study its causes.

Some time ago the Federal Trade Commission undertook to gather the facts of prices, costs, production, ownership, etc., in the coal industry. It was for such purposes that congress had created the commission, and in this case Congress had given it specific authority besides. Nevertheless the operators were able, through the Supreme Court of the District of Columbia, to obtain a permanent injunction forbidding the commission to act in the matter. That injunction will stand unless it is removed by the Supreme Court of the United States.

It seems incredible that Congress should really possess no power to authorize such inquiries, as the court has held. Possibly the law is faulty. But if the power is lacking, it ought to be provided, if it takes an amendment to the constitution. Otherwise the Federal Trade Commission, a necessary body, potentially as important as the Interstate Commerce Commission, will never amount to much.

Night Riders in Serious Plight

The Ingleswood enterprise brought nothing but grief. One man, in his grave. The members of the party who set out to punish offenders independently of lawfully constituted authority are facing prosecution on a serious charge. The situation was precipitated because persons in the raiding party did not realize their responsibility for their acts.

In any crowd of men there is usually certain to be one here and there with no sense of discretion. There were highly imprudent persons among the Ingleswood raiders. It is almost the universal rule that in most enterprises like the raid the imprudent are most in evidence and the most likely to be in action. It is one of the chances that prudent men must take when they set out to do the sort of thing that was done at Ingleswood.

If the California law is like that in Oregon those in custody at Ingleswood face serious consequences. There was a killing during the raid.

The Oregon law provides that whenever three or more persons assemble in such manner as is adapted to disturb the peace, or disguised in such manner as to prevent them from being identified, it constitutes unlawful assembly. Whenever three or more persons acting together use force or violence without authority of law it constitutes riot. The penalty for the former is severe and for riot action is serious. The act of the Ingleswood raiders was wholly outside the law and would come within the Oregon statute.

As seen at this distance the affair

at Los Angeles has brought nothing but disaster upon the raiders. There is not a man who was connected with it but must regret the fate that led him into the enterprise. Seizure by the police of the records and papers of the organization fixes the responsibility for high-handed acts committed in the oil fields and will probably lead to prosecutions and convictions there.

The Ingleswood raid was altogether an ill-advised, ill-timed, and ill-fated enterprise, the moral of which cannot be misunderstood.—Portland Journal.

WENATCHEE WANTS HER NAME ON SHIP

WENATCHEE, Wash., May 2.—The local commercial club will make a protest by wire to the United States shipping board at Washington against the proposal to change the name of the steamship Wenatchee to the "President Jefferson." The board has adopted a policy of naming all Admiral line boats after former presidents of the United States.

The club trustees last night decided to prevent this change if possible.
