

### PORT. OREGONIAN ANNOUNCES K. K. PRIMARY TICKET

Election "tickets"—lists prepared by groups—popped up in political circles yesterday like dandelions on a new lawn. And, following the figure of speech, the first to show was the orange colored ticket which has made its appearance regularly for many years.

The orange ticket is vouched for by the Oregon Federation of Patriotic Societies and bears the seal of that organization and the name and address of its secretary, W. C. Elford, 580 Umattilla avenue. There is also an anti-blue law ticket and a red-white-and-blue ticket, the latter apparently being an orphan, as it has no acknowledged sponsor, not even the printer's label.

On the orange ticket, which was circulated at the auditorium Tuesday night, when a Ku Klux Klan lecture was given, the following candidates are endorsed: Congress, Koreff, governor, Hall; state treasurer, Hoff; supreme judges, Burnett and McCourt; labor commissioner, Dalziel; public service commissioner, Thielhoff; circuit judges, Crouch, Tucker, Dewitt and Hawkins; state senators, Klepper, Wilson and Clark; representatives, Adams, Brownell, Campbell, Hurlburt, Hughes, Kirkwood, Kuhl, Kuehn, D. C. Lewis, H. A. Lewis, Lynn Stimmom and Woodward; joint representative, Meindl; county commissioners, Rankin and Walker; auditor, Martin.

Neither Judge Tucker nor Auditor Martin has opposition.

It is said that the Ku Klux Klan intends to follow the orange ticket to a large extent but will break away on some spots.—Portland Oregonian.

### Samuel Gompers Makes a Vigorous Attack on Prohibition

NEW YORK, May 5.—Samuel Gompers, veteran president of the American Federation of Labor, speaking Wednesday night to a crowd that jammed Madison Square Garden in a mass meeting called by the New York branch of the association against the prohibition amendment, declared that "labor must make the fight now and we will never stop fighting until the rights of the people have been restored to them."

He was cheered by crowds both inside and outside the big pavilion, for those who could not enter the hall heard the speakers through voice amplifiers. The meeting was largely attended by members of union labor, representatives of more than 30 labor organizations being present. There also were many men prominent in the city's business and financial circles who occupied places on the stage. A large part of the audience was composed of women.

To Fight Laws.  
"I and the federation I represent," Mr. Gompers said, "are in favor of

beer and light wines and against any attempt to enforce sumptuary laws aimed at the personal liberties of our people."  
"I have always had faith in the future of my country, but with prohibition I am apprehensive of that future. Temperance was the rule of the great mass of organized labor, but the prohibitionists and the so-called anti-saloon leaguers have done more to undermine the morality and temperance of the working man than any other agency I know."

Finds Drunkenness.  
"I have traveled all over the United States before prohibition, including its so-called dry territories, and today as I pass through these sections I find more drunkenness than ever before."  
"There are no stronger or more powerful supporters of the Volstead act than the distillers and bootleggers," Mr. Gompers declared to the accompaniment of vociferous applause. "With the Volstead act and prohibition replaced by a little light wine and beer bill, the bootleggers would go out of business."

### The Menace of Mob Rule

If there is ever a call for punishment by an invisible court it is not before the regularly constituted legal tribunal has passed upon the case. Mob violence and ku klux klanism cannot be justified under any condition when the legal machinery of the state is operative, and the assumption of power by any set of men in dealing out assumed justice is a criminal act in itself, and as such should receive the punishment the act deserved. The recent Los Angeles case where a body of disguised individuals sought to correct certain alleged violations of the law according to their code of right met the natural sequence of such action, and one man, himself a peace officer, and two others of his disguised comrades, were shot and the peace officer killed. Whether this mob was a part of the so-called invisible government or was composed of individuals prompted by self-conceived desires to redress wrong mat-

ters not nor has it been determined; their act was wrong, illegal and without provocation. The courts are constituted to deal with all infractions of the law, and the taking upon themselves the power delegated to the courts places them beyond deserved protection and make of themselves lawbreakers doubly guilty of the law's violation they sought to punish. This mob may not have been made up of ku klux but whether they were or not the ku klux klan will receive the odium of the act, because they masquerade in disguise and their identity is difficult to establish, and the accomplishment of better things which they profess to be their object, will not be acquired through invisibility. If their purpose is a worthy one let it be done in the open and they will receive the reward to which they are entitled; otherwise they must bear the stigma that their actions place upon them.—Sheridan, Oregon, Sun.

### Is a Park for Sheep, or Tourists?

The people of Roseburg are making a new and harder fight to keep Diamond Lake out of the Crater Lake National park. We trust their efforts will be futile, because no bigger mistake could be made if Oregon wishes to promote tourist travel. This whole area along the summit of the Cascades from Crater Lake to the McKenzie pass should really become a part of the national park in order to give it the area and attractions necessary to draw and hold visitors for a reasonable length of time. No Crater Lake Park is generally good for but one night's stay and it is not susceptible of any great development unless enlarged, according to the statements of the park officials. With a larger area along the skyline boulevard included the greatest playground of the Pacific coast would be developed in a few years by the park organization, which is willing, in fact quite anxious, to undertake the task.

### MINISTER POINTS TO K. K. DANGERS

PORTLAND, May 12.—"I have always associated masks with banditry or revelry," declared Dr. Ernest M. Halliday, general secretary of the extension board of the Congregational church, who took a rap at the Ku Klux Klan in his address at the luncheon of the Rotary club at the Benson hotel Tuesday.

"I don't believe it necessary to be long to this ghostly fraternity to enforce the law," he said.

"Such an organization is laying it

self open to abuse and misrepresentation, however laudable its purpose. There are many who will take advantage of the incognito to perpetrate their own unlawful acts."

The speaker declared that centuries ago the right to trial by law was wrested from autocracy.

"We must retain these rights if we are not to undermine the principles of our government," he continued.

The speaker expressed the belief that if America falls now it will be not through the breaking up of the republic, but the deterioration of active good citizenship.
