IT'S UP TO THE PEOPLE.

THE primary campaign closes today as far as this paper is concerned. We have no last-minute minis to explode. Sufficient unto the day is the joy thereof and the day that ends this primary, is for all sensible people a day of great rejoicing.

Our main effort has been to bring the facts before the people and point out to them, regardless of politics, regardless of personalities, the dangers confronting this community and the state, at this election.

Now let the people decide. We are confident that the voters of Oregon both at this election and at the election in November, will emphatically declare that they are still competent to conduct their own affairs, under the constitution and laws of their forefathers, and ask no assistance from any outside force, north or south, visible or invisible.

This must be a government of the people, by the people and for the people,—all the people,—or it can be no government at all. Every privilege the people have, every protected right, every advantage over old world autocracy,—all have been achieved, only because all government has been free, out in the open, subject at all times to popular inspection and control, and only by maintaining these principles inviolate, can American institutions be maintained.

No person shall wear upon any public street or alley in the City of Medford, or in any theatre or public place any mask, cap, cowl, hood or other thing or device concealing the identity of the wearer.

Dr. Keene Replies to D. M. Lowe To the Editor: There is one feature of the D. M. Lowe letter that requires an answer. His veiled defense of the perpetrators of mob violence needs no consideration; but the question of high taxes does need some consideration.

I think I am safe in saying that I pay as much tax as D. M. Lowe does, and I am deeply interested in a reduction of the tax burden on the people of Jackson county; and since Mr. Lowe's suggestion I am constrained to call the attention of the voters of Jackson county to Mr. Thomas' record in the legislature upon the tax question, quoting from the "Oregon Voter" which is authentic and which gives a resume of Mr. Thomas' activities as a senator, where I find the following:

"In 1921 sessions voted for 40 salary increase bills. Against 14. Absent 4. And again Mr. Thomas was: "One of only five senators to vote in favor of considering a resolution to bond Oregon for \$40,000,000 to embark into the hazardous electrical power business, a measure which would have imposed heavy cost risks upon the taxpayers and would have held back water power development by private capital."

If Mr. Lowe's interest in the dear taxpayer is as sincere as he would have the people believe by his article in the paper, it will not be a difficult matter to determine where his vote will be cast, for this \$40,000,000 which his candidate sought to inflict upon the people of the state of Oregon would have increased the burden of taxation to the people of the state for a continuous annual drain upon their purse strings for a period of twenty years; and this \$40,000,000 obligation would have taken \$2,000,000 annually from the taxpayers' pockets to pay the interest charge, and another \$2,000,000 annually to pay the sinking fund required to meet the principal obligation. The measure is one which would have snuggled up very closely to the taxpayer's person, and would have caused an exclamation of financial pain to proceed from every taxpayer in Oregon.

And I would also call the attention of Mr. Lowe and the voters of Medford particularly to the effort of Mr. Thomas a few years ago to saddle upon the taxpayers of Medford a bonded debt of \$300,000 for which the city would have received no benefit whatsoever, and the property owners would have been required to pay the bill through taxation.

Mr. Lowe and citizens of his kind are evidently of the opinion that if a man is charged with a crime he is presumed to be guilty from the very day that the indictment is returned against him, and that he is not entitled to a fair trial before a jury of his countrymen.

Under the laws of Oregon, and in fact under the laws of every other state in the union, a man is presumed to be innocent until he is proven to be guilty by witnesses before a jury, and it matters not whether a man is charged with arson, mob violence or bootlegging, he is entitled to a defense and to a fair trial.

DUKE OF RICHMOND TO SELL ESTATES LONDON, May 18.—(By Associated Press). Another duke has announced his intention to sell his estates owing to increased taxation and other burdens. The Duke of Richmond is the latest recruit to the ranks of the "new poor." He offers for sale his estates in Aberdeenshire, including the town of Huntley and six parishes, comprising 60,000 acres with 400 farms and small holdings. The duke is one of the most prominent men in England. He is a particular friend of King George.

HAWLEY CONFIDENT OF NOMINATION

SALEM, May 18.—(Special)—The contest over the republican nomination for representative in congress for the First District, comprising seven counties in western Oregon, has been attracting much attention here since A. W. Norblad of Astoria filed for the nomination early in April. Carl G. Glover of Washington county is also an aspirant for the nomination but has been making no active campaign over the district.

Representative Willis C. Hawley of Marion county, incumbent, announced a number of weeks ago that he believed his duty required his presence in Washington where he stated he had more than \$5,000,000 for public improvements in the district in pending legislation, besides much additional legislation of great importance to his constituency, and that he would not return to Oregon before the primaries.

Mr. Norblad has been making an active personal canvass of the district while Representative Hawley has conducted his campaign by means of correspondence and through his thousands of friends over the district, his Oregon headquarters being at Salem, Oregon, in charge of his former secretary, Ronald C. Glover, who has been practicing law in Salem since the conclusion of the World War in 1918.

Representative Hawley advises he has received thousands of letters and other communications from all parts of the district, assuring him of the continued friendship, confidence and support of the people, and Mr. Glover advises that hundreds of letters and personal calls have reached the Oregon headquarters, all of which are favorable.
