OLCOTT LEADS IN NECK AND NECK RACE

GOVERNOR IS 125 VOTES IN THE LEAD

Closest Race in Political History of Oregon Keeps Contending Factions On Edge—One Goes Ahead, Then Another—Final Outcome Waits On Official Count.

PORTLAND, Ore., May 22.—(By the Associated Press.)—Results from 21 counties complete at 2:30 today gave Chas. Hall 42,278 and Governor Ben W. Olcott 42,153 for the republican nomination for governor. This was a lead of 125 for Olcott, compared with a lead of 85 on the last preceding compilation.

PORTLAND, Ore., May 22.—(By the Associated Press.)—Seeing back and forth, the lead in the race for the republican nomination for governor swung between Charles Hall and Governor Ben W. Olcott today as returns from the remote sections of the state were tabulated. The latest compilation made early this afternoon placed Olcott in the lead with 35 votes after Hall had held the lead on the preceding summary. The latest figures were: Hall, 42,282; Olcott 42,157.

20 Counties Complete.
Twenty counties had been reported complete early this afternoon and of these Hall had carried nine and Olcott eleven. Of the sixteen counties from which incomplete returns had been received political observers believed from the trend of the voting that Hall would carry three and Olcott 13.

The tentative lineup gives Hall Clackamas, Columbia, Coos, Curry, Douglas, Josephine, Lane, Multnomah, Clatsop, Clatskanie, Tillamook, while the following are claimed for Olcott: Benton, Deschutes, Hood River, Klamath, Linn, Marion, Morrow, Sherman, Wasco, Washington, Yamhill, Baker, Gilliam, Grant, Harney, Jackson, Jefferson, Lake, Lincoln, Malheur, Polk, Union, Wallowa and Wheeler.

The last three listed for Hall are incomplete as are the last thirteen in the Olcott column.

PORTLAND, Ore., May 22.—According to a tabulation of latest returns from 18 complete and 18 incomplete counties of the state at 11:15 o'clock today Charles Hall of Marshfield had taken the lead in the race for the republican nomination for governor. The figures: Hall, 42,325; Olcott 42,246, a lead for Hall of 79.

PORTLAND, Ore., May 22.—Governor Ben W. Olcott got into the lead for the republican nomination for governor on returns tabulated at 3:40 today of votes cast in last Friday's primary, his total on this tabulation, which included complete returns from 18 of the 36 counties of the state being 42,324, compared with 42,049 for Charles Hall, state

DISAGREEMENT IN BURCH JURY FOR 2ND TIME

Alleged Murderer of J. Belton Kennedy Freed Once More and Date for New Trial Set for Next Saturday—Vote 7-5 for Acquittal.

LOS ANGELES, May 22.—The jury in the trial of Arthur C. Burch for the murder of J. Belton Kennedy was discharged by Judge Sidney N. Reeve

today after reporting it was impossible to agree upon a verdict. Jurors said that the final ballot was 7 to 5 for acquittal. The division was unchanged since Saturday when the first ballot of six to six was changed by one more juror swinging to favor acquittal. The four women on the jury voted for acquittal, the case was voted on the calendar for next Saturday to be set for a third trial.

After adjournment the four women jurors gathered about the Rev. and Mrs. W. A. Burch, parents of the defendant, and shook hands with them. One of the women jurors said to Mrs. Burch, "we all feel very sorry for you."

Deputy District Attorney Asa Keyes, who conducted the prosecution, said: "There will undoubtedly be another trial of Burch." He went to

ULSTER M.P. MURDERED IN BELFAST

W. J. Twaddle, Member of Ulster Parliament, Murdered On Way to Office—Premier Sir James Craig Issues a Manifesto Advocating Retribution.

BELFAST, May 22.—(By Associated Press.)—Killing today of W. J. Twaddle, a member of the Ulster parliament, who was shot while on his way to business, caused the issuance of a manifesto by Sir James Craig, the premier, announcing a special meeting of the cabinet and the legal authorities. The premier declared "just retribution" was called for.

Mr. Twaddle passing through Garfield street, was nearing his place of business on North street when two men approached and fired seven shots at him from a range of two yards all the bullets taking effect.

The victim collapsed immediately and the assassins decamped before the horrified spectators realized what had happened.

Manifesto Issued
The premier in his manifesto said: "My detestation of this horrible crime fills me with such indignation that I have summoned a special meeting of the cabinet and all the authorities dealing with law and order. Such an event as this murder demands just retribution."

The manifesto says Mr. Twaddle was murdered for his loyalty to the empire and his devotion to the cause of Ulster and the welfare of the country. His colleagues, it was declared, will carry on and face the future, no matter what the future might hold for them.

"Justice and retribution rest with the higher authorities," the manifesto adds. "Let the people rally around the established government which will see that proper measures are taken without plunging our province or our capital into a welter of crime and bloodshed."

Special Ceremony
As a tribute to Mr. Twaddle's memory the premier said the people of Belfast and the six counties would observe today and tonight with special reverence.

"I will deal with the whole matter when the parliament meets tomorrow. I feel satisfied that the government has made a sufficiently comprehensive move to meet any eventuality that may arise."

The manifesto concludes by announcing that the parliament will adjourn Tuesday after passing a vote of condolence with Mrs. Twaddle and the relatives of the murdered member.

De Valera Wins Out
LONDON, May 22.—(By Associated Press.)—The agreement reached in Dublin Saturday by leaders of the political factions is regarded by the most of the editorial writers of today's London newspaper as the surrender of Michael Collins to Eamon DeValera. They do not see how it will enable the Irish people to express their will respecting the Anglo-Irish treaty.

The Times declares that those responsible for the outrages in the north acted identically with the extremists in the south, the object in each case being to overcome the north's resistance to union by coercion and violence.

DEPORTATION C. CHAPLIN'S MOTHER UP

Immigration Authorities Investigating Circumstances Surrounding Aged Shell Shocked Mother of Famous Film Star—Sons Want Her to Remain in the U. S.

WASHINGTON, May 22.—Immigration authorities are investigating the conditions upon which Hanna Chaplin, the aged and shell-shocked mother of Charles Chaplin, motion picture actor, and Sidney Chaplin is allowed to remain in the United States. This became known today with the issuance of an order by E. J. Henning, assistant secretary of labor, granting stay of time to enable Mrs. Chaplin and counsel employed by her sons to present legal grounds for permitting her to be a semi-permanent resident in the United States.

Mrs. Chaplin, herself an actress, it was explained, was mentally deranged by shocks suffered during one of the first of the German aerial raids on London during the war. When the war ended her sons desired to take her to California to give her environment and treatment which would ease her condition and possibly, it was hoped, restore her reason. She was after some difficulty given permission to enter the United States and remain for one year.

The Chaplin brothers, upon her arrival in the United States gave assurance that she would never become a charge on public charity and installed her in a cottage at Santa Monica, Cal., under care of trained nurses and with expert medical and neurological attention.

The attending physicians report it was said, that her mental condition has improved steadily, despite her age, and counsel also have presented a statement that Charles Chaplin is worth more than \$1,000,000, contending that the extraordinary circumstances justify some yielding in the legal barriers against admission to the United States of aliens, either permanently or temporarily mentally unsound.

A decision in Mrs. Chaplin's case, it was said, was expected to be announced shortly by the immigration board of review.

GEORGIA MAYOR'S HOUSE IS BOMBED

COLUMBUS, Ga., May 22.—Commissioners of Muscogee county today placed the entire resources of the county at the disposal of the city commissioners of Columbus in an effort to bring about the arrest of those responsible for the bombing early yesterday of the home of Mayor J. Homer Dimon.

The bomb wrecked a section of the mayor's home, but without injury to any member of the family. Recent letters to the mayor contained strong objections to the commission form of city government and declared unless the city manager was discharged, both he and the mayor will be killed.

Wheat Ship Burns Up
OGDENSBURG, N. Y., May 22.—The steamer Conestoga, loaded with wheat bound from Port Colborne to Montreal was destroyed by fire in the Cardinal canal here yesterday. The loss is estimated at \$250,000.

Several of the crew were badly burned. The cause of the fire is unknown.

Oil Collectors Robbed.
CHICAGO, May 22.—Two collectors for the Sinclair Oil company today were held up and robbed of \$15,000 by two bandits who escaped in an automobile.

The robbery occurred on a busy street.

Drinking, Majority American Colleges, Is Now a Lost Art

BOSTON, May 22.—Drinking among college students has diminished materially since the 18th amendment was enacted and in a majority of colleges drinking has practically disappeared, according to President F. C. Southworth of the Meadville Theological school, in his report of an investigation made to the Unitarian Temperance society.

98 DROWNED IN SHIP COLLISION FRENCH COAST

British Steamer Egypt, Hit By French Steamer, Sinks in 20 Minutes—Life Boats Inadequate—2 U. S. Missionaries Among Missing.

BREST, May 22.—(By the Associated Press.)—Ninety eight persons are missing and 242 were saved of those who were on board the British steamer Egypt when it was sunk off the island of Ushant, Saturday night by a collision with the French steamer Seine, according to the latest figures.

Among those missing are two American women, Mrs. M. L. Sibley and Miss V. M. Boyer, whose home addresses are unknown here. It is possible that some of the missing, in addition to those brought here, may have been picked up by the steamer Cap Iracou. The Cap Iracou was nine miles away from the scene and replied to the distress signals with the assurance that she was speeding to the spot. According to the Egypt's pursuer the ship floated only about 20 minutes after her plates were crushed in by the Seine. The Egypt, he declares, was not moving at the time of the accident, lying to on account of the dense fog and sounding her siren continuously.

Mrs. Sibley and Miss Boyer were missionaries on their way to India. The Egypt went down in 400 feet of water. She carried \$200,000 in gold besides a consignment of mail for India. So far one mail pouch has been picked up, but nothing else except the wreckage from the crash was found on the surface.

The ship's officers did not save even the vessel's papers. It is not questioned by most of the survivors, however, that many of the 500 odd persons were thrown into the sea or jumped from the sinking ship when they were unable to obtain places in the few lifeboats that were lowered.

Earthquake in Chile
SANTIAGO, Chile, May 21.—A severe earthquake lasting five minutes was felt here at 10:50 o'clock this morning. No damage had been reported.

BRITISH TROOPS SENT TO IRELAND AGAIN, EXPECT RESUMPTION OF WAR

LONDON, May 22.—(By the Associated Press.)—The government has invited Irish signatories to the Anglo-Irish treaty to come to London and discuss with the British signatories the agreement signed Saturday between representatives of the provisional government and the followers of Eamon DeValera, it was announced in the house of commons this afternoon by Winston Churchill, secretary for the colonies.

While every endeavor will be made, he added, to avoid unnecessary expense and sensational act, it is the intention of the British government to support the government of northern Ireland in every way necessary. This he thought raised the official

FRANCE MAY SEND ARMY AFTER CASH

French Cabinet Believed a Unit in Bringing Military Pressure to Bear On Germany—Question of Allies Joining Is Only Problem—J. P. Morgan in Paris.

PARIS, May 22.—(By the Associated Press.)—The French parliament will reconvene tomorrow in an atmosphere of anxiety, chiefly over the prospective use of military to bring pressure on Germany.

Expiration of the time given Germany to accept the reparations commission's conditions is only one week off, but there will be no immediate action, since Premier Poincare, although determined to go ahead alone if necessary, will take time to induce the allies to join him if he can.

The cabinet is regarded by the best posted members in parliament as sure of a big majority in approval of its policy of energetic action. Some energization is felt lest this situation make still more acute the difference which has arisen in the entente.

PARIS, May 22.—(By the Associated Press.)—The allied governments represented on the reparations commission are looking with considerable hope upon the prospect of a permanent solution of the German reparations questions growing out of the meetings of the committee of international financiers including J. P. Morgan of New York, which will begin in Paris Wednesday. The circumstances under which the committee was formed indicate that the governments of France, Great Britain, Italy and Belgium are disposed in advance to receive the conclusions of the committee with great deference.

Sir John Bradbury, British minister, member of the reparations commission was under stood to have made the first suggestion that the commission should invite eminent persons in both allied and neutral finance to examine into the question whether an international loan could be issued for Germany to facilitate over a long term of years her cash payments to the allies.

PARIS, May 22.—Roland W. Boyden, an observer for the United States government, took part in the deliberations and gave his unofficial opinion. The commission requested Mr. Boyden to ask the state department at Washington if it would approve of an American member of the commission. The state department replied expressing unofficially its unwillingness, it is stated, that an American financier should be invited as a private individual.

The commission in determining who should be invited from America, agreed that no one having direct relations with Germany finance could be considered and decided upon Mr. Morgan as the banker representative of American finance as having a clear appreciation of both the American and allied interests. The invitation was transmitted to Mr. Morgan through the state department and he accepted as soon as he knew that it was looked upon favorably by the American government.

The German government was consulted and it accepted the invitation to have an official representative.

According to the accounts of the outrages by republicans in Ulster, Mr. Churchill said the government had every confidence that the northern parliament would continue to grapple with the task of maintaining order.
