R.R. LABOR BOARD IN HOT FIGHT

Majority Members Lash Minority Report Charging Bad Faith and Bolshevism—Wage Cut Moderate and Proper—Minority Accused of Inciting Men to Strike.

CHICAGO, June 17.—(By the Associated Press.)—Majority members of the United States railroad labor board who yesterday ordered another slash from wages of the nation's railway workers, today retaliated to criticisms of minority members of the board with the charge that the dissenting members presented "incendiary arguments in a strained and exaggerated effort to inflame the employees to strike against the decisions of the board."

The minority, constituting two of the three labor members, were accused of "sowing some of the tiny seeds that have germinated and blossomed into industrial anarchy in Russia."

Yesterday's decision, which lopped nearly \$27,000,000 from the wages of 325,000 railway clerks, signalmen and stationery firemen, brought total reductions effective July 1 under the board's orders, up to \$135,000,000. Approximately 1,200,000 railway employees are affected by the orders.

Accompanying yesterday's order, carrying reductions ranging from two to six cents an hour, was a lengthy supporting opinion from the members representing the railroads and the public, and the dissenting opinion by the labor members condemning the order.

In their prompt rejoinder today the majority members said:

Urging Men to Strike.

"There is one feature of the dissenting argument, which is so unusual that it should not be passed over without notice, and that is the portion wherein the two dissenting members advise the employees to strike against the decision of the board."

"It is something new for labor members of the board to issue incendiary arguments to employees in favor of striking against a decision of the board. The giving of advice of this kind has heretofore been left to outsiders, who were not under the official obligations imposed by the transportation act, the main purpose of which is to prevent railway strikes and protect the public from their dire effects."

"A fair statement of the facts will convince any disinterested man that no injustice has been done to these employees by the present decision and that the decrease in their wages is conservative and is based upon the law and the evidence."

Recognition of budgets proposed by the minority would result in the loss of hundreds of millions of dollars to the railroads each year, the majority members continued.

"This shortage would have had to be paid by some form of taxation on the public, presumably freight rates, which would have added to the burdens of every individual in the country, rich and poor," they said.

Common Sense Should Rule.

"It is well to remember," the statement continued, "that the time will never come in this or any other country when ordinary rules of common sense and business, call them economic laws if you wish, can be absolutely ignored in the conduct of any industry. The latest instance in which these laws have been thrown overboard and replaced by fine spun socialistic theories both in railway and other industries is found in Russia, and the result there is not one that this country desires to emulate."

"The minority are sowing some of the tiny seeds that have germinated and blossomed into industrial anarchy in Russia when they make such statements as this: 'They (the economic laws) are simply a description of the way in which business and industry have worked to date, and it has worked out very badly for human life.'"

"It will be readily conceded that our social and industrial system has

LABOR CAN'T BE CRUSHED BY LAW LEADERS STATE

A. F. L. Determined to Find Way to Escape Supreme Court Decision—Congressional Veto of Supreme Court Decisions Suggested.

CINCINNATI, June 17.—(By the Associated Press.)—Labor's interpretation of the supreme court decision in the celebrated Coronado coal case, holding international unions subject to damage suits under the Sherman anti-trust law, was presented today to the federation's labor convention by the federation's executive council, composed of its 11 officers.

"The supreme court cannot crush the labor movement without endangering the foundations of society," declared the report. "The workers will not accept slavery. Therefore, they will find a way to preserve those liberties which they have and to gain more as time passes."

No means for overcoming the decision was suggested by the council on account of the creation by the convention of a special policy committee for this purpose, but the council declared, it was "extremely alive," to the attitude of courts as outlined to the convention by Senator La Follette, of Wisconsin, who urged a congressional veto of supreme court decisions.

Organizations of farmers and other unincorporated associations of individuals were said by the council to face the same plight as the trade unions, for it was said the opinion applies to them with equal force as it does to labor organizations.

Section six of the Clayton act, construed by the report as exempting labor union from the anti-trust laws, was declared to have been passed by congress "to ratify the wrong" done by the supreme court in the famous Danbury haters' case, holding the workers liable for damages as individuals and as a union.

"Evidently the supreme court does not intend to be bound," the report added, "by the legal enactments of congress, and feels it self superior to the judgment of the law making body of the land."

Declaring that the Coronado decision made union funds subject to damages resulting from unlawful acts of individuals about whom the union knew nothing, the report added that organized labor sought no extraordinary protection, but contended the individuals should be punished under criminal or civil law.

IRISH MAD AT ELECTION, RAID BOXES

Apparent Defeat for Radicals Leads to Violence and Bloodshed—Voting Papers Dublin University Seized By Irregulars—Bitter Enders Threaten War Again.

DUBLIN, June 17.—(By the Associated Press.)—Complete returns from yesterday's parliamentary elections in South Ireland are not expected before next Tuesday night at the earliest, but indications are that the republicans will suffer losses.

The chief indication was furnished by the vote at the national university in Dublin, where the voting papers were seized by raiders, headed by Rory O'Connor of the irregular republican army. A decision as to the candidates elected had been reached before the raiders arrived.

The announcement showed that Dr. Ada English, republican, has been displaced. She was prominent in the Dail Eireann in resistance to the treaty, while Prof. McGinnis, who was returned in her stead, was an active supporter of the Anglo-Irish pact.

It was explained today that the object of the raiders, representing the dissenting section of the voters was to discover how the university electors had voted and whether all the Sinn Feiners among them had observed the Collins-De Valera pact. This was the only constituency capable of providing this information, as contrary to the rule prevailing elsewhere, the university voters sign their names to the voting papers.

SMASH RECORDS NATIONAL MEET AT STAGG FIELD

CHICAGO, June 17.—With 13 of the 15 events decided, California led in the scoring with 22 5-9 points, with Penn state second with 19 1/2. Notre Dame was third with 16, Illinois fourth with 12 1/2 points.

CHICAGO, June 17.—With Illinois and California favorites to first honors, 330 athletes, the best of America's collegiate stars, met on Stagg field today in the second national collegiate track and field classic.

A cooling breeze swept the field from the northwest in contrast to the sweltering heat for the trials yesterday, and conditions were favorable for record breaking.

California started to break into the point column early when Johnny Merchand, the versatile Golden State athlete, won the shot put with a heave of 44 feet, 5 1/2 inches. McDonald, another California man, took second place in the quarter mile run, and Witter, a teammate grabbed third place in the shot put. This gave California ten points against five for Illinois.

The first record to be shattered was in the mile run, which was won by Shields of Penn State from a field of 18 starters. Shields covered the distance in 4:20 2-5, beating the former record of 4:22 2-5 established by Watson of the Kansas Aggies in the meet last year.

Paula, the Grinnell sprinter cracked the second record when he took the finals of the 100 yard dash in 9-9-10, breaking the mark of 10, established by himself in the meet a year ago. Bill Hayes of Notre Dame was a close second.

CHICAGO, May 17.—After Brick Muller of California had cracked the record for the running broad jump, by leaping 23 feet 8 1/4 inches, Legendre of Georgetown collapsed this performance by jumping 24 feet, 3 inches, nearly a foot over the collegiate record of 23 feet 3 3/4 inches, made by Stinchcomb of Ohio state last year.

With six of the 15 events decided, California led in the point score with 12 1-18. Pennsylvania state was second with ten and Illinois third, with 9.

The fourth record to fall was in the discus throw. Lieb of Notre Dame threw the discus 144 feet, 2 1/2 inches, 2 feet and a quarter inch better than last year's record by Pope of Washington. Afterward in an exhibition heave, Lieb threw the plate 150 feet 2 1/2 inches.

Paula established his second record of the day when he copped the 220-yard dash in 21 4-5 after winning the century in the record-breaking time of :39 9-10. Paula's time in the 220 yard event was only a second slower than the world's record, held by Charlie Paddock of California, and he beat the collegiate record of 22 2-5 made by Wilson of Iowa a year ago. Paula's feat was the fifth record breaker of the meet.

Scratches Match On Keg of Powder, for Wet Goods Within

KIDNAPPER 2 WOMEN SHOT DOWN

Fred Brown Pursued Through Three States, Captured North of Medicine Bow, Wyoming By U. P. Detectives—Attempts to Escape—Shot Near Heart.

CHEYENNE, Wyo., June 17.—Fred Brown, sought through three states since his alleged kidnaping of two women in Omaha, Nebraska, was captured last night in the wild country north of Medicine Bow, Wyoming, after he had been shot above the heart by a member of a posse searching for him, as he made a last dash for liberty. The capture was announced today by officials of the Union Pacific.

W. J. Clement, Union Pacific special agent at Cheyenne, Sheriff A. S. Saunders of Carbon county and Deputy Sheriff Cooper, who had been following Brown since he was traced to Medicine Bow by means of the license number on his car early last night, came upon the bandit as he was attempting to extricate his automobile from the mud in which it had stalled on the road north of Medicine Bow.

Leaping from their automobile, the officers covering Brown with their guns and ordered him to stand away from his machine in which his guns were concealed. Brown apparently started to obey, according to the account of the capture received here, then made a dash for a big rock some distance from the road.

A bullet fired from a rifle by a member of the searching party caught him above the heart and he fell to the ground. He was taken back to Medicine Bow in the officers' automobile for emergency treatment and then was put on a freight train to be taken to Rawlins, Wyoming.

WOMAN KIDNAPPED ON GOLF COURSE ESCAPES AND ACCUSES HUSBAND

CINCINNATI, June 17.—Accompanied by her brother and her attorney, Mrs. Clara Marshall returned to Cincinnati early today from Magnesia Springs, Indiana, where, she said, she escaped from an automobile in which she was abducted forcibly by four men yesterday when playing golf at a country club here. Two of the men, she said, left the machine just outside the city limits.

From the Indiana village late last night, Mrs. Marshall telephoned her father, William B. Schawe, treasurer of a Cincinnati shoe manufacturing company that she was safe, although showing the effects of her struggles with her captors, and that one of the men was her husband, Albert Marshall, from whom she had been separated for several months and had sued for divorce.

No motive for the act was assigned in telephone conversation, and upon her return to Cincinnati, Mrs. Marshall was said to be in a highly nervous condition, bordering on collapse and could not be questioned.
