## P. T. BARNUM AND ADVERTISING.

IT IS REFRESHING in these tense and somewhat depressing times to turn back to the days of P. T. Barnum.

In the current "Atlantic" there is a most diverting sketch of America's greatest showman.

P. T. had the hide of a rhinoceros, the exuberance and brass of a Billy Sunday and the unflinching optimism of Colonel Mundy. Criticisms fell from his Yankee back like water from a duck, misfortunes only made him smile, he didn't care what people said, he didn't care what happened, for the good and the bad he proceeded to enter on the right side of the ledger as "advertising."

The only thing P. T. B. couldn't abide was obscurity. As long as he and Junbo and Tom Thumb, and the greatest show on earth, were in the limelight he didn't care whether the people clapped their hands or shook their fists.

"It's a great thing," said he "to be called a humbug. I've been called so often. It means hitting the public in reality. Anybody who can do so is sure to be called a humbug by somebody who can't. \* \* \* After all it was a good advertisement for me, as well as for Higginson; and it would have been difficult to serve me up about these times in printers ink in any form that I should have objected to."

Printers ink. There was the key to Barnum's success. If he had lived today, he would undoubtedly have been awarded the Pulitzer prize for no man was of greater service to the newspapers.

In 1885 he wrote: "Fully appreciating the powers of the press (to which more than to any other one cause I am indebted for my success in life) I did not fail to invoke the aid of printer's ink. Without printer's ink I should have been no bigger than Tom Thumb. \* \* \* Advertising is to a genuine article what manure is to the land—it largely increases the product."

A man complained to him once that he had a good article and had advertised it, but could not sell it.

"How did you advertise it?"

"I put it in a weekly paper three times and paid a dollar and a half for it."

And Barnum's comment was: "Sir, advertising is like learning—a little is a dangerous thing."

The striking unions in written response sent to the White House were said by this official to have told the president they could not call off the strike unless a guarantee was given that all of their men would be

reinstated in service with seniority rights unimpaired. The president had proposed that the seniority status of the returning strikers be left to adjudication by the railroad labor board.

## Smudge Pot Horrified by Scandal Crop in Los Angeles

LOS ANGELES, Aug. 9.—In Los Angeles, sufficient unto the day is the scandal thereof. In the last 24 hours, there has been a couple of mild, rippling sensations duly featured in the papers. Bill Hart, beloved of the cow country, admits separation from his wife—a screen beauty. This was the afternoon thrill, and in the morning the populace went to their work, with renewed vigor after reading of a visiting lady, who went auto riding with strange men, and forgot to jump out. They found her in the early morning, unconscious under a tree in the suburbs. The police are investigating.

In Los Angeles, there is considerable interest in lady murderers, who have had, or are having their day in court. Mrs. Peete serving life for the slaying of a mining engineer—a high handed person, the reports say—ran afoul of San Quentin prison regulations, and no longer enjoys the meager privileges of a "lifer." This was an explosive story in a penny paper, and in the next editions, journalistic rivals came right back with more sigh and sob stuff. Madalynne Obenchain, alleged to have inspired one "sweetie" to shoot another one, was portrayed as leading a battle in the county jail, winding up in a free-for-all hair pulling contest, finally stopped by the matron. Mrs. Carrie Phillips, who awaits trial for beating out the brains of an alleged rival with a ten cent hammer, was not belittled, but her aged mother—80 years old—has found out why "Carrie doesn't come home."

The gossip, credited with being the cause of the brutal crime, seem to have overlooked a chance to exercise their passion for sowing misery or the elderly mother would have been informed long ere this of the whereabouts of "Carrie." People, acquainted with the traits and habits of fullgrown tale mongers, are skeptical. They do not see how possibly, they could have stayed away.

K. K. Trial Slows Up  
The Ku Klux Klan trial has lost its snap, though every day there is a riot of rumors, dealing with "confessions of the goblin," "strange men prowling around the king kleele's house of nights," and a vague hint that the kleele, on trial, is making ready to depart. Nevertheless, the

S. F. Firemen Return  
GOLDEN, Utah, Aug. 12.—The Southern Pacific company announced at 12:30 o'clock today that the locomotive firemen who went on strike in this district yesterday had agreed to go back to work. The company stated it expected to have the four marooned trains out of here sometime this afternoon.

Although all official statements were lacking on the terms of the settlement it was understood the firemen go back to work under the same conditions which prevailed when they left their jobs.

Company officials said the firemen held a conference this morning and after the meeting a union delegation notified them that the strikers were ready to resume work immediately. Officials said they believed this the ending of all trouble in the movement of trains through Ogden.

Food Supply Short  
LAS VEGAS, Aug. 12.—The situation in Las Vegas is critical on account of a short food supply. It is estimated that there is only enough foodstuffs on hand for three or four days.

Company officials say there is no food on hand in the yards for the 150 guards and that unless the strikers consent the guards cannot be moved out of the yards and no foodstuffs taken in.

Mails Held Up  
LOS ANGELES, Aug. 12.—Seven carloads of westbound mail were reported today to be tied up at Ash Fork, Ariz. Mail from the east has been routed for a few days by way of El Paso, but the spread of the strike was said to have blocked this channel.

Passengers Suffering  
LOS ANGELES, Aug. 12.—The 12 transcontinental trains of the Santa Fe system that were halted at Barstow, Needles and other points in the desert east of San Bernardino, were still there today and Assistant Manager Brewer, said he did not know when the trains could be moved. Mr. Brewer said food, water and other essential supplies were on hand for several days and that more would be taken in motor trucks.

He said that appeals to the trainmen to move the trains had been fruitless and they would neither do the work themselves nor permit others to do it. He said reports were that barring the discomfort incident to the desert heat, the passengers were not suffering any hardships and that the railroad would do all it could to help them avoid further discomforts.

To the list of Santa Fe trains held at these points it was necessary to add today the southbound (coast-bound) trains of the Salt Lake line, which were halted at Caliente, Nev., by strike conditions. These trains were said to be equipped with diners and to have their water tanks filled. The plight of those aboard was even worse than that of the Santa Fe passengers, however, as the roads time at Big Rock lodge on Rogue river.

What the public seems to be waiting for with the most interest, is the documentary evidence to be adduced at the trial. Politics in Trial  
Politics is also taking a hand in the klan trial. Thomas E. Woolwine, the prosecutor with a national reputation, and a fiery orator, whose jury pleas convince, is mentioned as planning to induct himself into the present trial, at the crisis. At the same time, banners announcing him as a democratic candidate for governor, beam with circus posters from the walls of skyscrapers. Mr. Woolwine has overlooked a chance to exorcise a political sweat and a chill, and will lose some votes which ever course he follows, and nothing else matters to politicians. Friends say he will do his duty—even if it gains him votes.

The Elduayen family, the victims of the Ingewood "raid" held forth as the chief witnesses today. Mathias and Felide—the men folks came dressed in black, but the women and girls were resplendent in gay colors. They are Spanish, and the two brothers, told their story through an interpreter, with much waving of hands and vocal explosions. The ropes, "pistolas," and masks lingered vividly in the memory of the brothers, accused of operating a still, and they told with all the dramatic fervor of their souls, their midnight experiences. Mathias, he testified, started his American career, as a slaughter house attendant, before going back to the soil. Milk, he testified, was all he ever peddled of a liquid nature, though rumor classes him, as a busy, but not prosperous bootlegger.

More Bombs San Bernardino  
SAN BERNARDINO, Cal., Aug. 12.—Four additional bomb explosions occurred today in the Santa Fe railroad yards here, following the explosion yesterday morning of 23 bombs in the same yards. Officers are investigating four fragments of large bombs, constructed out of pipe elbows plugged with steel slugs and apparently loaded with chemicals. No one was injured by the bombs and no damage of consequence done.

Two additional United States federal deputy marshals to assist in preserving order, and federal department of justice men came here to investigate the explosions.

Refuse to Obey Lee.  
LOS ANGELES, Cal., Aug. 12.—D. E. Crayne, general chairman here of the Brotherhood of Firemen and Engineers, said today in connection with the telegram from President W. G. Lee of the Brotherhood of Railroad Trainmen that he "could not and would not order the men under his jurisdiction to return to work."

He said it was an individual matter where the brotherhood men left their work as individuals due to hazardous conditions of employment following a statement from the brotherhood executives that they could leave their work if the conditions were hazardous. In view of this action by the men, he said, he would take no steps to order them back to work.

Salt Lake Outlets.  
LAS VEGAS, N. M., Aug. 12.—Transcontinental traffic over the Salt Lake line of the Union Pacific system was completely tied up here today when members of the big four brotherhoods refused to handle trains on the Las Vegas division, which extends 286 miles from Yermo, Cal., to Caliente, Nevada.

In settling disputes had not been carried out.

Telegrams to this effect were sent to General Chairman Duffy and General Secretary Haswell of the Santa Fe system at Los Angeles.

"We are in full sympathy with the shompen's strike," Mr. Lee said, "but I will not pass authority to strike on to individual members or to local committees in any case."

"I am insisting that all walkouts be conducted in an orderly manner and not piecemeal and that the constitution and general rules of our organization be lived up to."

"This trouble must be settled as all similar troubles have been settled."

In explaining his position to a representative of the Associated Press Mr. Lee said messages he sent to the general chairman of the Chicago Great Western, and the Missouri Pacific railroad are being forwarded to all general committees forwarding complaints.

They read:

"If employment on your line is unbearable on account of conditions due to shompen's strike your general committee should be convened and if a majority of such committee votes in favor of a strike, authority of the undersigned as provided for in general rule nine of the constitution and general rules of the brotherhood will be given."

President Lee said he had not sanctioned the Santa Fe strike.
