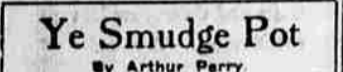

Jackson County School Notes

Only six pupils outside of Ashland and Medford schools are completing eighth grade work in January.

Miss Elvira Hollebeck of Walla Walla, a graduate from O. A. C., is the new commercial teacher in Jacksonville high.

A sheet of Lincoln's birthday bibliography secured from the State Normal School has been mimeographed and sent out to the teachers of the county this week.

An outline course of study for the fifth and sixth months of the school year has been prepared in the county superintendent's office and is now ready for distribution. Its aim is to unify and make more thorough the work of all one and two room schools.

Beaver Creek and Neil Creek schools are closed for a week because of illness in the communities.

Last Saturday the group of north zone teachers gathered at Trail, where sunshine prevailed above the valley fog. All but three teachers were present, and some of those attending had traveled more than twenty miles in order to be there. Three reading circle books for the year were reviewed—"Making a curriculum for elementary school," "Effective Training for Study," and "Facts of Childhood and Youth." The noon lunch was in cafeteria way, hot coffee being supplied by Mrs. Ash, and all enjoyed the feast. The last work on the afternoon program was presented by Miss Blumenfeld of the Ashland schools. Various school room and school ground games were taught, also the Danish Dance of Greeting. This is helpful work for the teachers and all appreciated Miss Blumenfeld's coming so far to be with them.

After two weeks of rather intensive office work Miss Burr and Mrs. Carter are again out among the schools of the county. Mr. Moss is leading on in the spring lines of club work, and club work is presented in each district which the supervisors visit.

I noticed one place where it had slipped off that the wheel on the back end of the tender cut right thru the ties, shaving the ends off just as smooth as so they had been cut off with an axe, and there was one place where everything like ties was pushed from under the rails for a space of four or five feet, but they finally got over the space, about thirty feet and started on for Butte Falls and I heard one of the railroad men say that they would likely get off the track again in the next two miles. The ties are so rotten that if they are on a curve the spikes are drawn out and the rails are spread and the result is another wreck. Fortunately there was no special damage done. It appears that the trouble is that they cannot get ties to repair the old road, at least that is the reason the men give for not fixing the road and making it safe to run on. Another difficulty they labor under is the heavy rains we have had this winter has made the ground so soft that that causes the rails to give way with but little trouble.
