

GIVE USE FORD CAR TO POLICE AID EFFICIENCY

Acting on a suggestion made by Mayor Gaddis the city council has taken action which will greatly increase the efficiency of the police force, by turning over to Chief of Police Adams the extra Ford car owned by the city, for the use of himself and the night policemen, and hence since last Tuesday night the local cops have been learning to drive the car, which will be on duty practically 24 hours a day.

The report that Chief Adams knocked over two lamp posts in a trial spin yesterday is erroneous, probably growing out of the fact that he ran over two dogs and a street corner marker. Neither is it true that Patrolmen Cave and Prescott late last night ran right by a restaurant twice on their way to lunch, being unable to stop the car after it once got going. They easily brought the car to a halt by running into the side wall of the restaurant and then getting out and throwing it over on its back.

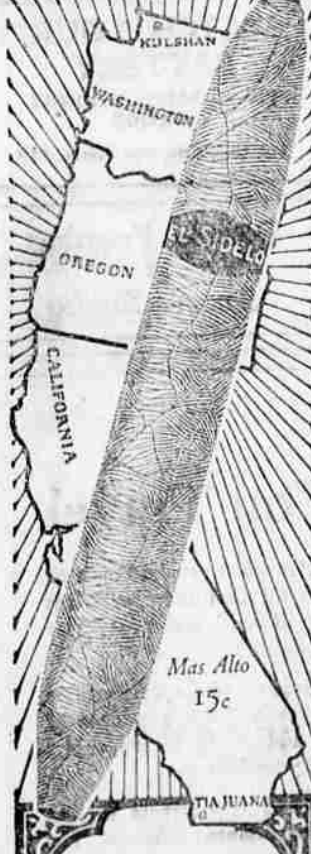
It is impossible for a small force of policemen without an auto to cover so much territory as Medford has, in answering night calls and the like, which fall to their duty, especially during the day when Chief Adams is on duty practically alone. The chief has to cover a large amount of the city in keeping track of how ordinances are being observed, and in addition has many other duties to perform which take him to many parts of town. Former Police Chief Timothy by an arrangement with the city council used his own car, the city paying for its upkeep and the gasoline used.

Fire Chief Elliott, who also has duties to perform all over the city, independent of attending fires, will also use his own private car in so doing, through a similar agreement as to upkeep and gas with the city.

PACKER MONOPOLY HEARING DELAYED, MERGERS OPPOSED

WASHINGTON, March 22.—Hearings on the complaint of Secretary Wallace against the acquisition of plants and business of Morris and company by Armour and company, originally set for April 2, at Washington, have been postponed to begin April 23 at Kansas City, Mo. It was announced today by Chester Morrill, officer in charge of the packers and stockyards administration.

Hearings also will be held at Omaha, East St. Louis, Chicago and other places, followed by final hearings at Washington. Officers of Armour and company who asked that the hearings to begin April 2 be postponed, were given an opportunity yesterday to explain their reasons and as a result the preliminary hearings were eliminated.

The packers were given until April 23 to file their answers to Secretary Wallace's complaint, which charged the merger would constitute a monopoly in restraint of interstate and foreign commerce and give opportunity for the manipulation and selling of livestock and livestock products.

The packers at the hearings will endeavor to convince the government that the merger of the two companies would not be a violation of the Packers and Stockyards act.

Officials of Armour and company contend the purchase would violate no law and that the combination would enable Armour and company to compete more vigorously because of economies which would be effected.

ALLIED LABOR FOR RUHR CONFERENCE

PARIS, Mar. 22.—(By Associated Press). A definite move by labor and socialist parliament groups to request the British, French, Belgian and Italian governments to place the Ruhr situation in the hands of the League of Nations was foreshadowed today following a conference of delegates representing these political factions in the several legislative bodies.

Spokesmen of the British laborites and the French, Italian and Belgian socialists deciding that a settlement of the controversy could only be effected "through American intervention or a decision of the League of Nations," came to the conclusion that the question of league assistance should be brought up in the British house of commons and in the chambers of the other governments.

Accordingly, J. Ramsay MacDonald of Great Britain, M. Vandervelde of Belgium, Signor Modigliani of Italy and Paul Boncour of France were delegated to carry out the wishes of the conference.

EXECUTION STAY TO SENTENCED I. W. W.'S

LOS ANGELES, Mar. 22.—Eight alleged members of the Industrial Workers of the World, convicted of criminal syndicalism and sentenced to terms in San Quentin penitentiary, today were in the Los Angeles county jail, having been granted a ten day stay of execution by Judge John Shenk of the superior court based on the defendant's oral notice of appeal.

The timber is favorably situated for logging, being penetrated by the Brownlee-Olde Lumber company railroad and the purchase may point to the installation of an operation or again may indicate only the blocking of the two tracts, which total approximately 25,000 acres, for convenience should the owners wish to dispose of them.

James H. Owen, representing the John S. Owen company here, and making an investigation of the holdings, was interviewed this morning, but vouchsafed no definite or confirming information in regard to the purchase or to the bearing it may have on the future operations of the interests he represents, or his own interests here.
