HUSKIES HOLD U. S. MIDDIES TO A 14-14 SCORE

PASADENA, Cal., Jan. 2.—The football teams of the University of Washington and the United States Naval academy were today preparing for the return trip home, each team perhaps a little bitter against fate for intervening at the zero minute and preventing a decisive victory in the intercollegiate gridiron battle yesterday, instead of a tie score, 14 to 14.

The game was, from the viewpoint of the critic spectators, the most spectacular brand of football ever played here in the series of east versus west contests.

Captain Bob Folwell's embryo admirals played a wide open game throughout with the exception of the third period with honors even.

It was the weight of the Husky line with their ability to tighten their defense that saved Washington from defeat.

The Navy's points were made in the second period by two touchdowns, one by McKee and the other by Callen. McKee converted in both instances.

The second and fourth periods were utilized by Washington for their scoring. A 35 yard pass from Abel to Dubois and a 23 yard run by George Wilson accounted for the first touchdown, with Sherman converting.

Their opportunity to tie the final score came in the last period and was grasped when Bryan received a pass from Abel and dashed over the line. Sherman kicked goal.

McKee, Shipley and Barchett featured in the Navy offense. Captain Carney was outstanding in defense.

Abel and Wilson gained most consistently for the Huskies. Abel's defensive playing appeared a little weak.

JOHNNY CARLSON LOSES DECISION TO TIM CALLAHAN

The Medford Legion put on a good show at the Armory New Year's afternoon, and a good sized crowd got more than their share of entertainment. The program was a varied one, running from low comedy to high tragedy, with plenty of singing for those who like a strong diet and considerable skill and science particularly in the main bout between Johnny Carlson, the pride of Gold Hill, and Tim Callahan, of Portland.

Tim got the decision and clearly deserved it, although Johnny put up a game battle, and considering that he was outwitted ten pounds, and clearly outboxed throughout, made a very creditable showing.

Johnny was to have met Red Burley of Portland, who recently knocked him out in Portland, but Burley refused to come, so Callahan who is said to be one of the best lightweights on the coast, took his place. Callahan was too fast and too clever for Johnny, and in the opinion of a majority of the fans could have stowed Johnny away early in the bout if he had felt so inclined. From a sporting standpoint however he adopted the better course for there wasn't a dull moment in any of the ten rounds, although in the final canto Carlson was plainly tired, and slipped to the floor a couple of times to get his wind and bearings. Callahan made a great impression and local fans would like to see him in action again, with some boy his own weight.

The low comedy event was a slugging match between Blackie Gordon of Medford, a local shoe shiner, and Kid Moran of Klamath Falls, who had a couple of hefty arms gloriously tattooed when he entered the arena, and who was tattooed all over when he finally left. Blackie Gordon started in waving a wicked elbow, and rolling his eyes as if he were engaged in giving an imitation of a Voodoo priest. The tattooed Kid laughed and shot in a right and left, but didn't laugh when Blackie dropped his incantation and started to swing from his right heel. They stood toe to toe and hammered like a couple of crazy boiler-makers until the Klamath Kid went down and took a slow count by referee Benton Bowers of Ashland. Only the bell saved him, and in the second round he went down to stay, while Blackie returned to his comedy role and hopped all over the auditorium.

High tragedy marked the scheduled ten round go between Red Watson of Ashland and Billy Gardeau of Portland. The Ashland veteran appeared in poor condition when he came in the ring and many predicted a short finish. Apparently realizing he had to do something quick or nothing at all Watson no sooner reached the center of the ring, then he plastered a terrific right on the Portland entry's jaw and Billy went down looking somewhat puzzled as to just what happened. He got to his feet however before the fatal ten, and started a little punching bee on his own account, with the result that at the end

FINLAND TO HAVE STRONG TEAM IN PARIS OLYMPICS

NEW YORK, Jan. 2.—Finland, second only to the United States in the track and field sports of the 1920 Olympics, is marshalling a sturdy band of athletes which promises to press Uncle Sam closer than ever before for the laurels in the eighth Olympiad at Paris next July.

Attention is focussed on Finland's preparations, particularly of the recent decision of William Ritola, distance running champion here for the past two years, to compete for his native land this year.

Y. Salminen, head of one of the largest Finnish athletic clubs, who is returning to Finland this week in company with Ritola after a brief visit to the United States, declared today that his country is not over confident but believes it will make a stronger bid than ever for honors at Paris.

Finland will send a team of probably forty track and field stars to Paris, far less than will represent the United States, according to Sullivan. But it will include all of the 1920 point winners, 21 in number, among them athletes who accounted for nine first places at Antwerp, a total equal to that collected by America.

PORTLAND, Ore.—Scott high school football team of Toledo, Ohio, defeated Columbia university here yesterday, 20 to 17 in a closely contested game. Scott high showed some of the cleverest football ever seen in the northwest.

PORTLAND, Ore.—Fred Fulton, Minneapolis heavyweight, knocked out George Lamson of Omaha in the second of a scheduled ten round bout yesterday.

PHILADELPHIA, Jan. 2.—Law Tondor, for several years a leading contender for the lightweight championship, yesterday suffered the worst defeat of his long ring career at the hands of Nate Goldman, a fellow Philadelphian and until recently comparatively unknown in fistie circles.

1923 CROP, YAKIMA BREAKS ALL RECORDS

YAKIMA, Wash., Jan. 2.—All previous records for crop production in the Yakima valley were broken in 1923, according to the annual crop statistics compiled by C. A. Foreman of the Yakima Morning Herald which are accepted by reclamation service and federal government as authentic. The total output for the year was 50, 223 carloads valued at \$6,696,117. This is a gain in value of \$8,000,000 over 1922, and a gain in tonnage of more than 8,600 cars.

The apple crop is estimated at 15, 000 cars, a gain of 5,500 cars over 1922. The total fruit tonnage was 22,972 cars, breaking all records for fruit production in this section. The valuation of the fruit crop, not including cannery products, is estimated at \$18,955,270. Only the low prices prevailing on farm products this year prevented the valley from exceeding the 1919 record.

MUCH DIVORCED STEEL BARON TO LIVE IN FRANCE

NEW YORK, Jan. 2.—William E. Corey, who rose from obscure origin to the presidency of the United States Steel corporation at 38 and who four years later abandoned his commanding position and married a musical comedy star after a romantic courtship, intends to settle permanently in France, according to his associates in the steel industry. No motive was given for the decision which apparently followed closely the granting last month by a Paris court of a divorce to the second Mrs. Corey, who was Miss Mabelle Gillman, a musical comedienne.
