Calves 50¢ higher. Week's bulk prices: Beef steers, \$5.00 to \$5.50; good loads, Monday, \$5.65; common kinds down to \$4.50; cows and heifers \$4.75 to \$5.00; few strictly good heifers Monday, \$6.85; canners and cutters \$2 to \$3; bulls \$3.50 to \$4.50; light veal calves, \$9 to \$11; others \$4.50 to \$8.50.

Hogs.—Compared to week ago: Mostly steady, feeders notably 25¢ higher; bulk desirable weight butchers, for the week \$7.75 to \$7.85. Weighted kinds \$7.35 down; heavy packers and throw-outs \$5 to \$6.75; slaughter pigs, \$7 to \$7.50; feeders \$2.25 to \$6.75.

Sheep nominally steady today, 280 received on contract. Compared with week ago: Fat lambs, 50¢ higher; sheep strong to ten cents higher; fat wool lambs, \$11.50 to \$12.50; heavies and culls \$11 down; shorn \$10.50 to \$11.25; fat ewes \$5.50 to \$6.75.
