PRES'T OPENS WORLD FAIR IN CHICAGO

Women's Exposition Launched
By President Coolidge Via
the Radio—Example Set in
Public Office Stressed By
Chief Executive—Cabbages
vs. Votes for Women.

WASHINGTON, April 18.—President Coolidge in a radio address delivered today on the occasion of the opening of the Women's World's fair in Chicago said an advantage to be gained from government economy and efficiency is the inspiration they provide for pursuit of such methods in business and in the home.

"If the people," asserted the president, "in the daily management of their modest domestic affairs, note that the great interests of their governments and of their semi-public institutions are dealt with in a spirit of laxity and a mood of carelessness, they find little inspiration to apply better methods in the management of their own concerns. The great business operations which are constantly under the public eye ought to be handled so as to make them an example in sound procedure.

"The importance of sound business methods was never so great as it is today. It is particularly true placed on a basis of rigid economy, that government business should be.

"In our modern society, public and private savings are quickly transmitted into capital available for production. The increased production makes goods more plentiful and therefore cheaper; and at the lower price level people can afford to consume more.

"The real disaster to a modern community comes when easy and ill-considered consumption prevents the storing away of new capital to meet the ever-increasing demands."

Mr. Coolidge commended sponsors of the fair for placing their work on a business basis by establishing a budget, with a result that all expenses were met before the doors were ready to be opened. This financial accomplishment, he added, presents a "strong contrast to the average project of like character supported in easy fashion out of public funds."

"I know of nothing more calculated to promote the pride of vigorous community life, the sentiments of self-respecting nationalism, the truest loyalty to high traditions of national character than these distinctive assemblies of the people," the president said.

"If we could find means to bring all the people and groups of the people truly to know and understand each other, I am confident most of our social problems would have been started well on the way to solution. It is not intolerance, so much as ignorance that leads men and nations into antagonism."

Pointing out to the benefits to be gained from holding the fair which opened today in Chicago, Mr. Coolidge said "our country wants its arts and science; its commerce and agriculture; its production and transportation; its education and invention, not merely that they may be used in the market place, the factory and the field, but that they may all be translated into the home."

"All of these efforts," he added, "are for broadening the outlook on life, for making better men and women; they all have the purpose to become effective forces at the fire-side. For long ages past men have gone forth into the world; more recently they have been followed by women. Each are endowed with the same desire, each attempting to contribute to the satisfaction of the universal longing of the human race to bring something better home. The contribution that it can make to that high purpose, the success of this fair will be measured."

WOMAN ADMITS STEALING FROM SALEM SCHOOL

SALEM, Ore., April 16.—A signed statement by Sarah B. Chamberlain, stenographer at the Salem Indian Training school at Chemawa, that she has appropriated to her own use over \$2200 from funds belonging to the pupils of the school, has led to her suspension from employment at the institution and her accounts are now being audited by H. W. Camp, accountant of the federal Indian service.

Mrs. Chamberlain's statement has been forwarded to the Indian office at Washington.

The shortage was first detected by another employee of the school, and following this Mrs. Chamberlain admitted her defalcations to this employee, and later signed the statement, according to the officials.

When the alleged shortage was made known to Superintendent Harwood Hall he immediately telegraphed the Indian service to send an auditor to check the records.

Mrs. Chamberlain has been connected with the Chemawa school about nine years. In her statement she mentions no specific period over which the defalcations have taken place.

The funds involved are not the funds of the school, but moneys belonging to the pupils themselves. This money comes in various ways to the pupils, in checks from their relatives, checks from agencies and in other ways. Upon its receipt at the school it is placed to the credit of the pupils.

Mrs. Chamberlain, by virtue of the position she held, had access to all the mail, and it was her custom to have the checks endorsed by the pupils, then take them to the bank and cash them. In this way she had access to actual cash and according to the officials of the school the alleged misappropriations were made from cash amounts. Mrs. Chamberlain has for years been well known at all the Salem banks and her checks are never questioned.

Daily Report on the Crime Wave

EAST ST. LOUIS, Ill., April 18.—Christopher Columbus Gwaltney, 32, a plumber and Peter Totsch, 55, his employer, quarreled in the First National bank here today, then went outside to the city's busiest corner, where Gwaltney shot and killed Totsch and Patrolman David A. Mohler, 53, who intervened and in turn was shot and killed by Detective Sergeant George Burns.

Scores of persons at the intersection died in consternation, thinking a bank robbery was in progress.

Officers believed the quarrel grew out of a claim which had been made by the laborer that his week's wages were short one day's pay. Totsch was business agent of plumbers' laborers' union No. 62 and plumber for his local water company. He had employed Gwaltney as a pipe layer.

Intoxicated Driver Convicted Here.
The first conviction in this county under the new law pertaining to driving a car while intoxicated was that of R. W. Walker of Gold Hill, in Judge Taylor's court here this afternoon. Walker was arrested in Gold Hill last night by Deputy Sheriff Terry Talent on that charge.

Walker was sentenced to sixty days in jail, fined \$100 and his car driving license was suspended for one year. This is the minimum sentence under this law.

COLORED HORDES GIVE PRINCE OF WALES OVATION

Amazing Spectacle Presented
When Heir to British Throne
Is Greeted By 20,000 Na-
tive Horsemen in the Wilds
of Nigeria.

KANO, Nigeria, April 18.—(By the Associated Press.)—Crowds of natives poured into Kano all night long to get a view of the Prince of Wales who arrived here yesterday. The newcomers displayed great enthusiasm, blowing horns and making so much noise that sleep was impossible.

The scene from the building tops this morning was amazing, great streams of plodding natives stretching for miles in all directions, converging on Kano like swarms of ants.

The emirs have already congratulated the durbar (formal reception to native princes). Most of them travelled hundreds of miles, accompanied by hosts of retainers and there were many deaths among the parties owing to the intense heat and jungle conditions.

All the emirs are attired in new and costly garments, acquired especially for their interview with the royal traveler.

Despite the long train journey and his exertions at tennis, Wales attended a dance after dinner last evening.

Kano's white population is only 350, but 500 were present at the dance, visitors having come from all parts of the northern provinces. Nineteen of the 25 women present had travelled great distances to welcome the Prince of Wales. The prince took a dinner jacket, received every person present and danced every dance.

A striking scene awaited the prince when he arrived at eight o'clock this morning for the durbar. There were twenty thousand horsemen ranged in a horseshoe formation, all flaunting their colors. Mounted British officers commanding the native troops hurried about, completing their arrangements for the event.

Press dispatches were taken from the durbar to the Kano post office by mounted police who galloped across the fields to get the news of the event to the wire.

As the prince arrived complete silence fell on the big arena, this being the Nigerians' manner of showing their respect. Then a Nigerian regimental band, the members of which play by ear, burst into a stirring march and hundreds of native drums were beaten.

Immediately upon his arrival the prince took a seat on the dais which was covered with a multi-colored canopy captured during fighting 70 years ago. A parade of Nigerian infantry and artillerymen, the latter carrying gun parts on their heads, was executed with beautiful precision. The crowd gave the spectacle a tumultuous reception, cheer after cheer breaking forth as the drums continued to roll.

Troops of the emir's cavalry charged into the field almost to the prince's feet with their lances at point and their swords raised high, waving back to the crusader's time, dating in the air. At the last moment, they pulled up spectacularly within a space less than two yards from the prince, giving a magnificent display of horsemanship.

Great maneuvers of cavalry followed, wave upon wave of horsemen, each headed by a band playing ancient instruments and all clad in the most gorgeous uniforms, carrying out their movements with veteran-like precision.

The prince viewed the scene with the most intense interest and the crowds went wild as the exultant drums rolled ceaselessly.

MOVIE ACTRESS TAKES POISON IN NEW YORK HOTEL

NEW YORK, April 18.—Gloria O'Radner, 17, of Los Angeles, who said she was a movie actress, attempted suicide at the Hotel McAlpin today by drinking poison. She was rushed to Bellevue hospital where it was said her condition was critical.

She registered at the hotel yesterday. Early today she telephoned the clerk at the hotel, "I've taken poison. I'm dying."

The hotel physician was summoned and gave her first aid.

Two notes were found in her room. One addressed to "Sidney" said: "Give these pictures to the dollie."

The other note, addressed to a Miss Hazelton, a guest at the hotel, said: "You were so nice to me last night. I want you to have my picture. By the time you get this note I will be with my mother. Good-bye."

Miss Vanderbilt Is No Flapper; Lauded As the Perfect Wife

EX-DRAGON OF KLAN CHARGED WITH MURDER

D. C. Stephenson Is Indicted for Murder of Miss Oberholtzer and Denied Bail By Judge—Two Companions Also Indicted.

INDIANAPOLIS, Ind., April 18.—D. C. Stephenson, former grand dragon of the Ku Klux Klan, and companions, Earl Klineck and Earl Gentry, were indicted on a charge of first degree murder today by the Marion county grand jury which has been investigating the death last Tuesday of Miss Madge Oberholtzer, 28, of Indianapolis.

The murder charge is based on the allegation that the three men failed to provide medical attention for Miss Oberholtzer after she had taken poison at a Hammond, Ind., hotel following an attack which she declared was made on her by Stephenson.

Judge James A. Collins of circuit court announced that the three men would not be admitted to bail.

Stephenson was indicted recently on charges based on his alleged mistreatment of Miss Oberholtzer. These charges were assault and battery with intent to kill, assault and battery with intent to rape, malicious mayhem, kidnapping and conspiracy to commit a felony. Klineck and Gentry, both former residents of Evansville, Ind., were indicted jointly with Stephenson on the latter charge.

Stephenson had been at liberty on \$25,000 bond and Klineck and Gentry on bonds of \$5000 each.

An inquest into Miss Oberholtzer's death was concluded yesterday by Dr. Paul F. Robinson, Marion county coroner. A verdict is expected next week.

The Noted Dead

NEW YORK, April 18.—Charles H. Ebbetts, president of the Brooklyn National League baseball club died here at six o'clock this morning. He was 66 years old.

Death came quietly. Mr. Ebbetts had fallen into a deep sleep at 11 o'clock last night and did not wake during the night. No one was at the bedside at the time of his death, but a few minutes after he had died, the nurse attending him entered the room.

Heart failure, from which he had been a sufferer for many years, overcame a brave fighter by the baseball magnate to continue in the game which he had helped to make nationally popular through his long connection with the Brooklyn club.

Mr. Ebbetts first broke into the game in 1883 as bookkeeper for the old Brooklyn club. Step by step he rose, filling various offices, until in 1899, he became president of the club.

Fred Hanlon, business manager of the Brooklyn club, said the team would play the New York Giants today, Sunday and Monday, according to schedule, but that the game on Tuesday, the day of the funeral, would be postponed.

NEW YORK, April 18.—Charles Thaddeus Thompson, superintendent of foreign service of the Associated Press, who had been connected with the organization continuously for the last 33 years died today in St. Luke's hospital at the age of 67. He had been in ill health for some months but was at his desk up to a few days ago.

Mr. Thompson had a distinguished career with the Associated Press in the United States and abroad. He reported scores of notable events, among them being the Algiers conference in 1906.

Kid McCoy Steps a Lively First Round With a Jute Mill

SAN LENTIN, Cal., April 18.—Norman Selby, better known as Kid McCoy, stepped his first round with a lumen in the jute mill at the state penitentiary here yesterday. Jute mill heads predicted that McCoy will become an expert as a spinner as he was a pugilist. McCoy's request to act as physical director to his fellow inmates will not be granted, officials said. It being pointed out that convicts receive sufficient exercise in their routine duties.

BURGLAR HITS WOMAN, IS SHOT BY POLICEMAN

PORTLAND, Ore., April 18.—After beating and knocking to the floor Mrs. George J. Koller, who resisted him while he was holding up her husband's grocery store here today, a man who gave his name as Lewis T. Crawford, 23, of Los Angeles, was pursued from the store by Mrs. Koller's son, Virgil, and was shot by a patrolman who took part in the chase, the police reported. Crawford is in a hospital with a bullet in his forearm and another in his left hip.

Mrs. Koller was taken to a hospital but was found to be suffering principally from shock.

When the robber entered the store, according to the police report, he asked for the proprietor. When Mrs. Koller said her husband was out, the man pulled a revolver and attempted toward the cash register. Mrs. Koller interposed and was knocked down by a blow on the head. The robber fired two shots through the floor at her feet.

Virgil Koller, 17, turned upon the man, angrily calling him a coward and daring him to shoot. The intruder rushed to the cash register, took some money and dashed from the store, followed by the youth. Two officers nearby took part in the chase and when the fleeing man turned to fire one of the officers shot him.

COURT DIRECTS TITLE CHANGES IN BUS BALLOT

SALEM, Ore., April 18.—Modifying the ballot title as prepared for the bus bill referendum, petitions by Attorney General VanWinkle, but not granting in full the demand of the petitioners for an alteration of the title, Judge McMahon today handed down an order in the appeal of the Lane and Marion county courts from the Van Winkle ballot to the circuit court.

The county courts averred that the ballot title prepared by Van Winkle stated that the state levies taxes on the busses whereas by their petition it imposes charges. The McMahon order makes it read "levy license taxes."

Another contention of the county courts was that the Van Winkle title did not show that it applies only to common carriers. The order of Judge McMahon brings that out clearly.

The bus bill passed by the recent legislature is being referendum by the bus lines and it was the ballot title to the referendum petitions that was in controversy.

Passing of the Early Pioneer

EUGENE, Ore., April 18.—J. M. Shelly, pioneer of Oregon and a member of the state legislature in 1903, died here today. He was born May 22, 1843, and moved to Pleasant Hill, near Eugene, in 1848, with his parents.

He was one of the leaders in the fight to free Oregon of the liquor traffic, while a member of the legislature. He had been ill since last November.

Golf Is Dangerous Game in Portland; 2 Men Knocked Out

PORTLAND, Ore., April 18.—A flying golf ball at the Portland golf club yesterday struck J. W. Porter, 21 year old lad, in the temple.

He was knocked unconscious and was at first thought to have a fractured skull, but today Dr. Hicks Fenton reported there was no fracture.

Tom Shea, Portland news-paperman, was knocked unconscious at the East Moreland golf links just as he was poised for a drive, a golf ball struck by an unidentified person striking him just behind the left ear.

"It was not what I said in my inaugural address that caused irritation in Washington but the way I said it," the vice president declared.

"And now I am going to say a few things because Senator Butler is here to listen. Unless in my own way I can act as a conduit to transmit to the senate the individual reaction of this constituency I don't think I would be doing any good in office."

"I appeal to you to express your opinion on this senate rule," he added. "The forebears of this country did not have any idea when they framed the constitution that it would result in a power in the senate greater than the veto power of the president. Would they frame the constitution on the basis of government not by the court, not by good legislation, not by law, but by senate rule which had been built up nobody knows how, in the last 119 years?"

"I want Senator Butler to know that these rules of senate procedure ought to be changed," the vice president continued. "All of you who think they should be changed stand up."

After the demonstration that followed this question Mr. Dawes said: "I knew Senator Butler would stand up. Senator Gillett would stand up also if he were here for he told me so."

At the conclusion of his remarks, the vice president turned to Senator William M. Butler and said: "I want to hear from Senator Butler on this matter."

Senator Butler quickly arose and responded:

"I believe in the reform of the senate rules. SECRETARY HUBERT WORK TO GIVE KLAM. INDIANS A \$25,000 HOSPITAL

WASHINGTON, April 18.—Plans for construction of three new Indian hospitals and an addition to a fourth was announced today by the interior department.

They will be built under supervision of the bureau of Indian affairs during the next fiscal year on the following reservations: Klamath, Oregon; Fort Peck, Mont.; Pyramid Lake, Nev., and Fort Lapwai, Idaho.

The Klamath reservation will have a forty-bed general hospital to cost \$25,000; Fort Peck a 24-bed general institution costing \$20,000; Pyramid Lake a new hospital and rehabilitation of an existing one, and Fort Lapwai will get an additional structure to care for fifty patients.

An appropriation of \$30,000 is available for the Pyramid Lake improvements, but the Indian bureau does not contemplate starting erection of the new building until the present hospital has been thoroughly remodeled.
