THOUSANDS MOORN AT BRYAN BIER

Funeral Train Leaves Dayton From Capital—Flowers Are Heaped Upon Casket—All Classes Pay Tribute to Commoner—Widow Retains Sad Composure.

CHATTANOOGA, Tenn., July 29.—(A. P.)—The Bryan funeral party arrived in Chattanooga at 10:15 central standard time. The public was admitted to the special Pullman where in single file they viewed the remains of the dead statesman.

A crowd estimated at about 10,000 persons pressed against the iron barrier of the station as the train from Dayton pulled in. Captain W. L. Baker, of the Chattanooga police, restrained the eager throng and his men formed in double lines to expedite the orderly review.

In single file the men and women of Chattanooga passed into the car where the statesman lay and looked down into the metal casket where the peaceful leader's countenance was seen. They moved on without halting, leaving the coach at the other entrance.

Flowers, the tributes of patriotic and civic organizations, were brought and placed within the compartment where the body reposed. Room was lacking to hold them all.

The widow remained in her seat in the rear section of the Pullman part of the car. Her face showed the strain of the sorrowful burden which she has resolutely sustained.

During the trip from Dayton Mrs. Bryan sat in her section, the one nearest the flag-draped casket. She maintained her composure so remarked upon by her associates since the death of her husband.

The resting place of the commoner was heaped with flowers. A truck load had been conveyed to the train at Dayton in addition to the wreaths which filled the funeral carriage.

Employees of the Southern railway along the tracks traversed by the funeral train, suspended their work as the train passed and stood with uncovered heads.

DAYTON, Tenn., July 29.—(A. P.)—The body of William Jennings Bryan began its long journey to the national capital early today when the bronze casket in which the commoner lay was removed from the Rogers residence at 7:40 o'clock.

The widow followed as the remains of her distinguished husband were placed aboard the special Pullman on a siding near the place of Mr. Bryan's death. Citizens of Dayton attended the funeral carriage on the short march through the streets of the town. A guard of six uniformed men formed the simple escort.

DAYTON, Tenn., July 29.—(A. P.)—Quitting forever the little southern town where friends made his last days happy, the body of William Jennings Bryan today began its long train journey from Dayton to Washington, where the nation will pay the final tribute to his memory before burial Friday in Arlington cemetery.

The special Pullman, attached to a regular Southern Railway train, drew out of Dayton at 5:03 o'clock, moving first toward Chattanooga, where the public will enter to view the face of the great commoner.

LADY OF CHORUS AND GOULD, NOW BRITISH PEERESS

Bride Calls Viscount 'George' and He Says 'Dear'—What Will London Society Do?—Family Tree of the Contracting Parties.

NEW YORK, July 29.—(A. P.)—A former chorus girl, a blonde, who married an American millionaire, thus legitimizing their three children, but who never had a place in American social circles, has become a British peeress.

Mrs. Guinevere Sinclair Gould, widow of George J. Gould, was married yesterday in Montreal to George St. John Broderick, Viscount Dunsford, son and heir of the Earl of Malmesbury. The family title dates back to 1751. He is 37 years old.

The viscountess is several years younger. It is also the viscount's second marriage.

No announcement had been made of the engagement. They slipped away from New York to Montreal to be married, they said, because it was a quiet place. Lady Dunsford's wedding gown was a Parisian creation of green crepe de chine with a lace back and lace collar fastened in front by a diamond arrow pin. Driving from the church to the Ritz Carlton hotel in a taxi, she wore a green coat trimmed with red fox fur. A Panama hat partly obscured her blonde bobbed hair.

She called her husband "George." He addressed her as "Dear."

"We want to keep our marriage as quiet as possible," Lord Dunsford said. "We shall go touring in Canada and possibly on the continent. We shall of course, end up in England, where we will live."

New York society is speculating whether Lady Dunsford's reception in London society will be more cordial than was that in New York three years ago.

Lady Dunsford is the daughter of Alexander Sinclair, a British officer. Her grandfather was provost of Trinity college, Dublin. She was appearing in the English musical comedy, "The Girl on the Film," in 1914 when she caught the attention of Howard Gould, brother of George J. Gould. When the comedy company came to New York the same year Miss Sinclair carried a letter of introduction from Howard to George, husband of the late Edith Kingdon Gould.

When the company returned to England she remained behind and as Mrs. Sinclair lived in a mansion just off Riverside Drive. Later she moved to Rye, New York. Children were born to her in 1915, 1916 and 1922. She married George Gould in 1922, a year after the death of Edith Kingdon Gould.

After a legal battle that followed Gould's death in 1923, the present Lady Dunsford obtained last June an annual income of \$10,000 for each of the children. Her claim for \$4,000,000, which she said was bequeathed her and the children is still in litigation. She has already received \$1,000,000.

Stalnaker, who was on duty at Washington prior to coming to San Diego, was the officer. Secretary Wilbur excused himself and went into the sick room and before he left offered a fervent prayer in behalf of this officer.

Friends were expressing their appreciation of the act of the secretary when Mrs. Wilbur said:

"Yes, Curtis firmly believes in prayer and he was only too glad to have the privilege of petitioning his Lord and Savior that Commander Stalnaker's life might be spared."

A high officer in commenting upon the incident, said:

"The questions of preparedness and peace are in safe hands when we have such a God-fearing man as Curtis Wilbur at the head of our navy."

FISH FUSS FUMING MOUTH OF ROGUE

MARSHFIELD, Ore., July 29 (A. P.)—Containing factions in the salmon price war here today awaiting a hearing on a petition for an injunction against outside fishing interests on the Rogue River sought by J. C. Johnson, attorney for the Roderick MacLeay Fisheries at Gold Beach.

The attorney asks that the outside interests be restrained from trespassing upon the property of the MacLeay estate and interfering with business. The hearing will be at Gold Beach tomorrow.

The injunction suit is the outgrowth of the fish war on the Rogue River caused by outside fishermen coming into the river, resulting in a big increase in price. Last night salmon had reached 18 cents a pound, the highest ever paid here.

MAN CAUSED 9 OF .67 FOREST FIRES

BEND, Ore., July 29.—Of 67 fires so far reported from the Deschutes national forest this season, only nine have been man caused, according to H. L. Plumb, forest supervisor, whose headquarters are in Bend. The others were caused by lightning, 30 having resulted from the last electric storm.

Most of the man-caused fires were set by fishermen, but only one arrest and conviction has resulted from the nine different instances, Plumb said. This one was at East lake and covered an area of three acres.

KIN HOPES TO LEAD FIGHT UPON APES

Charles Bryan May Continue Work of Famous Brother—Sees Action By Congress Eventually—Anti-Evolution Bill in Georgia to Fore.

CRESTON, Iowa, July 29 (A. P.)—Congress eventually will be called upon to take a hand in the evolution theory, Charles W. Bryan, brother of William Jennings Bryan, said when he passed through Creston last night en route to Washington to attend his famous brother's funeral. Mr. Bryan indicated he was deeply interested in the cause for which the great commoner made his last fight, and that he might be active in carrying on the work of his dead brother.

"The people of the United States," he said, "are becoming aroused to the real issue in the conflict between religion and evolution."

"Several states already have passed laws prohibiting the teaching of evolution and more will soon follow suit."

"Eventually congress will be forced to meet this problem."

"My brother studied the theory of evolution for ten years and his heart and soul were in the fight against it. My sympathies were with him in his last great fight down in Tennessee."

ATLANTA, Ga., July 29.—(A. P.)—An amendment designed to prohibit the teaching of evolution in the common public schools of Georgia today was voted down overwhelmingly by the state house of representatives.

In the viva voce vote the "noes" drowned out the "yays."

Speaking in behalf of the amendment, Representative Lindsay referred to the University of Chicago as the source of new theories "which for the last 25 years have overwhelmed this country" and which "culminated a short time ago in one of its graduates taking the life of a little boy as a scientific experiment."

He said: "No man's education—no system of education that is founded on things other than the fundamentals of Holy Writ can endure."

"I don't want any smart Aleck trying to teach my child that man descended from a tadpole or a monkey. My child shall not be subject to the inroads of scientists. We must protect them from the poison that is being injected."

"When a man gets so smart that he can't believe the Bible, he is just too smart to know that he's a fool."

Representative Barrett, chairman of the appropriations committee, termed the proposed amendment "silly."

"Write it in if you want," he said, "but you will be making yourself ridiculous if you do."

Accused Klamath Lady Acts As Own Lawyer Is Freed By Jury

PORTLAND, Ore., July 29.—Mrs. Lulu Lang, from the Klamath Indian reservation, refused the services of a lawyer and fought her own case to an acquittal today in Judge Bean's court. She was charged with attempting to destroy or mutilate a public record. Both she and her husband, Thomas Lang, made long talks.

The charge was that she tried to scratch her name off an agreement between herself and the California Oregon Power company. The paper was held by Superintendent Baker of the reservation and, since the Indians are wards of the government, was held as a public document.

She conducted her own case in rather an autocratic manner, objecting to questions of prosecutors now and then and winding up with a strong plea to the jury.

PROSECUTOR AT KLAMATH IS INDICTED

E. L. Elliott, Pierce appointee and Special Dry Aide, is charged with disposal of sugar, stolen from Mason Ehrman—Accused Friend of Governor.

KLAMATH FALLS, Ore., July 29.—E. L. Elliott, who is scheduled to take office Saturday as district attorney of Klamath county, was indicted on a charge of malfeasance in office on a secret indictment returned by the grand jury this morning.

The accused attorney was arrested in his office shortly after the noon hour and was in custody of Deputy Sheriff Hilton pending his appearance before Circuit Judge Leavitt this afternoon to arrange bail bond.

The indictment involves the theft and subsequent disposal of approximately 21 sacks of sugar from the Mason Ehrman & Co. warehouse here in March, 1924. It is charged that the sugar later was found by certain persons and part of it turned over to Elliott, who at that time was special prohibition prosecutor for Klamath county.

The sugar, it is alleged, subsequently disappeared. It is charged that Elliott disposed of it and made no return as a public official as to what became of the sugar or funds said to have been received for the sale of the sugar.

Elliott declined to make comment immediately following his arrest.

Following the resignation of District Attorney Ganong, here early this month, Elliott was appointed district attorney by Governor Pierce, effective August 1. For the past few days he has been arranging his business in order to take over his new duties. He had already announced the appointment of W. A. West, former deputy supreme court clerk at Salem, as his deputy.

Elliott served as special prohibition prosecutor for Klamath county for 18 months prior to January 1, under appointment by Governor Pierce. When William Ganong went into office as district attorney, Elliott resigned his special commission. He is known to be a close personal friend of the governor and at the time George L. Cleaver was dismissed as state prohibition commissioner, Elliott was prominently mentioned for that post.

SCOPES STANDS AT BIER OF BRYAN

DAYTON, Tenn., July 29.—(A. P.)—John Thomas Scopes, in whose prosecution for violation of the Tennessee evolution statute Mr. Bryan gained wide renown, as the champion of fundamentalist religious ideas went to the home where the commoner lay in state yesterday.

The young biology instructor entered the room where the body lay in its casket, stood a moment in respectful silence and walked quietly away.

Dr. John R. Neal, senior counsel for the defense in the Scopes trial, also viewed the remains of his recent legal antagonist. He offered his sympathetic services to the bereaved family and remained with others at the home for several hours.

China Treaty Up Aug. 9.

WASHINGTON, July 29.—(A. P.)—Arrangements are being made at the state department for the formal exchange August 5 next of ratifications of the nine-power treaty relating to China, which was signed at the time of the Washington arms conference.

SNOOPERS, SPEED TRAPS, AND TANTRUMS BY TRAFFIC COPS, OPPOSED BY DUNNE

HOOD RIVER, Ore., July 29 (A. P.)—The Oregon State Motor Association was organized to secure law enforcement. It is unalterably opposed to speed traps. No speed trap evidence is admitted in courts of California. We are after the driver who dodges through traffic and doesn't keep his side of the road. We are not seeking that man who, though he may exceed the legal limit somewhat, drives his car on his side of the road on straightaways.

"You cannot get too harsh for us with the drunken driver. He is a menace to the road."

"We wish to see the man who doesn't know how to drive, who goes too slowly and holds up traffic, censured."

"An ideal traffic officer is one, who in full uniform, operates in plain sight. He is worth more to you than 1000 officers who hide by the roadside in the bushes. The traffic officer who is of the greatest worth to you is that one who has the least arrests. And the ideal traffic officer is that one who knows how not to fly into a tantrum when dealing with traffic."
