COLONEL MITCHELL RENEWS ATTACK ON AIR SERVICE

DETROIT, Aug. 7.—(A. P.)—Colonel William Mitchell, former assistant chief of the United States air service with the rank of brigadier-general, gave indications here yesterday that he would launch another attack against present conditions of the air service when congress convenes in the fall.

Referring to the air service, he said: "As long as we are under the army and navy we will not have any air service. We haven't more than a dozen fighting ships and the rest are nothing but toy outfits falling down around our ears."
