BULGARIA INVADED BY GREEK TROOPS

LEAGUE IS APPEALED TO IN BALKANS

Bulgaria Asks League to Halt War, as Greek Artillery Fires on Bulgarian Villages and Occupies Three Bulgarian Posts — Famous Article Ten Involved

SOFIA, Bulgaria, Oct. 22. (A. P.)—It is officially reported that Greek troops have invaded Bulgarian territory. No declaration of war, however, has been made from the Athens government.

VIENNA, Oct. 22.—(A. P.) Sofia advises the Bulgarian government as counter move to the Greek ultimatum, has forwarded a protest note to the League of Nations based on article X. The Bulgarian troops along the Greek frontier have been instructed to offer the utmost resistance to the Greek advance against Petrich.

SOFIA, Bulgaria, Oct. 22.—(A. P.) The Bulgarian Telegraphic agency declares Greek artillery has penetrated Bulgarian territory, killing five sentinels and firing shells against the village of Petrich.

ATHENS, Oct. 22.—(A. P.) A tense situation, the outgrowth of the hostilities between Greek and Bulgarian forces along the Macedonian border line, still existed today. It is asserted by the newspapers, allegedly on the word of a military authority that it is the purpose of the Greeks immediately to cross the Graeco-Bulgarian frontier and occupy the towns of Poroy and Petrich and to hold them until the demand for an indemnity of 2,000,000 francs, an apology and punishment for the Bulgarian officers who started the trouble, has been met.

HAWLEY GIVES OREGON VIEWS UPON TAXATION

Western States Tax Payers Report Presented to Congress Committee by Oregon Congressman—Mellon Pres-Revised Set Income Tax Changes

The proposal suggested a rate of 1 per cent on the first \$3000 or taxable income, 2 per cent on the next \$1000, 3 per cent on the next \$1000, and 5 per cent thereafter.
