

# RUSH DEPUTES TO HALT LIQUOR WAR IN DESERT

SAN BERNARDINO, Cal., Nov. 9.—(A. P.)—Deputy Sheriffs Jack Brown and Jess Amarias early today were speeding over the long stretches of desert toward Government Holes, 250 miles east of here, where long standing troubles between cattle men and alleged bootleggers yesterday resulted in the reported killing of two men.

Brown and Amarias, men who know the desert, are under orders from Sheriff Shay of San Bernardino county to pick up constables and desert men en route and drive the gunmen forever from the region.

Reports to Sheriff Shay yesterday were that Matt Burt, believed to head a gang of bootleggers and a reputed "two gun man," had been killed in a gun fight with cattle men. The other man reported killed is believed by officers here to have been a cowman.

Government Holes is a watering spot in a sparsely settled district of the Colorado desert. Rumors of feuds between rum runners and cattlemen long have come from the bleak hills and desert wastes about the water hole where only the finger tips of the law have reached.

County officers believe the trouble is a result of resentment of cattlemen over the presence of illicit liquor runners who are reported to have made their headquarters near Government Holes and to have been active in running liquor across the Colorado river into Arizona.

Brown and his party are expected to reach the scene of the fighting about noon today.

## Oregon News in Brief

PORTLAND, Ore., Nov. 9.—(A. P.)—Leroy Hanson, formerly a special policeman, went on trial here today on a charge of first degree murder of James A. Day.

Hanson, according to the prosecution, shot and killed Day in a fit of jealous rage, after he had taken two shots at another man, not identified.

Both Day and Hanson lived in an apartment house. Day lived upstairs with his two children. Hanson lived with his wife in the basement.

PORTLAND, Ore., Nov. 9.—(A. P.)—Experiments of taking whitefish in the Crane Prairie section for sale in Portland markets by game commission operatives was authorized by the commission at its regular meeting today. Sportsmen have made complaint that whitefish feed on young trout.

SALEM, Ore., Nov. 9.—The First National bank of Salem today announced plans for the erection of a ten story office and bank building at State and Liberty streets here at a cost of \$450,000. Construction will begin in June.

## CRAWFORD QUILTS AS SUPT. OF FLAX INDUSTRY, SALEM

SALEM, Ore., Nov. 9.—Robert Crawford resigned today as superintendent of the flax industry at the state penitentiary and Governor Pierce said that John J. Quinland, prison engineer, would now be in full charge of all industries at the penitentiary, including the flax and farming industries. The governor refused to make further comment on the change, except to say: "I'm not going to have any further clashing of authority at the penitentiary."

The change was announced by the governor immediately after a very brief conference in his office early this morning with Crawford and Deputy Warden J. W. Lillie. The latter is acting warden during the absence of Warden A. M. Dalrymple, who is visiting eastern prisons and attending a national prison conference.

The governor said that Crawford would remain in the employ of the flax department. He has been superintendent since the beginning of the Pierce administration and also served in that capacity for a time under the Withycombe and Olcott administrations.

## RUM FLEET APPEARS OFF ATLANTIC COAST FOR CHRISTMAS TRADE

NEW YORK, Nov. 9.—(A. P.)—Fourteen ships of the rum row fleet have reappeared off the New York coast laden with holiday drinks. New tactics have been evolved to meet any repetition of the coast guard blockade of last summer that drove away the vessels anchored there. The

new flotilla does not anchor; when coast guard vessels make their appearance, the liquor armada takes to its heels and still coast guard vessels run out of fuel and have to go to port for replenishment.

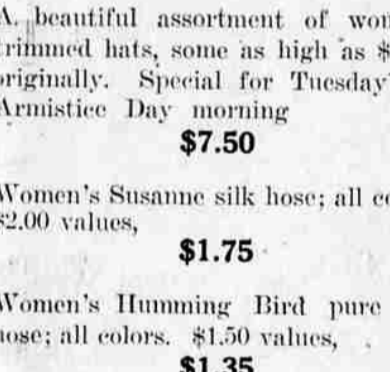
