3 AIRPLANES IN ALASKA MISSING

FAIRBANKS, Alaska, June 2.—(AP)—Anxiety for the safety of the seven men and three airplanes missing in the bleak and barren stretches of northern Alaska was growing again here today, due to continued failure of radio stations to get in communication with Point Barrow, objective of the fliers.

The missing men are Noel Wien, Fairbanks, and R. E. Merrill, Anchorage, pilots of two planes; Jack Robertson, L. Virgil Hart and Charles G. Clark of the Fox Film corporation, en route to Point Barrow to take Arctic pictures; and Matta Nieminen, pilot, and Hinko Hinko, radio operator of the relief plane which set out to look for the Fox expedition.

HAL HOSS WON BY A 6763 MAJORITY

SALEM, Ore., June 2.—(AP)—Completion of further official primary election totals by the secretary of state, show that Hal E. Hoss received 46,228 votes for the republican nomination for secretary of state, or 67.63 more than H. H. Corey, who was second in the race with 35,567. T. B. Handley's vote was 26,115.

For supreme court justice Geo. Rossman received 9,115; John L. Ham 7,828 and L. H. McMahan, 49,141. Ham's plurality over McMahan being 28,295.

The democrats, by writing in names, presented James W. Mott of Astoria with the democratic nomination for congress for the first district. Mott was an unsuccessful candidate against W. C. Hawley for the republican nomination. The democrats gave Mott 242 votes, Hawley 142. H. G. Starkweather 157.

SUSPECTED POST OFFICE ROBBER TRY GETAWAY

PORTLAND, Ore., June 2.—(AP)—En route to Portland from Astoria where he was arrested with Robert E. Kennedy as suspected member of the "Smokes" Johnson post office robber gang, Amos E. Jones, 31, attempted last night at St. Helens to smother his guard and escape.

Arthur Johnson, deputy marshal, reported that Jones threw an overcoat over his head as he sat on a seat opposite, but that Kennedy refused to aid in the attempt. The train conductor came to the assistance of Johnson, and Jones was overpowered.

Baby Cigaret Fiend Responsible For a Fire Damaged Home

MONTREAL, Que., June 2.—(AP)—A three-year-old cigarette addict was blamed today for a fire which destroyed and damaged the home of his parents Wednesday. Mrs. Henry Lamarche, the mother, told Fire Commissioner Quinn in court that all efforts of herself and her husband had so far failed to keep cigarettes from the boy.

"Well, the insurance companies are not going to protect you if you allow your three-year-old son to smoke cigarettes," said an insurance representative.

EX-CONGRESSMAN INDICTED FOR MAIL ROBBERY

CHICAGO, June 2.—(AP)—Charles S. Wharton, who, as former congressman, helped make laws and as a former assistant states attorney, helped enforce them, has been indicted with six others on charges of robbing the United States mails. The indictment, which came from the federal grand jury yesterday, is the result of investigation into the \$123,000 train robbery at Riverview Park a suburb, last February. Thirty government agents have been engaged in building the case against the men under indictment. They are: Charles Wharton, Charles (Jimmy) Cleaver, alleged leader; William Donovan, Frank Meyer, Lawrence O'Brien, Virgil Litzinger and John Plannery. The latter two are at large.

Plannery two years ago was sentenced to be hanged with Henry J. Prunke, the midget bandit, but was freed on a second trial.

Wharton, who is one of the city's well known criminal lawyers, was expected to surrender today. Bond already has been fixed at \$100,000 for him and at \$100,000 for the others.

Wharton appeared in the United States marshal's office today. He was arrested and released on \$100,000 bond.

SOCIETY WOMAN REFUSES TO OBEY ORDERS OF COURT

LONDON, June 2.—(AP) In a luxurious seven-room mansion in Hyde Park Mrs. Katherine Routledge, author, explorer and wealthy society woman, today held the fort against an order of court which arose out of differences with her husband, Scourgey Routledge, her companion in many adventures.

"I am doing this as a protest in behalf of women," she explained in an interview when she herself admitted since she has dismissed all her servants so that they might not become involved with her. The interview was admitted only after Mrs. Routledge had carefully scrutinized his card which he passed through a self in the door, and satisfied herself that he was not an officer of the law in disguise.

She explained that the trouble arose from the separation of herself and her husband last summer. The house and nearly all its contents are her property. After the separation was agreed upon, she sent her husband's books and personal belongings to various warehouses. Then the question as to who should pay the warehouse charges arose.

Routledge demanded his property, she said, but refused to pay the charges. She also refused and the warehouse people declined to surrender them without payment.

Litigation followed and the court ruled that she must restore her husband's goods. She still refused to pay the charges which would release them. This court, they issued the order of sequestration.

Mrs. Routledge determined she would not comply with it. She dismissed the servants and does all her own house work.

Shipping out at odd times to make a few necessary purchases, since she does not permit even the milkman to call, she said her treatment was due to the fact that she was a woman and that she had taken the present course to call attention to the unfair way women are treated.
