

T. A. FIFER HAS LEG FRACTURED IN AUTO CRASH

Turner A. Fifer, well known teller of the Medford National bank, is in the Sacred Heart hospital suffering from a fractured small bone in his left leg and a minor injury on the back of his head caused by his being struck at about 5:30 last night on East Main at Cottage street, by a car driven by William Morgan, a Medford high school student, 18 years old.

It seems that when Mr. Fifer, who lives on Cottage street was crossing East Main street, when Morgan who was driving Jack Porter's car eastward at from 18 to 20 miles an hour, and had just passed Dr. E. B. Pickett's car, first observed Morgan's car coming towards him, he became rattled, and zigzagged back and forth to get out of the way, thus confusing the driver.

Dr. Pickett, who witnessed the accident, it is said holds that Morgan was not to blame, which is also the theory of the police. The injured man first at treatment and had him taken to the hospital, where an X-ray examination disclosed the fractured leg bone.

MEMORIAL ORGAN IS PRESENTED TO CATHOLIC CHURCH

A \$7000 Reuter organ, the gift of the Misses Annie and Katie Kelleher in honor of their mother is the latest and most striking donation to the new Catholic church now undergoing construction on Oakdale. The organ, which will be installed November 15 is built to suit the conditions of the beautiful new church, a classic study in Romanesque architecture.

Other outstanding donations to the edifice include the oak pews, given by Mr. and Mrs. T. E. Daniels, and the art glass windows which represent individual parishioners. A decoration of particular beauty in the church is the large rose oval window in the front of the church, the east window of which will be ornamented with a scroll design.

The church, the dimensions of which are 12x52 with a 62-foot transept, is a classic study in Romanesque architecture. A tower rising to a height of 62 feet will be surmounted by the cross, typical of all Catholic churches. A valuable feature of the new building is the use of acoustical plaster throughout the church, which will assure perfect carrying quality.

Temporarily, according to Rev. F. W. Black, pastor, the old altar will be used in the new building as they are in keeping with the Romanesque architecture. The approximate cost of the building is estimated at \$45,000.

PEAR SHIPMENTS PASS 3000 MARK

With the shipment of forty-three carloads of pears from Medford last night, 3000 cars of pears have been shipped from here so far this season, and at least 300 more cars of pears and 500 apples, of which only a comparatively few cars have been shipped so far, are yet to go.

Shipping of pears and apples will continue at a much lesser pace than heretofore, for the next two weeks, until the number of shipments dwindles from 18 to 12 a week.

The packing houses which have been running comparatively light the past week, will begin a livelier pace this week when the shipping out of winter Nellis pears and apples will be begun.

The week before 842 mills reported 334,628,000 feet for a five-day running time. Production was 376,108,000 feet and shipments 391,858,000 feet, both slightly lower than the preceding week. Unfilled orders of 324 southern pine and west coast mills were 871,945,937 feet, against 829,465,320 the week before.

REPAIR BYRD'S SHIP, VOYAGE IS RESUMED

PANAMA, Sept. 22.—(AP)—After having had its pumps repaired, the City of New York, supply ship of Commander Byrd's South polar expedition, was at sea again today headed for Dunedin, New Zealand. From there the explorers will go to the edge of the Antarctic ice cap.

PUPILS MARCH OUT AS PORT. SCHOOL BURNS

PORTLAND, Ore., Sept. 22.—(AP)—While fire swept the Fernwood school, two miles east of Newberg, late yesterday, two score children marched calmly from the building. The fire had gained headway before the danger was discovered, and when the alarm was sounded the children stood at their desks and marched out quietly without panic. The building and the year's work supply nearly were destroyed. The gymnasium was saved. Origin of the fire was undetermined.

Scotch Truckman Sells Bricks for Case of Whiskey

LONDON, Sept. 22.—(AP)—Sixty days in prison with hard labor is the sentence that John O'Rourke, a Glasgow truckman, has received for substituting bricks for 24 bottles in two cases of a load of whiskey which he was conveying from the railway station to the docks.

News dispatches from the Scottish port say that this case may be an explanation of many complaints received from certain quarters in the United States that whiskey cases from the Clyde districts often contained hard stuff in the form of bricks instead of Scotch blends.

POWER PUBLICITY GIVEN ON COAST

WASHINGTON, Sept. 22.—(AP)—Publicity activities of power utilities in Pacific coast states will receive attention of the investigation being conducted by the federal trade commission during the week of October 7.

Although no definite dates or list of witnesses have been made public, the commission announced today that California, Oregon, Washington, and perhaps other western states would be covered soon after the inquiry into utility affairs in the south is completed.

The southern phase of the investigation, which will cover Georgia, Alabama, Tennessee, and North Carolina, begins next Tuesday.
