

### FOOTBALL FANS SHOULD NOTIFY S. P. OFFICE HERE

Southern Oregon football fans planning on traveling to the Benson Tech-Medford high football game at Portland Thanksgiving day, should advise local Southern Pacific officials at one of their intentions, so ample equipment can be obtained. The special rate of \$14 for the round trip is good from all Eugene and Astoria points. It will leave Portland about 9:20 o'clock after the game, and arrive home Friday morning. Arrangements have been made for the Elks band to make the trip.

The football team of 28 men—the entire first, second and third string—will leave Tuesday night, and arrive in Portland Wednesday morning. They will indulge in a light workout Wednesday afternoon, and then rest until the game. The team will have their holiday dinner after the game, which will mark the official breaking of the football training season.

### CHANNEY EXPENSES REPORTED AT \$20

In his unsuccessful campaign for reelection as district attorney, Newton Channey, despite the vicarious fight put up for him in the newspapers, only spent \$20.75, according to his campaign expense statement, filed with the state department at Salem last Saturday.

His successful Democratic opponent, George A. Coddling, spent something like \$92 in his campaign. However, these two rival candidates did not need to spend much out of their own pocket books, as the brunt of the fight for each was carried on by his respective county central committee. Especially was this so in Channey's case, as not only the Republican county committee waged a campaign in his behalf, but also the Citizens' Tax-payers' committee.

About all that Messers Channey and Coddling had to do was to let nature take its course and work personally and lay back until election day to see what course the voters took.

The expenses of the Jackson County Republican committee during the campaign were \$2100, as filed by Vernon Marshall, treasurer of the committee, with the state department at Salem, instead of \$2800, as was inadvertently stated in this newspaper.

### NATIONAL PARK RECORDS MOVED TO WAREHOUSE

The accumulation of the voluminous records, office equipment, etc., of the Crater National park headquarters office since the beginning of the park's legal existence as such, which have been stored for years in the attic of the federal building in this city, were being removed by big motor trucks today to the Crater National park warehouse on North Central avenue, which was completed last spring.

(AP)—Sgt. Stajer, a former secretary of Arnold Rothstein, has been arrested as a material witness in the shooting of the gambler on November 4, the police announced today.

### Malchus' English and Son Drowned in Klamath River

(Klamath Falls, Ore., Nov. 26.—AP)—Malchus English, Klamath purchasing agent for the Weyerhaeuser Timber company, and Penney English, his six-year-old son, were drowned in the icy waters of Klamath river, six miles south of Klamath Falls, when a 22-foot motor boat operated by Dr. Paul W. Sharp, Klamath Falls, foundered after striking thick ice.

As the boat started to sink, stern first, English took firm hold of his son and jumped into the water. Fifteen yards from shore he stopped. His son slipped out of his arms and drowned in 15 feet of water. English was pulled to shore by Dr. Sharp. All attempts at resuscitation proved futile.

Dr. Sharp said it was probable that Mr. English had collapsed from heart failure.

Only the stern sank. Had the seven persons on the boat crowded up to the bow, no fatalities would have resulted.

Dr. Sharp saved Mrs. C. H. Mueller, who was the first to jump and who had lost her life-preserver. Before Mr. English collapsed, he dove twice for the little boy, but was unable to reach him. The body of the child was recovered a short time after the tragedy.

### HEALTH PROGRAM OF COUNTY UNIT IS GIVEN KIWANIS

An interesting resume of the Jackson County Health Unit program followed during the past year, was presented by Mrs. Lydia King, county health nurse before the Kiwanis club this noon at Hotel Medford.

Referring to the unit as "the machinery that promotes and protects the health of the county," she pointed out a number of branches of the work covered by this organization, and with which the average citizen is not familiar.

The most positive results of the work is obtained by the prevention and educational measures established through the county. Reports are sent into the local office periodically from the various school centers so that the county physician and nurses have a direct contact with those who need aid and lose no time in being of service to them.

Epidemics and contagious diseases are battled before they get a head start upon the community. Then the preventive treatment of the unit. Infant and maternity clinics are held periodically as are the tubercular clinic, school clinics, orthopedic and chest clinics.

A loan closet is maintained by the Jackson County unit, in which sick room supplies, which have been donated, are kept and loaned to poor families who cannot afford them.

Mrs. King invited the Kiwanians at the close of her talk, to come up to the health office in the court house and take an inventory of the supplies.

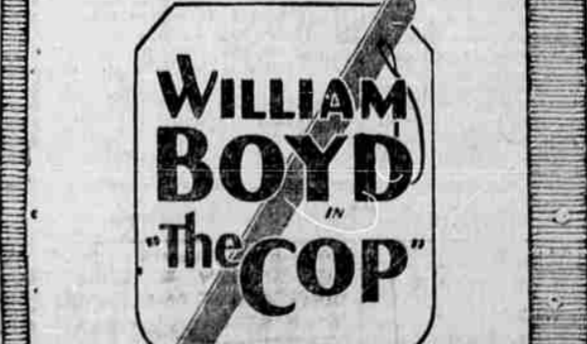
