

STOCKS CORRECT TOP-HEAVY FORM BY SELLING OFF

NEW YORK, Jan. 5.—(AP) The stock market displayed a complete reversal of form today, selling off sharply after a spirited opening rally.

After an opening lull in each stock Radio and Victor Talking Machine broke sharply on the traditional "selling on the good news" following the announcement of merger terms.

Motor stocks were under pressure on the theory that recent price cutting foreshadowed keener competition among the leading manufacturers.
