

COUNTY GRANGES GROWTH TOLD TO ALL DAY SESSION

The Pomona grange held its first regular business session of the year at Talent, with the Talent grange as host. About sixty grangers were present.

The reports of the masters of the eight granges throughout the county showed that very satisfactory progress is being made, with new members being taken in at nearly every meeting.

Many grangers from northern California were present and told of the progress of granges there, as well as giving interesting advice on grange work.

Immediately after the lecture hour the county deputy installed the new officers for the coming two years.

The executive committee elected was Ross Kline of Eagle Point, John Neidermeyer, of Jacksonville and George Hilton of Central Point.

The new master appointed the past masters of the past year of the subordinate granges as a committee on committees.

A few of the resolutions and motions brought before the grange were acted upon as follows: Resolution requiring school teachers to teach full 20 days per month, opposed. Asking legislature to adopt measures to protect natural water power projects, adopted. Opposed the Columbia river reclamation project and urged legislature to oppose all new reclamation projects of this nature until there shall be no agriculture surplus from present acreage now under cultivation. Resolution of sympathy to Brother Sparks, past master of the Pomona grange, who is ill in Jacksonville sanitarium, was adopted. It was also moved to send lecturer to lecture at the school, which will be held in Corvallis on the 12th of February.

The grange gave a rising vote of thanks to Talent grange for their splendid hospitality for the day.

A special meeting was called by the master to be held at Central Point, Tuesday evening, January 29th, at 7 p. m. There is much business to be done at this special meeting and all are requested to be on time.

The master appointed Brother Clarence Davies as a committee of one to arrange for a 5th degree team.

BULLETIN BOARD GIVES FEDERAL DEPT. LOCATION

Not all the various departments of the U. S. government of Medford are housed in the federal building here—only the most important ones are—and because a number are scattered about the business section of the city so much trouble was caused by strangers calling at the federal building and hunting up certain offices that Postmaster Warner, establishment of that building has established a bulletin board in the main lobby floor, giving the location of each of the outside federal offices.

Heretofore this bulletin board only told of the federal offices on the various floors of the building. Those located outside are the following: U. S. commissioner, First National bank building; U. S. free employment bureau, chamber of commerce building; County agents, Liberty building; U. S. Geological survey, county court house; U. S. referee in bankruptcy, Medford Center building; federal prohibition officers, police station; U. S. weather bureau, Liberty building.

The federal offices located in the federal building are: first floor, Medford postoffice; second floor, district court room; district court clerk, district judge, United States marshal, Crater National park and army recruiting office. Third floor, Internal revenue office, deputy collector of Internal revenue, postal inspector, Crater National forest.
