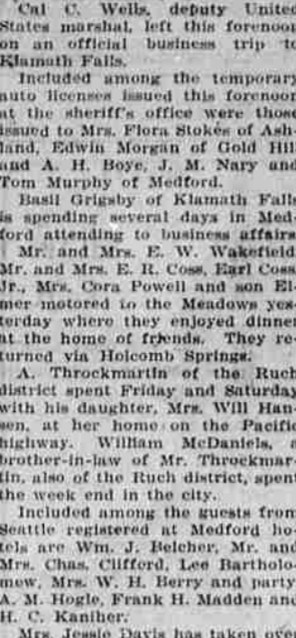

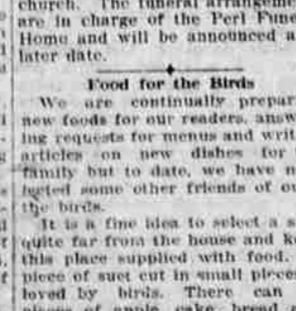

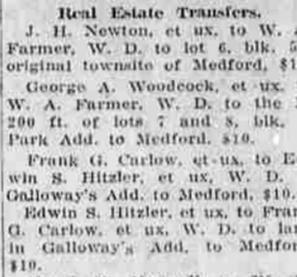

How to Carve Meats Correctly

A skillful carver of meats does not remove the fork during the entire process of carving.

The carving fork should be placed in the meat at the left in a position that will steady the whole roast or fowl. Sharp knives are necessary of course.

To carve a rolled rib roast cut very thin slices across the grain.

The difficulty of carving a porterhouse steak is lessened if the bone is removed before cooking. If the bone is left in the carver first cuts around the bone with the point of his steak knife, freeing the meat from the bone.

To carve poultry, plunge the fork in the breast bone, separate the leg from the body by cutting down to the leg joint and foreseam the leg over sharply from the carcass. Then separate the drum stick from the thigh. Then slice off white meat from the breast and cut next. Disjoint the wings in the same manner as in removing the leg. A guest is always asked for a choice of portions and if no choice is given a slice of white an done of dark should be served.

Carving is not easy, but may be done well by the novice if the joints of a meat are known and the knife is very sharp.

Varieties of Italian Paste

Italian pastes are all made from wheat flour although there are many varieties of them. They are all made from the same dough, therefore, the tests for determining the quality of one applies to all of them.

They should be of an even, creamy color, if they are gray or white streaked with white, they are of inferior quality.

When they are broken into pieces, they should break off perfectly straight. If they split lengthwise, they contain weak places due to streaks.

All varieties should upon boiling hold their shape and double in size; in case they break into pieces and flatten, they are of poor quality.

The chief varieties are macaroni, spaghetti, and vermicelli. Macaroni is the largest in circumference, spaghetti a trifle smaller and vermicelli very small and without a hole through the center.

On Top of the Tea Cart A neglected item in many a well ordered household is the tray that sets on top of the tea cart. Because of the dark wood beneath the surface of the glass, smudges or stains are likely to be overlooked until the tray is lifted while dinner or tea is being served.
