## CALIFORNIA CREW WINS ON ESTUARY

**Bruins Take Lead at Gun and Never Headed—Five and Half Lengths to Fore at Finish—Bear Freshmen Victors in First Race—Huskies Take Junior Varsity Event.**

OAKLAND ESTUARY, Cal., April 13.—(AP)—Pulling far ahead of their northern rivals with a terrific pace, the world champion University of California crew decisively defeated the University of Washington eight by five and one-half lengths in their annual three-mile race on the estuary here today.

The Bear crew, including seven of the nine veterans that swept to 10 consecutive wins and the Olympic championship last year, defeated the northerners in a surprisingly easy manner. They went into the lead at the start with a powerful sprint and continued to pull ahead for the remainder of the race.

At the half-way mark they led by two and a half lengths. About a mile from the finish the Bears had increased the lead to four lengths, 200 yards from the end they were four and a half lengths ahead and this advantage was increased to five and a half lengths with a great driving finish.

The official time was 15 minutes and 14 seconds, which is five seconds slower than the course record that was set by Washington in 1923 at 15:09. The varsity race was the third of the regatta program.

Honors in the first two races were even with the California freshmen sweeping across the finish line, 10 feet ahead of their northern rivals, and the Huskies coming back in the junior varsity race to trounce the Bears by three lengths with a new course junior varsity record.

The official time for the California yearlings in their two-mile race was 10:37.45, which is 14.45 seconds slower than the 10:23 record set up by Washington in 1925. The Husky Jayvees rowed their three miles in 15:46, officially smashing the mark of 1:25:25 set by Washington in 1925.

The races were watched by a great crowd of approximately 50,000.

## DRY AGENTS TO SURVEY GRAPE JUICE MARKET

WASHINGTON, April 13.—(AP)—Prohibition Commissioner Doran announced today that he had instructed the two prohibition administrators in California to make a survey of the juice grape situation in that state. The commissioner said he wished to obtain an estimate of the acreage and methods and places of marketing juice grapes.

Commissioner Doran, who declined to divulge the purpose of the investigation, said at this time he was not prepared to say that any of the juice grape crop was eventually reaching illegal liquor traffic channels through being converted into wine.

## WHALEN FLAYS HOSTESS TRIAL AS AN AFFRONT

**Guinan Publicity Arouses New York Police Commissioner—Night Club Atmosphere 'Vicious'—Urges Move to Ban Girls.**

NEW YORK, April 13.—(AP)—Aroused by the acquittal in federal court of Texas Guinan, Police Commissioner Whalen in an address last night advocated a law forbidding employment of hostesses in night clubs.

He declared the night club atmosphere to be a "vicious" one and said that the demand for girls between 18 and 18 years of age for hostesses was so great as to create a serious moral situation.

Although he did not mention Miss Guinan by name, he said the publicity given the trial of a night club hostess this week "was an affront to law and order."

"This question of a night club hostess is a very serious one," he added. "It is becoming close to something else long since driven out of this community, and the young girls who read of this case will be led on by the publicity given her 'heroism.'"

"It sickened me to see the publicity for the person on trial this week was in the forefront in bringing young girls into this unwholesome atmosphere."

The commissioner spoke before the newly organized church laymen's committee of the Greater New York Federation of churches. He said he hoped the federation would get behind a movement to have a law enacted prohibiting employment of night club hostesses in New York. Miss Guinan was acquitted of a charge of maintaining a nuisance through sale of liquor at a club where she was hostess.

## CHICAGO STUDENT BEATEN TO DEATH BY OLDER YOUTHS

CHICAGO, April 13.—(AP)—Each of the 4000 students of the John Marshall grammar and high school is to be questioned under the police plan for finding out who was responsible for the death yesterday of nine-year-old Joseph Stein.

The boy returned from school complaining of having been beaten by older boys. Half an hour later he died. A post mortem examination failed to show signs of violence, but when a second examination was made, in view of stories of being beaten, an injury to the temple was found. It was this blow, Dr. J. Kearns of the coroner's staff said, that caused death.

C. A. Beers, principal of the combined school, said all students would be called in, one by one, placed on their honor, and asked to tell what they might know of the fight that ended fatally.

GRANTS PASS PEARS UNHARMED BY FROST

GRANTS PASS, Ore., April 13.—(AP)—Although cherries and peaches in this district have been hard hit by recent heavy frosts, growers of commercial pears say this fruit has not been damaged. Early morning frosts, fruit growers say, have minimized the damage to the pears. The prolonged frosts are the most severe in many years.

## BOY SCOUTS FALL FROM CLIFF PATH

**One Dead—Scout Master Hangs on Edge of Chasm for Eight Hours—Group Is Overtaken by Disaster On Quartzite Peak Near Town of Chewelah, Washington.**

CHEWELAH, Wash., April 13.—(AP)—With one of their party dead, another with a broken leg, and their scoutmaster in a serious condition from cold and exposure after hanging over the edge of a cliff for eight hours, a group of Boy Scout mountain climbers were returned to Chewelah today.

A party of six scouts with Don Hutchinson, their scoutmaster, and Paul, his brother, a former United States football star, and later across the city to Grand Central Terminal where, late today, it will be taken to his old home in Cleveland.

Claws were at half staff and many thousands stood with bared heads as the impressive procession wound its way to the railroad station.

In one of the cars in the cortege was Colonel Charles A. Lindbergh. The flying colonel and the late ambassador were warm friends, their friendship dating back to the day when Lindbergh was welcomed by him to Paris after his historic flight across the Atlantic.

## SENATORS SEE DEBENTURE AS BEST FARM AID

WASHINGTON, April 13.—(AP)—Some members of the senate agriculture committee have definitely turned to the debenture plan of the national grange as a part of the new farm relief plan in place of the equalization fee.

While there is as yet no certainty that a majority has been won over, it is the opinion of many committee members that the plan has an excellent chance of becoming part of the senate farm bill unless President Hoover declares against it. At the same time, most of the members feel that it would certainly fall in the committee if the White House objected.

The plan, on the other hand, has found little favor on the house side. In fact, a number of house agriculture committee members who called on President Hoover yesterday, told him that a majority of the house members were opposed to it.

Senator McNary of Oregon, chairman of the committee, has taken no stand on the plan, but he has notified that the committee was "very much impressed" with the testimony of agricultural department experts that the plan was working out well in Norway and Germany.

WASHINGTON, April 13.—(AP)—President Hoover was represented today as being in accord with the general principles of the new farm relief bill, as drafted by a house sub-committee which presented it to him yesterday for study.

NEWBURY, England, April 13.—(AP)—Athford, by Blandford, out of Athasi and owned by W. Barnett, won the Newbury cup today.

## WAR BILL HANDED TO TEUTONS



**Ten Billion War Damage Asked By Allies—Dr. Schacht Grimly Solemn—Rumor Says Germany Will Reject Claim—Acceptance for Study Mere Polite Formality.**

PARIS, April 13.—(AP)—The allies' bill to Germany for reparations for damages incurred in the World War was handed Dr. Hjalmar Schacht, president of the reichsbank, in the tea room of the Hotel George V. this morning.

The size of the bill was not announced officially, but it was said generally it had a present value of from \$10,000,000,000 to \$12,500,000,000, calling for annuities over a period of 33 years totalling around 100,000,000,000 gold marks—about \$24,000,000,000.

The presentation of the bill came after nine years of bickering as to its size between the allied creditor nations and Germany, the debtor. It represented a reduction, it was believed of nearly \$100,000,000,000 under the maximum of \$125,000,000,000 claimed by the allies before the Versailles conference.

The Gernah delegation, headed by Dr. Schacht, appeared promptly at 11:30 a. m. for the meeting in the tea room. There was about them all the grim solemnity of the opening session of the reparations conference on February 11.

As they entered the tea room and the door closed behind them the anteroom buzzed with talk that they were already aware of the amount of the claim and would reject it. Through courtesy to the allied delegates, however, they were expected to go through the fiction of studying it for a day or so.

## REVOLT END IN MEXICO SEEN NEAR

**Rebels Depressed By Federal Victories—Morale Falls After Surrender of Officers—Whereabouts of Escobar Unknown—Presidential Aspirant Also Missing.**

NOGALES, ARIZ., April 13.—(AP)—An atmosphere of depression descended upon rebel headquarters across the border early today and rumors were being heard on all sides portending a complete collapse of the rebel movement in Mexico.

Reports of sweeping federal victories on all battle fronts appeared to have had their effect on the morale of rebel leaders, and a distinct note of pessimism was manifested at rebel headquarters in Nogales, Sonora. However, a feverish activity was noted on the Mexican side of the line.

The rebel morale suffered a tremendous blow last night with the surrender of General Francisco Manzo, commander of rebel troops on the west coast. General Benito Bernal, his chief of staff, and 13 other rebel staff officers to United States immigration officials here.

Unofficial reports stated that Manzo had been court-martialed and removed from his command by General Jose Gonzalo Escobar, the rebel commander in chief.

SENATOR BAILEY OF TEXAS DEAD

SHERMAN, Texas, April 13.—(AP)—Joseph W. Bailey, former United States senator from Texas, dropped dead in the district court room here today.

Mr. Bailey was appearing in a case involving toll rates on a bridge over the Red river. He dropped dead shortly after making a plea for the transfer of the suit to the federal court.

## KLAMATH FORGER MUST LEAVE CITY

KLAMATH FALLS, Ore., April 13.—(AP)—The mercy of the court and the intervention of a protective society saved Mrs. Rose Randall, forger, from a prison sentence yesterday. She pleaded guilty to the charge of forgery and was sentenced to five years in prison, but paroled to Mrs. Clara J. Upton of the Pacific Protective society. Judge Duncon imposed another condition, that she do not return to Klamath Falls.

Mrs. Randall's husband, William Miles Randall, was sentenced to serve three years in prison for forgery.

Rev. Percy Elected BAKER, Ore., April 13.—(AP)—Rev. Herbert E. Percy of Baker was elected secretary of the 19th annual convocation of the eastern Oregon missionary district of the Episcopal church, in session here yesterday. Bishop William P. Remington of Pendleton is president.
