He said he can run five miles easily in 43 minutes. He keeps in constant training and has taken part in running races all over the nation.

When he trains he uses shoes weighing five pounds each and when he takes part in a race he uses lighter shoes, causing his feet to feel much lighter and giving more inspiration to run.
