The Meaning in Golf
 The World Worries.
 Mr. Rockefeller Does Not
 Unwise Unionism.

A meaning beyond technical golf, in the fact that Hagen, an American player, was first, in the annual British championship, open to all players. Also in the fact that Farrell, an American, was second, and Diegel, an American, was third.

Hagen has won the "open" four times in all, and twice in succession. An American played the difficult 18 holes in 67 strokes, far under "par," breaking all records.

Golf, in itself unimportant, like chess and other games producing no result, is highly important, in its proof of power to concentrate continuously.

To play golf as those three young Americans played it, amazing and defeating the British, proves that something in this country promotes intense concentrated effort. To that concentration we owe our industries, our prosperity, our amazing growth.

Your newspaper columns look like a catalogue of the world's worries. Each nation has its special anxieties. We are worrying about the tariff. Big producers worry, lest they get insufficient protection.

Farmers fear that farm relief may only provide more middleman profit. And they worry with good cause.

Prosperous Britishers worry about the coming election. The Socialist party, which is the Labor party, may again control the government. Unemployment will be responsible if that happens.

Even if labor lacks a majority, it may be the strongest of the three parties, in parliament.

The German debt settlement worries France, England and other countries. They want Uncle Sam to do the work, make the plans, take the responsibility. But they are afraid that our suggestions will not include a sufficiently complete draining of Germany's resources.

That question will probably be settled within two weeks, in a sane manner. Germany will be taxed an amount that she can pay. And following the definite agreement, Germany's prosperity will increase swiftly.

Millions of young Germans now begin their lives in industry, instead of wasting four years each in the army.

Five hundred thousand young men, producing, instead of soldiering, will easily be worth to Germany \$1,000,000 a day over and above the cost of feeding, clothing and housing them. Their surplus earnings, alone, will almost pay the German indemnity.

Ireland has a special worry, in the greatly increased sales of English newspapers throughout the Free State.

Irish newspapers are dropping, London and other English newspapers growing in Irish circulation daily.

The worry is racial, not financial. The Irish fearing that British ideas and modes of thought will supplant Irish ideas, and that Ireland will cease to be Irish.

The British worry about loss in population. "Flappers" allowed to vote, seem reluctant to marry, or at least to have children.

Within three months the number of deaths in England and Wales exceeds the number of births by 50,000. It is not a case

U. S. PLANS KLAMATH RAIL EXTENSION

SURVEY OF LINE EAST IS ORDERED

John S. Owen, President of Big Timber Concern Announces Move for Connecting Link—Forty Mile Construction Would Tap Vast Timber Wealth—Take Fruit Tonnage.

The Owen-Oregon Lumber company of this city, has under consideration the extension of its logging railroad from Butte Falls, the center of its logging operations to Klamath Falls, according to a statement today by John S. Owen of Eau Claire, Wisconsin, president of the timber concern.

"I think our railroad should be extended to Klamath Falls, and orders have been issued by the board of directors to James H. Owen, general manager to proceed with the survey. We are going to find out if a line is practical, and it is certainly worth investigating," said John S. Owen.

James H. Owen, general manager, said that pursuant to instructions he would have a surveying crew in the field in a short time.

The present railroad line from Medford to Butte Falls is a standard gauge, heavily railed and heavily ballasted, 32 miles long. It was formerly the Pacific & Eastern, purchased by the Owen Oregon company when they started operations here. The P. & E. was formerly owned by Hill interests, and was built with a view of extension to Klamath Falls and Bend, a decade ago.

The Owen-Oregon company has a logging railroad operating out of Butte Falls and is the one to be extended. The distance to Klamath Falls is about 40 miles. The district is rich in virgin timber, with easy water grades. Three years ago James H. Owen made a personal trip over the district, and reported "a route was feasible for the construction of a railroad."

He later sent out a surveying crew. Last year a surveying crew was in the field making preliminary surveys.

It is known from sources outside the Owen-Oregon Lumber company that they have long been interested in the extension of their present logging operations, so it will tap a large volume of timber on the divide between their present holdings in eastern Jackson county and the Weyerhaeuser holdings, and give them a direct route east.

West Route Too Big
 Asked regarding the report that the Owen-Oregon company was concerned with the construction of a railroad to Crescent City, Calif., John S. Owen said: "That is too big a proposition for us."

The Weyerhaeuser company is now building a logging railroad to their holdings on Spencer creek, in Klamath county, and the two extensions would be in touch with each other.

Besides developing the timber industry the proposed extension would open new summer recreational area, and provide fruit shipments of the Rogue River valley with a shorter route east. It was unofficially announced last week that the Southern Pacific contemplated routing fruit shipments via Alturas, Calif., as soon as possible, going from here to Weed, Calif.

Then to Klamath Falls, and then over the Alturas cut-off, thus saving 12 hours in transit, a day on the fruit auction market, and avoiding the icing congestion at Roseville, Calif. The proposed new route would save the trip to Weed and halfway back.

There have been many reports regarding the extension of the Owen-Oregon lines, but the statement of John S. Owen today is the most definite.

John S. Owen, accompanied by his brother, William C. Owen of Pontiac, Mich., leaves tomorrow night for his home in Eau Claire, Wisconsin, after spending two weeks here attending to business matters and visiting relatives. They returned Friday from an auto trip to Crescent City.

RECESS OF SOLONS TO BE SHORT

Republicans Abandon Suggestions for All Summer Vacation—Hoover Invites Borah, Fess to Peace Dinner—Concerned By Party Break in Senate Over Fess Letter.

WASHINGTON, May 13.—(AP)—Holding the export debenture plan of farm relief constitutes revenue legislation and under the constitution therefore should originate in the house, Republican house leaders today decided to move to refuse to accept the senate farm measure after its approval by that body.

WASHINGTON, May 13.—(AP)—Republican leaders today abandoned suggestions for an all summer recess and determined to mold the party majorities in congress into working shape for early decisions on the controversial farm relief and tariff issues.

President Hoover took the initiative yesterday in bringing his scattered forces in the senate together, inviting Senator Borah of Idaho to luncheon, and the critic of the Idahoan, Senator Fess of Ohio, to dinner at the White House.

Today Senator Watson of Indiana, the Republican leader, put his foot down on talk of an all summer recess although he announced a willingness to consider a recess of three weeks or a month beginning early next month after the house completes the tariff measure and while it is under study of the finance committee.

Mr. Hoover is disturbed over the party break in the senate which was brought into the open when Senator Fess, the Republican whip made public a letter condemning Senator Borah "and the other pseudo Republicans" for failing to support the Hoover views on farm relief.

DENT. BURDICK EXTORTIONIST CLIENT CLAIMS

PORTLAND, May 13.—(AP)—Charles Paulin, Denton G. Burdick, Oregon attorney, charged today, a former speaker of the house of representatives and present member from Deschutes county, extorted \$47,500 from her by "falsely and fraudulently representing his status and ability."

Mrs. Smith declares in her complaint that she lost a considerable sum of money and property several years ago and that Joseph E. Marsh, an old acquaintance, gained her confidence in 1927 and brought Burdick to her residence in Bellingham in October of that year, urging that she retain him in a legal capacity in connection with her losses.

The complaint alleges that Burdick told Mrs. Smith he was very influential, was an intimate friend of a former governor of Oregon, and could bring to justice the people who had defrauded her. He said, too, the complaint declares, that he could bring about the recovery of her money and property, whereupon she paid to Burdick and March \$15,000.

PORTLAND PAIR FIVE KILLED IN HELD IN DEATH AIR ACCIDENTS GROCERY CLERK DURING SUNDAY

Wife Tells of Secret Marriage—Husband Did Not Mean to Shoot, She Claims—Mother Persuaded Son to Surrender.

PORTLAND, May 13.—(AP)—Charles Paulin, 22, and his wife, Bertine, who have not lived together at all during the three years of their secret marriage, found themselves under the same roof today—in the city jail—with the spectre of murder hanging over them.

Paulin is charged with the slaying of Harry Nichols, 25, a grocery clerk, at the St. Paul hotel here, Saturday night. His wife, whom he surprised in Nichols' room, is held as a material witness.

Paulin gave himself up at police headquarters yesterday after police had searched for him for 15 hours.

"He did not mean to shoot," Paulin's wife declared today. "Oh, I know he did not intend to shoot!"

"We were secretly married three years ago. It was an elopement. We were carried off our feet—it was against my better judgment. We were emotionally and mentally incompatible. He cared nothing for books and reading. I wanted him to study and better himself, but he seemed unable to get farther along than cab driving."

"So I maintained an apartment by myself, while he lived with his mother and brother."

With another girl, she said, she stopped in for two or three minutes to see Nichols in his room. As they were there, Paulin entered and shot. Paulin then fled. He later surrendered on advice of his mother who spent the early hours of a jittery "mother's day" in persuading her boy against flight.

ORDER REARGUMENT CUT IN FRUIT RATES

WASHINGTON, May 13.—(AP)—The supreme court today ordered for reargument on October 21 next the appeal of the Ann Arbor and other railroads seeking to prevent a reduction in the rates on deciduous fruits shipped out of California. The case was argued several weeks ago.

RAINFALL CONTINUES IN KANSAS

More Damage Threatened in Kansas, Missouri and Oklahoma Flood Zone—Three Lives Lost Over Week-End—Bottom Farm Lands Suffering Greatest Loss By Water.

KANSAS CITY, Mo. 13.—(AP)—More damage was threatened today as floods in sections of Kansas, Missouri and Oklahoma swirled to new heights as light rains continued to fall.

Three lives were lost and great property damage was the toll exacted over the week-end by swirling waters. Most of the damage followed sudden downpours in central Kansas where the waters engulfed parts of Council Grove, Herington, Gypsum, Lindsay, and other towns.

Two Mexicans lost their lives in Herington. John L. McGehee, commissioner of Noble county, Oklahoma, was drowned near Red Rock. Flood waters from Kansas today bore down on northeast Oklahoma.

The forecast was for cloudy weather and light showers, tonight and Tuesday over the flooded area. The Smoky Hill river, at Salina, was breaking over residential sections.

Herington and Council Grove were cleared of the high water almost as suddenly as they were inundated.

Greater damage from the Neosho river, which engulfed Council Grove, was feared farther down its watershed, to the southeast. The stream was reported falling at Chanute and had dropped ten inches from yesterday's peak, but still was rising to the south.

Apparently the greater damage, as is ordinarily the case in floods in this section, will be inflicted on bottom farm lands.

Spring river and other streams went out of their banks in southwest Missouri last night following 24 hours of heavy rainfall.

At Fort Scott 150 homes were flooded late yesterday by the Marimaton river. Many families took refuge in railway depots and other buildings thrown open to them, where they spent last night.

CLIMATE CAUSE OF PADDLING IS VIEW OF FATHER

Long Beach Sorority Girls Full of Pep, Says Dad of Suspended Student—School Board Is Threatened By Parents.

LONG BEACH, Calif., May 13.—(AP)—The father of Margaret Lindsay, 18, who attained her sorority at the price of taking her meals from the mantelpiece, and the parents of nine other young ladies who initiated Margaret with paddles, today threatened war on the board of education for suspending their daughters from Polytechnic high school.

"I will send Mary Jane to school tomorrow," said Mrs. M. J. Meisenheimer, "and we will see whether they refuse to admit her to classes. I am proud of the girl because she told me the truth."

The girls were suspended for belonging to a sorority, contrary to a state law. The sorority had become known to officials when Joel Lindsay protested that the girls were "too rough in initiating his daughter into the secrets of the order with wooden paddles. Miss Lindsay, he said, was forced to stay in bed two days and was still dining in the buffet or free lunch counter."

"They are not going to suspend her," declared Lindsay. "The experience already has been painful enough for any girl. She's resigned from the order, anyway."

"Oh, well, girls will be girls," said the father of one of the suspended young ladies. "These girls are just husky, full of pep, that's all. It's the climate."

George Stallings Miracle Man Dies



HADDOCK, Ga., May 13.—(AP)—George T. Stallings, who won fame in 1914 by capturing the world's baseball championship for the Boston Braves, died early today at his home near here. Stallings was 63 years old.

Death came at 5 o'clock this morning, after an illness of several months which had forced his retirement from the management of the Montreal club of the International league.

Stallings was given the name of the "Miracle Man" in the baseball world after his remarkable record in 1914 in leading the tail-end Boston Braves to the pennant and the world championship.

He was a native of Augusta, Ga., but had lived near here for 25 years except during the times when he was absent attending to his baseball duties.

A widow and three sons survive.

AIR FUNERAL IS PLAN FOR AGE OF WAR FAME

LONG BEACH, Calif., May 13.—(AP)—Appropriate funeral arrangements were being made here today for Bernard Lauscher, 32 year old German world war ace, officially credited with downing five allied planes, who was killed in a freak airplane fall from a distance of fifty feet at the edge of Death Valley Saturday afternoon.

The plans, not fully consummated, already call for an "air funeral," in which the body of the dead German hero will be flown from the funeral parlors to the cemetery, with a group of southern California aviators flying in formation above the aerial cortege.

Lauscher was earning his livelihood by flying eager eyed tourists from Trona, Cal., to Death Valley, one of the most interesting desert regions in America, famed for its mystery and sinister beauty.

A hot desert wind, blowing over the sand dunes caught his plane, tipped it into a steep bank and careened it to earth.

Lauscher, during the war, was shot down from 10,000 feet altitude by French anti-aircraft guns. He landed in German territory, seriously wounded, returning to his squadron a few months later. Shortly afterwards his plane was set afire in an aerial battle, and he leaped to safety in a parachute.

UNIVERSITY FORCED TO OPENDOORS

Students Obtain Injunction Against Order of Board Closing Des Moines University—Trustees Restrained From Interfering With Instruction for Semester.

DES MOINES, Iowa, May 13.—(AP)—Des Moines university, ordered closed "until further orders" by the board of trustees following student riots Saturday night, was reopened today through issuance of an injunction restraining enforcement of the order of the board.

Dr. Harry C. Wayman, president of the university, was notified of issuance of the injunction by telephone and without waiting for formal serving of the district court's order summoned the students to return to their classes.

The injunction was said to be in the nature of a friendly action. Earlier, Dr. Wayman, who with the remainder of the faculty had been released by the trustees, had said he would carry out to the letter the order of the trustees suspending all classes and lectures in the university until further notice from the trustee board.

Application for the temporary writ of injunction was made by six students of the university and asked that the president of the school and its board of trustees be restrained from closing the university during the remainder of the current semester and from taking any action which might interfere with the regular operation of the university.

The petition further demanded that the defendants be restrained in any way from limiting the degree of instruction or limiting the granting of credits.

The disorders of Saturday came to a head after a meeting of the trustees called to investigate charges of some of the students involving Dr. T. T. Shields, 61, Toronto, president, and Miss Edith H. Robman, 48, secretary of the board. In the background also were reports of a fundamentalist-modernist controversy and contentions that the board had imported Canadian students to spy upon members of the faculty.
