Her husband, a fine young man, cursed with inherited wealth, which makes real effort seem not worth while, is busy with his race horse Cragadour, favorite for the derby, to be run next week.

One man trains that horse, another bred the horse, another will ride it. But Lord Astor owns it, and that is his great interest.

His American wife is not interested in Cragadour, except mildly. She says she will keep track of Ramsay MacDonald, and "keep the socialists up to their promises."

That sounds a little like the editor of the Skibteen Eagle, writing, "We have our eye on the czar of Russia."

But it's better than having your mind on a race horse, now that you can buy for \$500 a runabout that would run the world's ten greatest race horses to death in one day.

Next week's derby is interesting, to the student of human stagnation. It interests tens of millions throughout the British empire. They know the odds on each horse and its breeding. They think hard on the problem "How shall I bet?" Like ourselves, they think little about "How shall I vote?"

And many of them will not think again until the next derby comes around.

If you have anything to sell, let people know you have it. To let them know, advertise.

This applies to widowed ladies with a hall bedroom for rent, and great estates and industries that need millions of additional income.

ASK HONEST TRIAL FOR DRY LAW

Message to American People Signed By Ford, Edison and Other Prominent Men, Seeks Support Hoover Enforcement Plans—Lawyers Organization Opposed By Choate.

NEW YORK, June 3.—(AP)—A "message to the American people," urging that "prohibition should be given an honest trial" and hearing the signatures of Henry Ford, Thomas A. Edison, Capt. Robert Dollar, J. C. Penney and 29 other men prominent in business and industry, was published today.

The message quoted the plea for law observance in President Hoover's inaugural address and invited Americans, "whatever their previous opinions and social practices, and particularly those in business and professional life, to join with us in following the president. Let us unite to give the eighteenth amendment an honest chance for complete enforcement."

A letter, expressing disapproval of the recently organized voluntary committee of lawyers opposed to the eighteenth amendment, and an answer to it by Joseph H. Choate, Jr., member of the board of managers of the committee, were also published.

Marshall Stinson, Los Angeles attorney, asked that the committee refrain from using the word "lawyers" to avoid "bringing the legal profession further into disrepute." He asked whether any members of the committee were retained by interests seeking repeal of the amendment.

Mr. Choate replied that honest belief is the sole mainspring of the movement, adding "We believe that prohibition is the most serious remediable evil from which this country now suffers."

The message to the American people and the lawyers' letters were published a day after the announcement that Justice Frankfurter of the New York children's court had been awarded the prize of \$25,000 offered by William R. Hearst for a substitute plan for prohibition.

Justice Hoyt's plan called for repeal of the Volstead act and enactment of a new law defining "intoxicating liquors" as "all alcoholic products of distillation," thereby excluding wines and beer. Traffic in wine and beer would be under state regulation under his plan.

GREETINGS SENT TO BEDSIDE OF SICK MONARCH

George Honored On 64th Birthday — Passes Good Night—Looks Forward to Next Year's Derby — Press Club Is Thanked.

WINDSOR, Eng., June 3.—(AP)—Numerous congratulations were received by King George today in honor of his 64th birthday.

The king, again in bed because of the formation of an abscess on the side of his recent operation, passed a good night and is looking forward to next year's derby, even though his illness will prevent his attendance at the great derby this week.

Replying to a message of greeting from the Press club, where an annual luncheon was held in honor of the founder of the famous derby stakes, the king's private secretary conveyed the king's thanks, adding: "His majesty was much touched by your reference to future victory in the greatest of all races which next year he hopes once more to witness and enjoy."

Members of the royal family offered their congratulations during the day.

MYSTERY SEEN IN DEATH OF MAGAZINE GIRL

DETROIT, June 3.—(AP)—Police and the coroner's office were at longheads today in theories accounting for the death in a hotel room Saturday of Miss Mary Baylis Lee, 27-year-old daughter of wealthy New York parents, and formerly a teacher in fashionable schools there.

Dr. James E. Burgess, coroner, believes a broken neck, battered face and chest, scratched hands and arms sufficient evidence that the young woman was slain after a struggle.

Inspector Fred W. Frahm, head of the police homicide squad, announced he was satisfied Miss Lee died of heart disease and that her neck was broken while the body was being taken to the county morgue.

The body of the girl was found last night floating in a nearby canal bed in a position simulating sleep, by a hotel maid who entered the room to clean. Miss Lee was working here with a crew of Columbus, Ohio, magazine collectors and did not appear for work Saturday morning. It is believed she met death during the preceding night.

SHRINE VISITORS DIE IN ACCIDENT

THINK HEIRESS SLAIN BY YOUTH SHE REJECTED

South Jersey Girl Found Dead in Bedroom—Suitor Turned Gun On Self—Engagement Broken After Childhood Romance.

MOORESTOWN, N. J., June 3.—(AP)—The deaths of Miss Ruth Mowday Wilson and Horace Roberts, Jr., members of two of south Jersey's wealthiest and most prominent families, were under investigation today. The police theory was that Roberts shot the girl and himself.

Miss Wilson, the daughter of John O. Wilson, Camden financier, attorney and real estate operator, was found dying in her father's home here yesterday. She had been shot twice in the head. A few feet away on the floor Roberts, a member of an old Quaker family of Moorestown, was found unconscious. One pistol bullet had entered his right temple and two had taken effect near the back of his head. Both died without regaining consciousness.

Clutched in Roberts' right hand was a pistol. Six bullets had been fired from it.

The pair were found by Miss Wilson's father in the young woman's bedroom. She was lying on the bed. Both were fully clad. There was no evidence of a struggle.

They had been sweethearts from childhood days. Each was 25 years old.

Police learned from friends that Miss Wilson had broken the engagement two months ago, but recently she and Roberts had renewed their friendship.

ALASKA GOVERNOR FLYING TO 'FRISCO IN ONE DAY TRIP

SEATTLE, June 3.—(AP)—Governor George A. Parks of Alaska arrived here at 10:30 a. m. today en route to San Francisco from Juneau, Alaska. He left Juneau at 1:30 p. m., Pacific standard time, and expected to reach San Francisco by 8:30 p. m.

The governor flew from Alaska to Seattle in a plane of the Washington-Alaska Airways company, and expected to leave shortly after his arrival for San Francisco. He plans to attend the graduation of his niece, Mary Thompson, at Mills college, Oakland. The flight is the first such attempted in one day from Alaska to California.

Up until press time, Governor Parks had not yet passed over Medford, although he was scheduled to arrive here around 2:30.

LONDON, June 3.—(AP) Premier Baldwin, head of the conservative government which has been in power for the past five years, will resign in consequence of his party's defeat in last week's general elections.

BE A SNOB IF SUCCESS IS DESIRED

Massachusetts Tech Graduates Told Easy to Marry Boss' Daughter if Gentlemen—'Front' of Harvard Has Brought Publicity and Money, Is Claim of Prof. Rogers.

BOSTON, June 3.—(AP)—The necessity of snobbishness, a doctrine enunciated by Prof. Robert Emmons of Massachusetts Institute of Technology in an address before the members of the graduating class, was under debate here today.

"Be a snob," Prof. Rogers told the seniors. "You will find it is just as easy to marry the boss' daughter as the stenographer. Dress snob and act like a gentleman and you will be surprised at the amount of money you can get away with."

"Never buy a suit of clothes unless you get an extra pair of trousers. Keep one suit of clothes pressed every week. Never buy shoes unless you buy shoe trees for them. Keep them shined, shave yourself and never wear the same collar at night which you will wear all day."

Harvard, he declared, has received more publicity and money than any other American university because Harvard has never stopped "putting up a front, never gives in, never argues, blantly going on its way."

Among those who rallied to Prof. Rogers' support was Miss Ada Louise Constock, president of Radcliffe college. "I believe Prof. Rogers was using the word snob in the better sense, or at least in an unusual sense," she said. "To me it appears that he wishes the young men of technology to cultivate the virtue of snobbishness, and if it means self-respect, high standards and dressing neatly, then I quite agree with him."

The Harvard Crimson, undergraduate daily, said: "It is little short of astonishing that a man belonging to a profession usually considered to represent the sternest of realism should have fallen for the vagaries of the 'right crowd,'" said the Crimson in an editorial today.

"Perhaps the boys at Technology have not had the time to frequent the dance halls of the back and so discover that the boss' daughter and his stenographer are sisters under a very thin skin."

MRS. CASSLER IS SUSPECT IN NEW MURDER MYSTERY

CHICAGO, June 3.—(AP)—Mrs. Catherine Cassler, who spent 27 months in jail for murder, part of the time close in the shadow of the scaffold, was back here today with new murder accusations flying about her graying head.

A mesh of circumstances which began forming before she returned from jail April 30, has involved her in the inquiry into the death of Camillea Soutar. The 24-year-old divorcee whose body, a bullet through the heart, was found deep in a swamp near Hebron, Ind., last Friday.

In the face of police charges, Mrs. Cassler has maintained a calm denial of any knowledge concerning Miss Soutar's death. She said she knew her husband, Truman, had employed the young woman as a housekeeper during part of the time she was in jail and that she had heard other things involving the two. "Camille," as Miss Soutar was called, was said to have called on Mrs. Cassler in jail several months ago, taunting her with a story that she and Mrs. Cassler's husband were to be married. Mrs. Cassler, however, said she "wasn't a bar for it. I don't get jealous."

BABE RUTH SUFFERS FROM HEAVY COLD

NEW YORK, June 3.—(AP)—Babe Ruth was taken to a hospital today for treatment of a heavy cold, which kept him out of the Yankees' lineup yesterday for the first time in two years. The treatment was described as a precautionary measure to prevent the cold developing into pneumonia. He probably will be out of the game about a week.

SENTENCES OF SINCLAIR AND AIDES UPHELD

William J. Burns' Fifteen-Day Sentence Only Exception—Power of Court for Protection Seen As Factor in Opinion.

WASHINGTON, June 3.—(AP)—The sentences imposed upon Harry F. Sinclair, Henry Mason Day and W. Sherman Burns for having the Fall-Sinclair Teapot Dome Jury shadowed, were upheld today by the supreme court, but the 15-day sentence on William J. Burns was disapproved.

Justice McReynolds delivered the opinion of the court, which was unanimous except that Justice Stone, who was attorney general during some of the oil lease litigation, took no part.

Pointing out that the defense contended that the evidence failed to show the detectives had established contact with any of the jurors, the opinion said, "We can not accept this view."

"It would destroy the power of courts adequately to protect themselves—to enforce their rights of self-preservation," it continued.

"Suppose, for example, some litigation should endeavor to shoot a juror while sitting in the box during progress of the case. He might escape punishment for attempt if some quick-witted attendant quickly thwarted the effort and kept the circumstances secret until the trial ended."

Leo A. Rover, United States attorney, who prosecuted Sinclair, said the oil men would start serving the six months' sentence for criminal contempt as soon as he completed the present three-month sentence for refusing to answer questions asked by the senate committee.

VEGETABLES AND SMALL FRUIT OF AREA RANK HIGH

In the shipment of carload lots of small fruits and vegetables last year, Medford ranked high in the shipment of 78 cars to Pacific coast and eastern markets, according to a resume of the 1928 season. The shipments took in a large variety of produce and indicated this section is especially active in this division.

DRUGGIST TORTURED IN CHICAGO

Gangsters Inflict Slashes and Burns On Wrong Man to Extort Still Information—Taken to Shack Near Gary, Ind.—Tossed From Car When Mistake Is Discovered.

CHICAGO, Ill., June 3.—(AP)—Kidnaped, tortured with glass and burning cigarettes, then dumped bruised and bleeding from an automobile, Matthew Zimmerman had a story to tell today.

He staggered into his home yesterday suffering from scores of bites and cuts, the latter having been inflicted by pieces of jagged glass slashed across his body by his captors in an effort to make him tell about a still he knew nothing of.

Zimmerman told police he was kidnaped Tuesday night when he answered the hail of several men who addressed him as "Matt." Lured to their car, he was seized, blindfolded and driven to a shack he believes to have been near Gary, Ind., where men immediately demanded that he tell them where the still was.

His captors called him "Matt Daly" or "Matt Dillon." Zimmerman said, and scoffed when he insisted that they had mistaken his identity and that he had no distillery and was not engaged in the liquor trade. To force him to talk, the men stripped him and cut his flesh with glass. When they burned him with cigarettes, Zimmerman said, he begged them to kill him.

Saturday night another member of the gang came to the hut. After looking at the captive, the newcomer cursed the others and declared: "You've got the wrong man."

"The men blindfolded me," Zimmerman said, "and put me back in their car. A little later they threw me out near Hammond, Ind., after telling me I was lucky to be alive."
