

WORRY CAUSE OF DOUBLE TRAGEDY PORTLAND HOME

PORTLAND, Ore., June 11.—(AP) Willis Freer, 44, formerly an employee of the Pennsylvania railroad at Chicago, Ill., shot and killed his aged mother, Mrs. Adelle Freer, some time between 9 o'clock Sunday night and Monday afternoon, then ended his own life. The tragedy was discovered late yesterday when police officers, summoned to the Freer home by alarmed neighbors, broke into the house and found Mrs. Freer, fully clothed, on the bed in her room, and the body of the son in an adjoining chamber. Both had been shot through the heart. According to neighbors, worry over the condition of his mother, followed by a temporary fit of insanity, prompted the deed. Mrs. Freer was 73 years old and recently suffered a nervous breakdown, neighbors said.

LIQUOR RUNNER KILLED BY WIFE

RIVERSIDE, Calif., June 11.—(AP) James M. Muelst, 38, described as a wealthy, blond, curly-haired, coroner, shot to death in his home, was declared by investigating officials to have been killed by his wife, Mrs. Gertrude Muelst, 33-year-old mother of three children, in a quarrel over Muelst's announced intention of joining narcotic smugglers operating between here and the Mexican border. Mrs. Muelst, who was reported by Sheriff Clem Sweetser to have confessed shooting her husband in a quarrel for possession of his gun, was in the county jail on a charge of suspicion of murder. Coroner's inquest will be held today.

HONGKONG ISLAND SHORT OF WATER

HONGKONG, June 11.—(AP) Hongkong island, after unprecedented droughts, is suffering from a water shortage which is the worst in the history of the British colony. Water, which is dependent on the rainfall, has been reduced to a scant month's supply. The island's population, totaling 1,000,000, have been placed on the strictest water dole and the streets are lined with queues awaiting their portions. The governor has announced the government would inaugurate measures intended to conserve water, and a disease which might be expected in view of the drought and hot weather.

FLYING CLUBS URGED FOR U. S.

WASHINGTON, June 11.—(AP) A movement to establish private flying clubs throughout the country has been launched by the National Aeronautic association. Senator Hiram Bingham of Connecticut, president of the organization, announcing the plan, said the movement was directed toward the "proper development of civil flying in the United States." It has been undertaken, he said, only after insurance difficulties have been overcome. It is now possible, he explained, for a flying club formed under the N. A. A. plan and char-
