

POINCARÉ ENDS FOUR DAY TALK ON WAR DEBTS

PARIS, July 17.—(AP)—The Poincaré government was victorious in its first clash with the opposition on the question of ratification of the debt records receiving 384 votes against 239 on a question of confidence.

The vote was taken on a motion introduced by former minister Louis Marin asking for postponement of debate on ratification of the Mellon-Berenger account.

Premier Poincaré opposed this and, making it a matter of confidence, demanded an immediate vote on the Marin motion.

Premier Poincaré was cheered long and heartily in the chamber of deputies today as he finished his four-day speech favoring ratification of the war debt records.

The premier recalled against the address of Herbert Hoover, at Toledo, then secretary of commerce, in which he explained the money was loaned by American taxpayers.

He praised the Young reparations plan highly and the careful work of the experts, their foresight, and their good intentions.

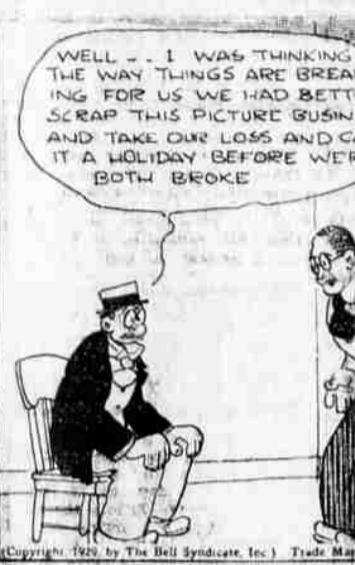

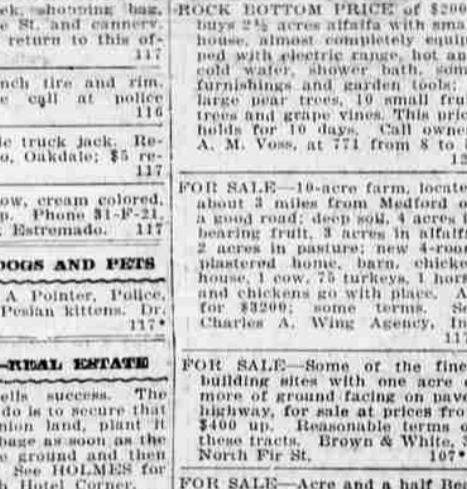

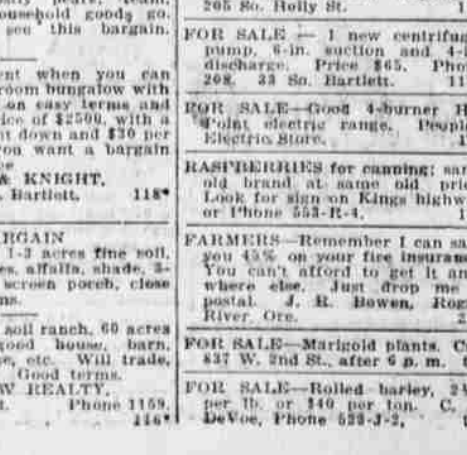
