Light frost for valley is first of fall season. Last night, which was the coldest of the summer season, to date brought in a light frost, the coldest temperature in Medford and vicinity being 24 degrees. This light frost did no damage as far as could be learned up to early afternoon, except to rip tomatoes, beans, etc., in the coldest parts of the valley. The chilly temperature made leaves and covering necessary during the night, and caused fire in stoves and grates to feel quite comfortable this morning. The probably high rain forecast for last night and today have evidently passed this section by, as they had not materialized up to late this afternoon, although the weather map and other indications were for light rain during that period. Today was comparatively clear and with much sunshine, and the forecast is for generally fair weather tonight and Sunday, but much change in temperature. It was good to see the sun again and also last night's stars and sky, which had been obscured for almost a week by the density of the forest fire smoke. Much of the forest fire smoke was rolling into the valley again today and while the atmosphere was much clearer a smoke haze somewhat spoiled the visibility again in the direction of the hills. Last night's cold weather and yesterday's breeze greatly restored visibility for lookouts in the forest and further checked the smoldering of forest fires and those which have been under control. It was so cold in the mountains last night that at the lookout stations in the higher altitudes ice was formed. Such cold nights and mornings with their dew have a tendency to check fires and prevent their spread, except in the afternoons. The Crater National forest is clear of fires except the smoldering ones that have been under control. However, the fire on the state land above Mays creek in the Crater forest, section is still burning in brush and second growth timber. It is not yet known how large it is, but inasmuch as it is near to buildings or valuable timber, it is regarded as a somewhat noisier one. ROSEBURG, Ore., Sept. 21.—(P) Prompt action of men and to-be-growers in the Crater valley last night resulted in saving the major portion of the fall garden crops from frost. Temperatures as low as 25 degrees were reported in various sections, but the growers, as a result of the frost, are still burning straw stacks, of hay and straw stacks, all throughout the night. Unprotected garden patches were destroyed. Damage will not exceed 20 percent, it is thought.
