

IMPORTANT U. S. CASES ON DOCKET

Federal Court Jury List Received By Taylor for Opening of Court Tuesday—Judge Bean to Preside—Indian Murder Trial Is Scheduled—Expect Over Week's Session.

A copy of the jury list and list of civil and criminal cases to be tried in United States court at the southern Oregon term of United States court, which convenes here next Tuesday, has just been received from Portland from the U. S. federal court office by Judge Glenn O. Taylor, who is a resident deputy clerk of the court.

The communication relates that Judge R. S. Bean will preside during the session and that the court will convene at 2 p. m. in the federal building. Deputy Clerk H. S. Kenyon will arrive here Tuesday morning to get everything in readiness for the court opening.

A size-up of the court docket, as it appears now, indicates a session of over two weeks, as besides the two important civil suits, there is to be a re-trial of a first degree murder case against a Klamath Indian, and the trials of two prominent Klamath Falls doctors, A. A. Soule and E. Dietsche, charged with the sale of narcotics.

EXPECT CUYLER TO SHINE AGAIN IN SERIES PLAY

Greatest Base Stealer Will Have Opportunity Square Account—In Same Form As 1925—Will Be Swinging, Is Threat.

By Paul R. Mickelson, Associated Press Sports Writer. CHICAGO, Sept. 28.—(AP) World series represents a changing world for the greatest base stealer of present day baseball, Hazen "Kiki" Cuyler. Alternately, they have brought him fame and broken his heart.

In 1925, this steel-muscled star batted and fielded his way to world series glory with the Pittsburgh Pirates. Two years later, because of differences with Manager Double Day, he was forced to wear the Pirate's uniform.

But the impending clashes between the Cubs and Athletics affected Cuyler an opportunity to more than square accounts. As one of the outstanding stars of the starting Cubs, he is expected to play a leading role against Connie Mack's men. And Cuyler is ready.

"What I didn't get a chance to do in 1927, I hope to do this time," Cuyler admitted. "All season I have felt right and I feel right now. I am going to play to win and this time when the fans yell for me, I'll be swinging."

In the 1927 episode, the refusal of Dorn to permit the speedy, accurate throwing outfielder to play, even as pinch hitter when a hit might have won for the Cubs, created almost as much talk as the one-sidedness of the series. All the cheers of the fans fell on deaf ears insofar as Dorn was concerned, and when the trading season opened again, Cuyler was traded for cash and players to the Cubs.

Dangerous Now. Baseball, in general, has been that way to Cuyler, now one of the most dangerous members of the so-called Cubs "murderers' row." It took him years—1924 to 1927—before he finally became a regular on the Pirate team. Then in 1928, an injury and some unkindly criticism from Cubs fans, who expected too much of him, threw him into a mental and battling slump.

This season, however, has found "Kiki" in the same form he was in 1925. He has hit more home runs than any player in either major league—49 in all, and his batting has ranged from .315 to .379. In addition, his throwing arm has been stronger. Only on rare occasions has a player gone from first to third on a single to his right field garden.

If the Cubs fail to get to Athletics' campers during the coming series, Cuyler will prove more invaluable to McCarty. The Bruin manager invariably plans a bunting, hit-and-run game when pitching is the least difficult to hammer.

EAST USHERS IN FOOTBALL SEASON

NEW YORK, Sept. 28.—(AP) The first general football engagement of the year involved 200 gridirons throughout the nation today, with about 50 contests to attract paying customers in the east. With a few scattered exceptions, such as Yale, Harvard, Princeton and Lafayette, every college squad on the Atlantic seaboard was expected either to open the season or continue a campaign begun last Saturday.

The mountaineers of West Virginia, with West Virginians Wesleyans' scalp already hanging at their belts, had another state rival in sturdy little Davis & Elkins today. D. & E. surprised with a 7-0 victory over the Mountaineers last season.

Goldenshire tune-up frags were the order of the day.

REVAMPED IDAHO TEAM IN FIRST SEASON TEST

MOSCOW, Ida., Sept. 28.—(AP) The University of Idaho football team, rebuilt this year by Leo Calland, former California, faced its first test here today against the Montana State college eleven in a non-conference game. Against a weaker team Calland said he would be reasonably sure of victory, but against the Bulldogs, who have often upset the Vandals in early season encounters, "I base my score at least a touch-down." The smallest team in several years will carry Idaho's colors today.

MASON OUT OF OREGON GAME AGAINST PACIFIC

EUGENE, Ore., Sept. 28.—(AP) The University of Oregon will open the football season here today against Pacific University of Forest Grove. Much interest has been shown in today's contest since it will be the only game played by the Webfoot squad before meeting the powerful Stanford eleven at Palo Alto next week. Captain Mason of the Oregon gridirons will be out of the games today and next week. He sprained his ankle in scrimmage Thursday.

SIMPKINS ON BENCH FOR STANFORD GAME

STANFORD UNIVERSITY, Cal., Sept. 28.—(AP) Stanford's gridirons were ready to make their second start of the 1929 season against the Olympic club eleven today with the first string line intact, but with one backfield man on the bench. Walt Helmcke, center, suffered a knee injury in scrimmage last Wednesday, and for a while it was feared he would not be able to play today. Last night, however, Coach Pop Warner announced that his first string center would be in the lineup. The backfield man out of play was the deceptive fullback, Bill Simpkins, who sustained a knee injury in the Army game last week.

Much Traded League Lead Now in Hands of Hollywood—Oaks Even Portland Series By 3 to 1 Victory—Ducks Rank Third

The lead has been traded back and forth between the clubs this week, and they have been tied twice. The series standing gave both two games each.

The Stars returned to a one-game lead over the league pack by routing the Missions with a five-run rally. The score was 8 to 4. Again the stands at Recreation park were packed, giving evidence of interest in the crucial series of the season.

Oakland's Oaks, visiting at Portland, won from the Ducks, 3 to 1 and made it two all for the week. The Bay City team scored its first run in the opening inning, bringing two more across in the seventh.

Howard Crossland claimed the lid on the Ducks after they had scored their fourth tally of Edwards. The Ducks today were in third place in the league standings.

Seattle defeated Sacramento in the northern city, 9 to 4. The Indians tommy-hawked Tony Freitas for 12 hits.

The Los Angeles Angels won their fourth straight game of the present series over the San Francisco Seals at Wrigley Field, Los Angeles. The score was 4 to 2.

VETERAN COUGARS TO PLAY COYOTES

PELLMAN, Wash., Sept. 28.—(AP) A team of ten veteran Cougars were led today to pounce upon the college of Idaho's Coyotes in Washington State college's first football game of the season. While only one member of the squad was new, Hollingbery, Cougar coach, sees a long face, predicting everything dire for his proteges. Last year the Cougars swarmed over the Coyotes at 34 to 6, but Coach Amos Cornell, the Idaho's mentor thinks things will be different today, and this was the only pre-game opinion. The Cougar lineup showed a weird plan of shifting in positions from last year but observers said that Hollingbery had found an exceptionally workable combination and little fear for the outcome was felt among Washington's faithful.

SCHISSLER TEAM LACKS VETERANS

CORVALLIS, Ore., Sept. 28.—(AP) Two revamped lines backed by veteran backfields will oppose each other here today when Oregon State plays its second non-conference game of the season with the California Aggies as its opponent. Coach Crisp Tomney upon his arrival here declared his team is suffering from a crippled line while Coach Paul Schissler of the States bemoaned the loss of experienced tackles guards and ends. The game should be fast and on a field much to the southerner's liking as to rain has softened the thin sodstuck covering.

CANZONERI TURNS BACK EDDIE MACK IN EIGHTH ROUND

CHICAGO, Sept. 28.—(AP) The thumping fists of Tony Canzoneri, former featherweight champion, have thrust back the bid of Eddie Mack of Denver for the right to challenge for the world's lightweight championship. Mack became a technical knockout victim of the New York Italian in the eighth round of the main bout in the Chicago stadium last night. Mack's chances of overcoming the former featherweight ruler were wrecked almost as soon as the fight started, when he sprained his ankle. He fought gamely and managed to give Canzoneri trouble with his left, but could not withstand the easterly's assault in the later rounds. The bout was stopped in the eighth after a right to the jaw had dropped Mack for a nine count. A crowd of more than 11,000 paid \$38,000 to see the card.

FANS SCAN HUSKY WHITMAN TILT TO LEARN STRENGTH

SEATTLE, Sept. 28.—(AP) A fast football game of the year today between the University of Washington and Whitman college. The weather forecast was fair and mild. Although having a veteran line and fast backfield, the Washington Huskies were expecting a good deal of trouble from the light but scrappy missionaries from Walla Walla, Wash. Much interest was manifested in the battle scheduled at 2 p. m. as Seattle fans were anxious to learn just how strong the Washington eleven is this year. Coach Enoch Bagshaw of Washington has a powerful line composed of 1928 regulars with the exception of Paul Schwieger, a 290 pound sophomore, at tackle. The Whitman team held the Huskies to a 7-0 score last year and were expected to put up another great battle. Coach Nig Borleske lost several regulars from his 1928 squad but had molded together a smoothly running combination.
