MacDonald's Sincerity. Convict and Canary. Cyclone On the Sun. We Need Twelve Fingers.

On Friday millions that had read about the shot heard round the world, on the radio heard Ramsay MacDonald's speech on peace, also heard around the world.

In 50 years no finer address has been heard in America. Earnest, simple, sincere, it carried conviction to the minds of millions here and in countries across the oceans.

Born in poverty, self-educated, beginning life as a Scotch workman, Mr. MacDonald has achieved a perfection of style and manner altogether admirable.

His achievement is recommended to those that lament the lack of "college education" and other opportunities.

MacDonald "was educated on the Bible and Robert Burns," enough education for any man willing to read history, study and think.

Mr. MacDonald emphasized, for his government, as Secretary Stimson has done, for America, that Britain and the United States have entered into no alliance as against other nations, open or secret. They have solemnly declared against war, as a means of settling questions arising among civilized nations, and invite the nations of the world to join in that declaration.

It is long since individuals in English-speaking countries abandoned the duel, between individuals, in settling points of honor, or other disagreements.

It is not too much to hope that national dueling will also be abandoned. The visit of Ramsay MacDonald means much for future peace. The two most powerful countries in the world have made a declaration more binding upon their honor than any diplomacy-made honor questions could possibly be.

Nevertheless, while MacDonald and Hoover talked in Washington, there were guards about the White House, police in the streets.

Civilized nations must have their guards and their police, on water, on land, in the air.

And, as civilian police and militia are sufficiently numerous and well armed to take

ATHLETICS ARE WORLD CHAMPIONS

WIN 3 TO 2 BY RALLY HITS IN 9TH

Victory Gained When Defeat Seemed Certain - Haas Hits First Heave for Circuit With One On, Tying Score - Simmons Scores On Miller's Blow for Winning Counter.

SHIBE PAIK, Philadelphia, Oct. 14.—(AP)—The Philadelphia Athletics, with a dramatic ninth inning rally, today won the world championship by beating the Chicago Cubs, 3 to 2, in the fifth and deciding game, played with the president and Mrs. Hoover as spectators.

The Athletics snatched another seemingly certain victory from defeat by scoring all three of their runs in the ninth inning after one was out and after they had been held to two hits for eight innings by Pat Malone.

With Mam Bishop on first, after singling George (Mule) Haas hit the first pitch over the right field wall for his second home-run in successive games, tying the score. At Simmons doubled and scored the winning run on Miller's two-base blow to the scoreboard in right center, after Jimmy Foxx had been purposely passed.

The Cubs drove the hero of the A's first victory, Howard Ehmke, out of the dug in the fourth inning when all their runs were scored, but the National league champions were stopped cold by George (Rube) Wagoner, south-paw, who was credited with the deciding victory.

Fourth for Mack. The Athletics, winning the series by four games to one, captured the world's championship for the fourth time in six attempts under the leadership of their 47-year-old pilot, Connie Mack, who thereby set a new world's record.

John McGraw and Miller Huggins each won three world's series. It was the third successive victory for the forces of American league, who now have achieved the remarkable run of 12 games won out of the last 13 in world's series competition.

MEDFORD STOP SUGGESTED TO SOVIET PILOTS

Chamber Commerce Wires Trans-Pacific Fliers Welcome to New Airport On Way to San Francisco From Seattle.

If a telegraphic invitation sent today by Seeley V. Hall, chairman of the aviation committee of the Medford Chamber of Commerce, is accepted, Medford will be favored by a visit of the plane "Spirit of the Soviet," while en route from Seattle to an Francisco on one of its first Pacific coast laps on its long journey from Russia to New York City.

The telegram, addressed to S. A. Shestakov, care of the "Spirit of the Soviet," Boeing Field, Seattle, is as follows: "Extend to you and your crew a cordial invitation to stop on Medford's new field on your flight from Seattle to San Francisco. We believe you will enjoy landing on one of the best and finest airports on the Pacific coast."

Date of the flight depends on arrangements in Seattle and it is not expected the stop will be long.

SEATTLE, Wash., Oct. 14.—(AP)—Conquest of the Atlantic may be a sequel to the epoch-making Moscow to America flight of the plane, "Land of the Soviets," S. A. Shestakov, commander and chief pilot of the expedition revealed today as preparations were being made to convert the ship from sea to a land plane.

Worn out by the thousand-mile flight from Waterfall, Alaska, to Seattle, during which their plane buffeted a 35-mile an hour head wind, the Russian fliers were emphatic in their desire to finish their round the world journey by air, instead of the more prosaic steamer and railroad route.

The hop from Waterfall took exactly 18 hours and 10 minutes. Navigator Boris V. Sterligov said. The plane glided into the air at Waterfall at 7:20 a. m., Pacific standard time and reached here at 5:30 p. m.

OREGON GRAVES LONDON CRANES DESECRATED BY WHEN AIR GIANT GHOULISH BAND GIVEN TEST RUN

PORTLAND, Ore., Oct. 14.—(AP)—A band of ghouls which already have robbed a grave of one body and several Indian graves of beaded relics and ancient weapons, leaving human bones strewn about burial grounds, were being sought throughout Oregon today, after Multnomah and Umatilla counties authorities revealed specific instances of destruction yesterday.

The body of Mrs. Frances Milled, former Oregon City, Ore., resident who died March 19, 1923, and buried in Douglas cemetery at Troutdale, Ore., Multnomah county, was removed from her grave during the past two days after the casket top had been shattered. The grave had been refilled partially.

Relatives of Mrs. Milled could give authorities no reason for the desecration. They said no jewelry had been left on the body. Records indicated the death certificate was in the usual form. The fact that ghoulish activities on Indian burial grounds in Umatilla county had been conducted about the same time Mrs. Milled's body was removed puzzled authorities.

Major Omar Babcock, superintendent of the Umatilla reservation, said he found at least four graves of Indian warriors opened, bones scattered about, and weapons and other articles buried with tribal Indians missing.

The grave of Talequut, a Walla-Walla brave, who died a score of years ago and that of Charley Whirlwind, an Indian medicine man, who died in 1907, had been opened and plundered, Major Babcock said.

Snake Fancier Dies by Fangs of Rattler Pet

MORGANTOWN, W. Va., Oct. 14.—(AP)—Bitten by a rattlesnake in his country home in the Cheat mountains, Colonel Charles William Cramer, nationally known herpetologist, died at a hospital here today, after racing his automobile 20 miles over rough mountain roads for assistance.

Cramer had a number of copperheads, rattlers and other snakes at his country place. A rattler escaped from its cage and as Cramer attempted to capture it, he was struck in the palm of the hand.

Cramer was removed to the hospital. He died 12 hours later. The herpetologist had been bitten several times before.

Find Finger. A human finger, either blown from the hand or crudely cut away, was found on the floor of a doctor's office near the store today. It is believed the physician's office was entered Saturday night or Sunday morning, presumably shortly after the safe was blasted.
