Four Russian flyers land on Long Island, ending a 12,500-mile flight from Moscow.

Colonel Lindbergh is there to greet and shake hands with them. He believes in good flyers, no matter whence they came.

He did not even ask whether their government intended to pay for bonds bought from the Czar and Kerensky by Wall Street.

Our government, which seems to dislike and fear the Russian government will notice that Russian flyers have been able to come from Moscow to Wall Street.

If four flyers can come now in one plane, on a friendly errand, why not 4,000 later, in better planes, on an errand less friendly?

Senator Blaine, of South Carolina says Alfred E. Smith, recently candidate for president, bought 500,000 feet of Russian lumber "for the construction of his new office building and hotel."

Governor Smith disposes of that, replying that he has bought no lumber or other building material. He is president of a company that gave a building contract to Starrett Brothers.

Americans had been told that Russia was rushing down hill to economic destruction, like the swine at the edge of the cliff. They will wonder how Russian industry can compete successfully with our lumber men.

British and American interests begin exploitation of potash and other valuable deposits in the Dead Sea, which annoys the Arabs. To see millions, in dollars and pounds taken from the thick salt water, for the benefit of British and American industrialists, is irritating. But the Mohammedans have had Palestine in their hands for thirteen hundred years, with plenty of opportunity to exploit the Dead Sea.

BINGHAM IS CENSURED BY SENATE

First Act of Censure in 27 Years Voted Against Connecticut Republican for Use of Lobbyist in Tariff Framing—No Corruption Charged—Vote 54 to 22.

WASHINGTON, Nov. 4.—(AP)—The senate today voted to condemn the conduct of Senator William Bingham, Republican, Connecticut, for taking Charles L. Eyanson, an officer of the Connecticut Manufacturers' association, into secret sessions of the senate finance committee at the time the tariff bill was being framed.

It was the first act of censure in 27 years.

The vote was taken after a protracted discussion during which Bingham defended his action. Bingham said his judgment in the way he used Eyanson, a tariff expert, might have been at fault, but on the "other hand" his motives in doing so were based on a whole-hearted zeal for a protective tariff.

Soft Language
Efforts by the senator's friends to soften the language of the resolution of condemnation which was offered by Senator Norris, Republican, independent of Nebraska, prevailed to some extent and an finally approved cleared Bingham of any intention of corrupt motives.

The resolution as adopted read "that the action of the senator from Connecticut, Mr. Bingham, in placing Mr. Charles L. Eyanson upon the official rolls of the senate and his use by Senator Bingham at the time and in the manner set forth in the report of the subcommittee of the committee on the judiciary, while not a result of corrupt motives on the part of the senator from Connecticut, is contrary to good morals and senatorial ethics and tends to bring the senate into dishonor, and disrepute, and such conduct is hereby condemned."

The vote was 54 to 22. The last time the senate had occasion to censure any of its members occurred in 1902, when "Pitchfork Ben" Tillman and John McLaughlin, the two South Carolinians, engaged in a personal encounter on the floor.

Tillman accused McLaughlin of changing his vote on a treaty and McLaughlin came back with the retort that Tillman was a liar. The exchanges quickly grew from verbal thrusts to physical combat.

WASHINGTON, Nov. 4.—(AP)—Senator Walsh, Democrat, Montana, said today the senate lobby investigating committee probably would inquire into reports that Dr. Edward R. Pickrell of the General Dye Stuffs corporation had used the office of Senator King, Democrat, Utah, as headquarters during the pending tariff legislation.

CATTLE THEFTS BY MOTOR CAR TO BE HALTED

The county court, it was learned today, has taken steps for the curbing of motor truck cattle thieves, who have been operating for six weeks in the Dead Indian district.

Special investigators have been named for duty throughout the county.

Fifty stockmen of the Dead Indian district recently filed a petition with the county court asking for protection.

It is estimated that between 30 and 35 beef cattle have been stolen this season in the Dead Indian district.

Two family milk cows, were also stolen.

During the last ten days, the thieving in the Dead Indian district has declined, and increased in the Big Butte district.

The rustlers have different methods of operation. Sometimes they butcher the cow in the woods, and leave the hide behind, taking the dressed meat to market. The other system is to load the stock into a truck, and haul it alive to the slaughter spots.

The county officials, at various times this fall have received reports of motorized cattle rustling, from the Applegate and Evans creek sections.

CITY BUDGET TO BE CONSIDERED TUESDAY NIGHT

Council Meeting Promises Interest When Committee Recommendations Discussed—Retention of Items Will Be Sought.

Tomorrow night's city council meeting promises to be unusually interesting, as several of the city council committees having in charge various departments, plan to have one or more items in the budget retained, which the citizens budget committee last week recommended be cut out before the budget ordinance is passed.

The citizens budget committee's duty ceased with its recommendation and its members have nothing more to do officially with the matter, and will not be represented at the council meetings on budget matters from now on, unless by Mayor Pipes, who favors the action of the budget committee in having recommended the slicing of some \$30,000 from the original tentative budget submitted to that committee by the council.

A minority of council members also incline to follow the budget recommendation, it is said.

The councilmen who are opposed to the recommended lopping of sums for departments in which they are interested, hope by friendly discussion and convincing argument as to the necessity for so doing, to induce the councilman body and the mayor to ignore at least some of the budget committee's recommendations.

The city water commission also is expected to attend tomorrow night's meeting and make efforts to induce the council to refrain from slicing \$27,000 from the city water department fund, as recommended by the budget committee.

PRIEST AFOUL OF CALIFORNIA LAWS WITH ROGUE FISH

GRANTS PASS, Ore., Nov. 4.—(AP)—A bit of nice angling in Oregon waters, it appears, is frowned upon by California statutes.

The Rev. W. E. McGough, Stockton, Calif., priest, came here to fish yesterday. He hooked the limit, and started back to Stockton.

He was arrested by California game wardens for having one fish weighing more than ten pounds. The California law holds that possession is evidence enough, so it did Father McGough little good to declare he caught his string in Oregon. He was held until he could arrange a cash bond.

Senator King III, Washington, Nov. 4.—(AP)—Senator King of Utah, who has been ill for the last three days with a stomach disorder, may enter Johns Hopkins hospital in Baltimore, it was said today at his office.

Slaying of Invalid Mother To End Suffering Condoned by French Jury

DRAGUIGNAN, France, Nov. 4.—(AP)—Richard Corbett was acquitted by a jury today of murdering his invalid mother last May.

So moving was Corbett's declaration in which he said he was willing to pay any penalty the jury thought just, that one of the jurors broke down and it was necessary for the judge to suspend the trial while medical attention was given.

Corbett, who is of French-English extraction, killed his mother, suffering with cancer, on May 9, and then shot himself, but later recovered.

"I admit I killed my mother," said Corbett calmly telling the judge and jury that he accepted full responsibility. "I knew what I was doing and I do not regret the act."

PRICES LAG AS PROFITS ARE TAKEN

Heavy Selling at Opening of Wall Street Carries Leading Shares \$5 to \$20 Lower—Trading in Normal Quantity—Market Hours Are Cut—No Session Saturday.

WASHINGTON, Nov. 4.—(AP)—Secretary Lamont reiterated today that business conditions are fundamentally sound and cited commerce department figures showing "absolutely" no increase in inventories; that forward orders are greater, that there had been no rise in commodity prices.

NEW YORK, Nov. 4.—(AP)—Governors of the New York stock exchange voted that the exchange shall be open for business between 10 a. m. and 1 p. m. on Wednesday, Thursday and Friday of this week, and shall be closed all day Saturday.

Trading on the New York stock exchange returned to normal proportions today but the market was called upon to absorb a heavy amount of selling, which carried prices of scores of leading issues down \$5 to nearly \$20 a share, with final quotations generally around the low levels of the day.

While nearly all of the recognized leaders and a majority of the 800 stocks traded in today showed substantial net declines, probably 200 or more issues closed with net gains ranging from fractions to 14 points.

NEW YORK, Nov. 4.—(AP)—The stock market, which rallied sharply in the closing sessions of last week ran into a secondary storm of selling today as Wall Street continued to clean out its impaired marginal accounts and large traders took profits on stocks bought in the breaks of last Monday and Tuesday.

An opening decline, which ran from one to nearly twelve points in most of the leaders, was followed by a brisk rally, but fresh offerings appeared and scores of issues were selling two to nearly twenty points lower in the early afternoon trading.

Trading started at a terrific pace as blocks of 10,000 to 50,000 shares were thrown into the market, but it slowed up later, and the ticker kept within a half hour of the market.

Call money renewed unchanged today at 6 per cent, time money and bankers' acceptances continued relatively easy. This was reflected in the generally stronger bond market.

U. S. Steel common, which has been one of the well weathered of the recent market, opened 84 points lower at 19 1/2, rallied to 19 1/2 and then dropped back to around the opening price, American Telephone conveyed an early gain of 1 1/2 to a loss of 1 1/2. General Electric extended its opening loss of three points to 14 1/2.

With the ticker keeping practically abreast of the market in the last hour, there was a marked revival of speculative confidence and prices generally rallied one to five points above the low levels established in the early afternoon trading. The closing was steady. Total sales approximated 6,200,000 shares.

NEW YORK, Nov. 4.—(AP)—After absorption of an early wave of profit taking at the opening, activity on the curb market slackened up considerably today and trading came near to normal proportions for the first time in more than a week.

The list was under considerable pressure, however. Losses of 2 to more than 10 points at the opening were substantially reduced during the morning, but renewed selling broke out in the early afternoon, notably in the utilities.

Deals Death to Couple Leaving Daughter's Bedside

KANSAS CITY, Nov. 4.—(AP) Mr. and Mrs. Harry V. Hurt left St. Mary's hospital here last night happy that their daughter, a victim of a street car accident, was improving. A minute later, just as they gained a safety zone to board a street car for home, a speeding motor car struck and fatally injured both.

Mrs. Hurt was dead when taken back into the hospital. Her husband, a painter, died several hours later. The only witness to the accident was unable to give police a description of the motor car, which sped away from the scene.

OREGON FACING DEFICIT UNTIL TAX MONEY IN

Million Borrowed From Highway Fund—Short Time Loans Also May Be Necessary From Portland Banks, Says Treasurer.

SALEM, Ore., Nov. 4.—(AP) The deficit of the state of Oregon on October 29, according to a statement from the state treasurer's office, was \$1,194,679.65 on October 29. It had been increased during the month from \$1,171,878.71 by the appropriation of motor vehicle license and transportation fees to the state highway fund and to the counties. There was on hand, however, about \$631,032 in unrecruited items, mainly inheritance tax money, for which receipts will not be written until the exact amounts due from several estates are known.

To relieve the deficit the state treasurer has borrowed \$1,000,000 from the highway fund. The state pays 2 percent interest to the highway department. The money will be paid back when the second half of state taxes is received from the counties prior to January 1. It is probable, the state treasurer said, that the state will find it necessary to borrow between \$250,000 and \$500,000 from Portland banks at 2 1/2 percent interest. These would be short loans of from 20 to 30 days.

The state's bonded indebtedness has been reduced since September 30, 1928, by the payment of \$2,662,500 in highway bonds and \$600,000 war veterans' state aid bonds. On January 1 next \$250,000 of war veterans' bonds will be paid and \$887,500 in highway bonds will be paid April 1.

The state's bonded debt as of October 1, 1929, was \$62,014,519.

JOSEPH FILES AN ANSWER TO MANNIX CHARGE

SALEM, Ore., Nov. 4.—(AP)—George W. Joseph, Portland attorney, against whom disbarment proceedings were instituted by Thomas Mannix, another Portland attorney, today filed his answer in the supreme court.

Joseph likewise filed disbarment proceedings against Mannix, and Mannix also was ordered by the court to file his answer today. Up to 1 o'clock p. m. he had not done so, but was expected to file the answer during the day.

The Joseph answer was filed by John Ventch, one of his law partners, and Joseph W. Joseph, Jr., his son.

Joseph's answer is a general denial of the charges made against him by Mannix. One of these charges was that Joseph and Henry Hansen, Portland newspapermen, had conspired to plant liquor in the home of Justice Rand of the supreme court and make it appear that it had been delivered by Mannix. Another charge pertained to Joseph's allegations as to business relations that Joseph claimed existed between Mannix, E. W. Wickey and Justice Rand while one of the E. Henry Wemme endowment fund was in the supreme court.

VIRGINIA IS FOCAL SPOT IN ELECTION

Democratic Machine Faces Severe Test in Ballot On State Officers Tomorrow—Heavy Vote Expected—Kentucky Result Also Holds Popular National Interest.

WASHINGTON, Nov. 4.—(AP)—Sporadic political campaigns over the country came to an end today with last minute appeals to the doubtful among the voters of a dozen states from Massachusetts to California and from Michigan to Virginia.

From the largest of cities down to the smallest precincts the leaders were perfecting more or less elaborate arrangements for getting out the voters tomorrow, but the campaign in some places, notably the Old Dominion, had been of such a character as to require little urging that the voter seek the nearest polling places.

With the Democratic political machine in Virginia facing the severest test it probably has yet met, an unusually heavy vote is expected in that state, which alone elects a governor.

First Real Fight
Until a combination of anti-Smith Democrats and Republicans threw the state into the Republican column just a year ago, political contests there were decided in the Democratic primary. Consequently this is the first real general election fight for state officers within several generations.

Under the leadership of Bishop James Cannon, Jr., of the Methodist Episcopal church, South, the anti-Smith Democrats have joined with the Republicans in supporting William Moseley Brown, for the governorship, against John Garland Pollard, candidate of the regular Democratic organization at the head of which stands Governor Harry Flood Byrd.

Interest in Kentucky
Outside of Virginia, Kentucky has the only other statewide election of popular interest. In the Bluegrass state the Republicans seek to make their control of the government complete by gaining a majority in the legislature.

The congressional election, to be held in the twenty-first New York district to fill a vacancy caused by death, brings forth a negro seeking a place in the national house of representatives. He is Hiram T. Delany, running on the Republican ticket in a normally Democratic district.

Contests in New York City, Boston and Detroit furnish the high lights in the mayoralty races.
