PAL OF MOONEY REPORT INSULL ASK LANDLORD ASKING PARDON INVESTIGATING BRING RECORDS IN BOMB CASE FOSHAY TO BUY OF BOOZE FEST

Detective, District Attorney and Jurors Offer Aid for Alleged Preparedness Day Bomber—Doubt Evidence Now.

SAN FRANCISCO, Nov. 8.—A petition by Warren K. Billings, asking permission to appeal to Governor C. C. Young for a pardon was on file in the state supreme court today. Billings was convicted of participation in the preparedness day parade bombing here in 1916 along with Thomas J. Mooney.

The petition was filed yesterday in conformity to a state law which provides that a person twice convicted of a felony must obtain the permission of the supreme court before he may seek executive clemency.

With the petition were offered letters signed by Duncan Matheson former captain of detectives here; District Attorney Matthew A. Brady, and three of the jurors who convicted Billings.

Brady's letter contended that there had not been sufficient evidence to convict Billings. The letter of the three jurors, William Thomas Baker, Edward T. Frank and John T. Adcock, asserted they had based their verdict on the testimony of Estelle Smith and John Macdonald and they now "doubt the veracity of the testimony."

Mooney's petition for a pardon has been under consideration by Governor Young for several months. The governor declared the move made by Billings would assist him in his consideration of the Mooney case.

NEW YORK, Nov. 8.—(AP)—The \$75,000 credit awarded by a jury to Marcia Estardis, night club hostess in her \$100,000 suit for mistreatment against Harry K. Thaw, was reduced today to \$25,000 by Supreme Court Justice Aaron J. Levy.

MINNEAPOLIS, Nov. 8.—(AP)—The Journal today said it had learned from reputable financial circles that the Insull Public Utilities interests of Chicago had started preliminary negotiations for purchase of the W. B. Foshay company properties.

Examination of affairs here of the Foshay company, which went into receivership last week, has been made by representatives of the Insull interests, the Journal said, adding that indications were reports of the preliminary investigations would be favorable.

The Journal understands the projected deal would involve all or a majority of the properties owned by the Public Utilities Consolidated Corporation, a subsidiary of the Foshay company.

It was considered unlikely, however, the Journal said, that any transaction involving sale of the properties would reach the final stage until completion of the inventory, work on which has been started by Joseph Chapman, receiver.

Valuation of the Foshay company properties, has been estimated to be in the neighborhood of \$29,000,000 or more.

The company operated utilities through the United States, Canada, Alaska and Central America.

WASHINGTON, Nov. 8.—(AP)—Three hundred clerical employees of the collectors of internal revenue throughout the country were ordered dropped from the payroll today by Commissioner Robert H. Lucas of the internal revenue department in calling for a ten per cent curtailment of the office forces.

Wall Street Party at Willard Hotel Will Be Subject of Grand Jury Probe Monday—Rail Head Also Will Appear.

WASHINGTON, Nov. 8.—(AP)—Frank S. Hight, manager of the Willard hotel, where the dinner reported to be Senator Brookhart as the "Wall Street booze party" took place in December, 1926, has been requested by District Attorney Rover to appear Monday before the grand jury.

Rover said he had requested Hight to bring with him all records relating to the dinner about which Senator Brookhart, who attended testified before the grand jury this week.

Hight is the second person connected with the dinner, given by Walter Fohy, New York broker for new members of the senate, who has been requested to testify before the grand jury. Edward E. Loomis, president of the Lehigh Valley railroad, was asked by Rover to appear Monday and has accepted the invitation.

Senator Brookhart said on the floor of the senate that he saw Loomis pour a new "alcoholic stuff" from a flask and drink it.

Otto Kahn, New York financier, was also present at the dinner but Rover has not indicated that he would be asked to testify.

BUDGET OF 1931 LESS THAN LAST

Millions Clipped From Federal Expense List—Amount for Farm Aid Not Determined—Waterways Improvement Given Increase—Army, Navy Program Funds Included.

WASHINGTON, Nov. 8.—(AP)—The budget for 1931 will amount to \$2,830,000,000 or about \$111,000,000 less than last year when the total with the appropriations and the deficiency reached \$2,941,000,000.

The figures do not include appropriations for the farm board.

The farm board appropriation for the 1930 fiscal year totaled \$150,000,000 and the amount which will be needed in the 1931 fiscal year has not been determined.

There will be an increase of \$10,000,000 for the improvement of waterways. Of this sum \$5,000,000 will go for actual waterway transportation improvement and \$5,000,000 for Mississippi river flood control work.

In addition the waterway fund will be increased by a sum of between \$4,000,000 and \$5,000,000 available for Ohio river improvement work, which will not be needed for that project because it has been completed.

Army, Navy Funds. President Hoover announced the budget outlook today, revealing also that it would carry the full amount contemplated by congress for the fifth year of the army navy aviation development program. There had been some loss during the last four years in the money appropriated for this purpose, but this year, the fifth of the program, the full amount will be made available.

President Hoover does not intend to recommend that the deficiency in the air program appropriation be made up in the next fiscal year, but he does approve intends to recommend making the deficiency available in a six-year, or in other words the year after the coming fiscal period.

GORE DEFENSE FILES MOTION AGAINST SUIT

A motion to strike, and make more definite and certain, was filed by the defense in circuit court today in the \$50,000 alienation suit of Mrs. Gertrude M. Gore against W. H. Gore and Sophia Ish Gore, parents of her husband, Jay I. Gore, who she is suing for separate maintenance.

The paper, filed this morning by A. E. Reames and George M. Roberts, attorneys for W. H. Gore, asks that the original complaint be made more specific and further asserts that it is irrelevant, immaterial and redundant.

The motion asks that the conduct and conversation be described in the separate maintenance plea filed by Mrs. Gertrude M. Gore, the defendant, Jay I. Gore, will be represented by Attorney Charles Reames. No answering papers have yet been filed in this action; \$150 per month separate maintenance for the care of three children is sought.

do Warning F. Ruse for Loss in School

VOTE SHORT TRADE DAY NEXT WEEK

Curtailed Sessions Will Be Rule—No Sales Saturday—Prices Sag in Today's Moderate Volume of Liquidation—Closing Is Easy With Oils Showing a Small Gain.

WASHINGTON, Nov. 8.—(AP)—Amendment of the Federal Reserve act to make it mandatory upon the Federal Reserve board to assert its authority and "to prevent by penalization such disasters in stock gambling operations as have recently disgraced the country," was advocated today by Senator Glass of Virginia.

NEW YORK, Nov. 8.—(AP)—The board of governors of the New York Stock Exchange today voted to close the exchange at 1 p. m. every day next week until Saturday, when it will again be closed all day.

This action continues the arrangement made after the violent session on Monday of this week. While no formal explanation was made, it is understood that commission houses are still struggling with an almost hopeless mass of unfinished business which was piled up in the past three weeks of frenzied trading.

Although trading returned to orderly and normal proportions today, several days still will be required for commission houses to get their tangled affairs straightened out and their employees, driven to the breaking point, are in need of relief.

Prices sagged throughout the list in the final minutes of trading, but liquidation was in moderate volume. U. S. Steel closed at 171, off 3; General Motors at 44, off 3; Radio at 35 1/2, off 2. National Cash Register was a strong spot, closing up 2 1/2 points, and several of the oils, including Barnsdall and Atlantic Refining, closed with small gains. The closing was easy.

Total sales approximated \$2,200,000 shares.

SPANK DAMAGE FROM THAW IS CUT TO \$25,000

NEW YORK, Nov. 8.—(AP)—The \$75,000 credit awarded by a jury to Marcia Estardis, night club hostess in her \$100,000 suit for mistreatment against Harry K. Thaw, was reduced today to \$25,000 by Supreme Court Justice Aaron J. Levy.

The verdict was returned two weeks ago after second trial of the suit in which the girl charged that Thaw had bitten her and paddled her with a hair brush at a New Year's party in his apartment in 1927.

The jury disagreed at the first trial but returned a verdict after 55 minutes of deliberation in the second hearing of the case. The lawsuit was another of the many episodes that have kept the former husband of Evelyn Nesbit in the limelight since he shot and killed Stanford White, noted American architect, in old Madison Square Garden in 1906.

Justice Levy had under consideration a motion by Thaw's attorney to set aside the verdict, and announced he would grant the motion unless the girl, whose real name is May G. O'Neill, would take \$25,000. The counsel said he felt confident she would take the smaller sum.
