Last Saturday Wall Street was sick. Yesterday morning it was sicker. Yesterday afternoon it suddenly brightened up and prices rose.

This time it is the turn of Harvard college, through its "economic society," to predict "that the period of uncertainty in commodity markets will not be prolonged."

The lambs will pray that this will not be the prelude to another drop.

Many brokers that know enough to gather in commissions without gambling could yesterday "Happy days are here again."

Total sales, 8,270,600 shares, the biggest day since the great wind of 16,000,000 and 10,000,000 and 12,000,000 shares day. At the last moment, bears, trapped, lost their money.

That's a small comfort for the little lambs that came home from Wall Street leaving their "bank rolls behind them."

Yesterday, on the little island of Elba, off the Italian coast, a small group celebrated the 100th anniversary of Napoleon's death at St. Helena, prisoner of the British.

Elba, Napoleon's first island prison, remembered his death with a solemn high mass, and a distribution of bread to the poor, the money supplied by Prince Demidoff in his will.

The word "enough" did not exist in Napoleon's vocabulary. He intended to use France as a base, as Alexander had used Macedonia. He meant to establish his real empire in Asia, and planned, quite seriously, his own future as a convert to Islam, riding around on an elephant.

WILL STUDY RESOURCES LOCAL AREA

Mining, Agriculture, Timber Subjects for Conferences at Grants Pass, Medford and Klamath - Harbor Assn. Backs Plan.

Further demonstration of the important part which the Northern California-Southern Oregon Development Association expects to play in the development of northern California and southern Oregon is contained in an announcement by President C. E. Gates that his association will sponsor three Mid-Pacific Empire economic conferences during the next few months.

The first meeting, the Mid-Pacific Empire Mineral Economic conference, is scheduled for Tuesday, July 15th, at Grants Pass, Ore. The development association has obtained the services of Albert Burch, of Medford, nationally known mining authority, who will be general chairman of the conference and under whose direction the entire program will be arranged.

"I believe that these conferences are the most progressive and forward movements that have been started in this section of the Pacific coast for many years, and upon their success depends, to a great extent, the program our association will carry on in the future to bring about greater agricultural and industrial development," stated Mr. Gates.

"We are really making an intensive and careful survey of the mineral resources of northern California and southern Oregon as they are, and we shall have at our command authentic data and information which we can pass on to the prospects we hope to create along industrial and agricultural lines."

"The conferences will, no doubt, bring out very forcibly the lack of transportation in our territory and will further prove the absolute necessity for the completion of the Crescent City harbor, thus providing us with a water outlet which will tremendously hasten an era of development here that we feel is right now at our 'front door.'"

"The harbor at Crescent City will be built without doubt and the recent activities of our association in its behalf will soon bear fruit. Of that I am certain. The additional (Continued on Page 6, Story 1)

GANDHI ARREST CAUSES RIOTING AMONG INDIANS

Widespread disorder, with two persons killed and up to 100 wounded, is the answer of Mahatma Gandhi's followers to the British government's arrest of "the holy one."

While the veteran nationalist leader sat behind the barred window of his cell in Yeroda prison, calmly and industriously spinning cotton in his miniature charkha, a mob of the nationalist movement—trouble occurred in many parts of the restless peninsula.

The most serious trouble broke out at Delhi today, where police fired on rioters and killed two of them, after a riot act, prohibiting the assembly of more than five persons, had been promulgated. At Calcutta 15 nationalities were injured in a clash with police when they attempted to interrupt railway service between Calcutta and Tatanahat. A mob estimated at 5000 took part in the disturbance, many of them lying on the tracks to hold up trains.

BIG CROCK AND CORK MEN WILL BE CLOSED UP

Government Opens Drive Against Sellers of Home Brew Paraphernalia - Small Dealers Next.

WASHINGTON, May 6.—(AP)—The government moved today to suppress all sale of paraphernalia for liquor manufacture.

The drive is being undertaken under the supreme court decision yesterday that distribution of such equipment was illegal under the Volstead law.

Prohibition Commissioner Doran announced the step, saying the action of the supreme court in upholding the seizure of bottles, corks and corks in Pittsburgh, on the ground that they had been displayed to attract purchasers who intended to use them in manufacture of illicit liquor, gave the bureau an effective weapon to proceed against every large concern producing such articles.

After the big dealers are "wiped out," Doran said the bureau would "go down the line."

"Our first job is to proceed against the big supply houses of home brew and for aging moonshine liquor," Doran said.

"We will proceed against every person and concern where the conditions are similar to the Pittsburgh case which was upheld by the supreme court yesterday."

LINDY INSPECTS AIR EXPOSITION

NEW YORK, May 6.—Col. Charles A. Lindbergh made an early morning visit today to the New York air show at Madison Square Garden.

Arriving soon after breakfast, the colonel saw what he wanted to see, talked to newspapermen and posed for photographers before the doors were thrown open to the public.

Tanned from his week in the tropics, opening the new over-Caribbean airmail service, he was smiling and affable as he walked around the plane.

BEARS RETREAT AS STOCKS GAIN UNDER SUPPORT

NEW YORK, May 6.—A fresh bull movement developed on the stock market late today, driving the bears to cover and causing speculative advances in high priced shares, about a dozen closing with gains of \$6 to \$29.

The market fluctuated uncertainly during much of the day, but had periods of pronounced strength at the opening and during the afternoon. Trading, however, was in sharply curtailed volume, total sales falling below 4,000,000 shares compared to more than 8,200,000 yesterday.

J. I. Case was a high flier, closing at \$227.75, up \$29. In yesterday's break it fell as low as \$274. American Tobacco B stock jumped \$17 to a record price at \$262. Allied Chemical mounted \$15, and Diamond Match \$16. Scores of shares closed with gains of \$2 or more. U. S. Steel, however, failed to participate notably, closing up only \$1.25.

LOCAL LIQUOR AGENT NABBED WITH TEN GALS.

Portland Raid Nets Two Under Cover Men - 'Working On Big Case' - Released Upon Request.

PORTLAND, Ore., May 6.—(AP)—A raid of two federal prohibition operatives late last night on liquor charges was followed this morning by their release by police on their own recognizance, and departure of one of them for Medford in company with the federal prohibition field agent for Oregon. Federal officers said the two men were working on a "big case."

When Patrolman O'Halloran and his squad raided a West Side place last night they found Prohibition Agent Moon and 19 gallons of liquor, parked just outside the establishment, police reports said. Jack Grant, said to be an undercover agent, had just entered the place, where police seized a quantity of liquor.

At police headquarters, where the pair was taken, Moon, who said his real name was Earl Bradley, produced credentials tending to show his connection with government field forces.

Police said Prohibition Field Agent Shirley asked that Moon and Grant be released. They were released on their own recognizance pending appearance in police court on possession charges.

Shirley explained that he wanted to take Moon out of town today, and police later were informed that the two had gone to Medford. Moon told police he and Grant were working on a "big case" which required delivery of liquor. They were delivering the liquor, he was quoted as saying, but were not taking money.

Moon is a former member of the Ashland police department and has a family in that city. He was appointed to the federal dry force several months ago on the recommendation of a group of Ashland citizens. While he has a regular appointment, he has been spending most of his time doing undercover work.

Efforts were made this afternoon to get in touch with Shirley or Moon but they apparently had not yet arrived here.

Moon is regarded in Ashland as a good officer and had been a resident there for some time.

CELEBRATE 20TH YEAR ON THRONE

Guns and Bells of British Empire Give Tongue in Honor of King George - Indian Troubles Disturb Peace of Country.

LONDON, May 6.—(AP) George V. "by the grace of God, king of Great Britain, Ireland and the British dominions beyond the seas, defender of the faith, and emperor of India," today celebrated the twentieth anniversary of his accession to the throne.

The day was observed, for the most part, quietly. Twenty-one guns in Hyde park boomed a salute, and naval stations throughout the empire took up the refrain. Bells of George's chapel, Windsor chapel, and Windsor parish hall were rung and flags were flown from public buildings.

In the morning his majesty received a number of servants from the London, Windsor, and Sandringham staffs and presented them with medals "for long and faithful service." King George arrived at Buckingham palace from Windsor only yesterday, but remained two weeks during which his time will be occupied with a variety of state and social functions incident to the London social season.

Appears Healthy The crowd which awaited him at Buckingham palace entrance saw the monarch tanned and apparently fully recovered from the serious illness of the winter of 1928-29. While at Windsor he was able to enjoy an outdoor life, resuming for the first time since his illness the horseback rides of which he is so fond.

King George succeeded his father, Edward VII, termed the "peace maker" while he was still prince. Four years afterward he saw his kingdom and dominions, and almost the entire world plunged into the great war. England since the war has experienced one of the most difficult periods of readjustment in its history.

Now, on the twentieth anniversary of his accession, the king, emperor and his subjects see on the eastern horizon what to many seems almost the looming of another war. The situation in India has grown steadily worse, and the signs are not yet happy.

The British policeman there has had once again to take up his baton to preserve order, and maintain the institution of the emperor—brilliant stroke of the Eastern-minded Disraeli—which fixes in the person of Britain's ruler the man to whom the princes of India kneel and the Sepoy pays allegiance.

SUSPEND PENALTY OF EXTORTIONIST

NEW YORK, May 6.—(AP)—Olga Elide Edwards, convicted of attempting to extort money from Nathan L. Amster, traction magnate, was given a suspended sentence of five years today in general sessions court.

Miss Edwards was found guilty of extorting money from Amster, who, she says, is the father of her six-year-old son Lee, on the threat she would expose him to his family and friends. He denied he was the father of the boy.

FORT BRAGG FAMILY DIE IN AUTO PLUNGE

FORT BRAGG, Cal., May 6.—(AP) Rimo Grivette, his wife and six-year-old son were killed with Mrs. May Jones when an automobile driven by E. C. Jones, who was seriously injured, plunged over a 70-foot cliff near here. All resided here. Mrs. Jones is survived by five children.

Health Program Urged Before National Red Cross Conclave

WASHINGTON, May 6.—(AP)—A thousand delegates to the annual meeting of the American Red Cross today heard two doctors urge upon their organization the undertaking of certain readjustments in American family life and the initiation of a comprehensive campaign to give the nation a "health conscience."

King Takes On Gee Goo to See Machine Work

NEW MARKET, Eng., May 6.—(AP)—King George played a wager on a horse today, for the novelty of working one of the new betting machines. When his majesty arrived at the races he became greatly interested in the machines, which were only recently installed. After listening to the explanation of how betting is done through the machine, the king purchased a ticket. The name of the horse he backed was not announced.

QUAKE AND WAVE TAKE 1,000 LIVES

Entire Town of Pegu, Burma Wiped Out By Tremor and Subsequent Incurion of Sea Water - Population Left Homeless.

RANGOON, Burma, May 6.—(AP)—The Exchange Telegraph agency said today that the entire town of Pegu had been wiped out by an earthquake and subsequent tidal wave, with the number of dead estimated at 1000.

The town presents a desolate picture, with public buildings and homes destroyed. Practically the entire population is homeless. Fires, which broke out in various parts of the town, still was smoldering this afternoon and it was feared the death toll might exceed even 1000.

A motion picture theatre collapsed while the show was in progress and buried the victims. At rail communication beyond the town was halted because of the collapse of a bridge two miles north of Pegu.

The offices of the Rangoon Times were badly damaged. One report, which has not been confirmed, said that Thongwa Island in the Hanthawaddy district had disappeared.

COURT TO DENY SQUATTER PLEA OF NOT GUILTY

PORTLAND, Ore., May 6.—(AP)—Emory Davis, Umpqua national forest squatter, charged by the government with contempt of court because he continued to reside on his alleged illegal claim after having been ordered off through court action, today pleaded not guilty to the contempt charge in federal court. He made his plea on grounds that he had maintained practically continuous residence since 1902, before congress passed an act reserving the forest land for homestead entry. Because of his prior residence he does not believe he should be deprived of his forest home and thereby is not in contempt by continuing to live there, his plea sets forth.

When Federal Judge McNary told Davis his plea would be overruled he asked for postponement of hearing until Friday. The request was granted.

Edwin Martin, another squatter, charged with trespassing in the Umpqua forest, pleaded not guilty. Pleas of not guilty had previously been entered by J. E. Graham and E. H. Best, two others arrested with Davis and Martin on contempt charges.

BISHOP GOT \$65,300 TO DEFEAT AL

Capitalist Relates Contributions for Anti-Smith Campaign in Virginia - Large Sum Given - Bishop Cannon Is Testimony.

WASHINGTON, May 6.—(AP)—E. C. Jameson, New York capitalist, testified today before the senate lobby committee he had contributed \$65,300 to the 1928 anti-Smith campaign in Virginia, \$65,300 of it going to Bishop James Cannon.

He added that his total anti-Smith contribution in 1928 was \$172,800.

A letter written by Jameson, which was read by Chairman Caraway, said \$17,000 had been used by Cannon and the remainder by the anti-Smith committee of Virginia, of which Cannon was chairman.

Jameson produced a number of checks to Cannon, several of which were made payable to "cash." Two checks, one for \$4300 and the other for \$3000, were dated after the campaign was over.

Jameson said Cannon was in debt for bills and that this amount was contributed to aid the bishop. "Where did you get the information the bishop was in debt?" Caraway asked.

"He told me so," Jameson replied, saying the debts were for stationary and printing. "Did he tell you what the printing bills were for?" "No, I didn't ask."

Gave Blind Checks. Caraway said both checks were payable to "cash." Jameson said he did not know the bishop until the campaign. He said he met Cannon through "Mr. Sleep."

Jameson identified Sleep as C. Bascom Sleep, former secretary to Calvin Coolidge and for many years Republican national committeeman from Virginia.

Caraway produced two checks totaling \$30,000 to the Virginia Republican state committee. Jameson then testified that \$92,000 in all had been contributed to Virginia's organization.

The chairman read a telegram from Cannon to Jameson which purported to discuss the report that should be made of campaign contributions. The telegram said: "After careful examination records state statements should be paid headquarters committee anti-Smith Democrats \$17,300. Paid Virginia committee anti-Smith Democrats \$48,000, making total \$65,300. This will correspond exactly with our official reports."

VOTE WEDNESDAY ON PARKER NOMINATION
