

NORTON NARREGAN DIES SUDDENLY IN MASONIC BUILDING

Norton L. Narregan, aged 40 years, one of Medford's most illustrious citizens and first master of Medford lodge No. 109, A. F. & A. M., died suddenly May 13th, in his office at the Masonic lodge. Death was due to heart failure. Mr. Narregan was born June 1, 1850 at Medina, Ohio. On October 1, 1875 he married Frances A. Bumm at St. James, Nebraska. They had two children, L. C. Narregan of Medford and Eugene G. Narregan of Seattle.
