MORROW IS NOMINATED IN JERSEY

Former Envoy to Mexico Sweeps Primary On Liquor Plank—Will Oppose Wet Democrat in Election.

NEWARK, N. J., June 18.—(AP)—With 223 districts making of 3,304 in New Jersey, the vote for Republican nomination for full term United States senator was: Fort 197,174; Frelinghuysen 43,093; Morrow 374,276.

NEWARK, N. J., June 18.—(AP)—Outdistancing his nearest opponent by 200,000 or more votes, Ambassador Dwight W. Morrow in the Republican nomination for United States senator, double victor in a primary election in which he stood for repeal of the 18th amendment and state control of liquor. In the principal contest, for the long term, Morrow was nominated in a four-cornered fight in which he won a majority of the total vote carrying all 21 counties.

Representative Franklin W. Fort, who ran as a dry with the backing of the State Anti-Saloon League, was second. Former Senator Joseph S. Frelinghuysen, advocate of modification of the liquor laws and federal control of the liquor traffic, ran third. John A. Kelly, who sought the nomination as the "original wet," was a poor fourth. Kelly was Morrow's only opponent for the short term.

Morrow will be opposed for election next fall by Alexander Simpson, wet Democrat, who was nominated for the six-year term without opposition, and for the unexpired term of former Senator Walter E. Edge by Miss Thelma Parkins, the only Democratic candidate for that term.

Foes Congratulate Morrow's nomination a few hours after the polls closed. They sent telegrams congratulating him on his victory and pledging their support in the fall election. The returns indicated that Morrow had carried many of the dry rural districts from which Fort was expected his chief strength.

JOSEPH'S DEATH HAS NO EFFECT IN SPEAKERSHIP

Mott Will Continue Drive for Next Legislative Session—Howard Withdraws for Gordon.

SALEM, Ore., June 18.—(AP)—James W. Mott of Salem has indicated that the death of George W. Joseph, Republican nominee for governor, will not cause him to withdraw as a candidate for speaker of the house at the next session of the legislature. Assuming that Joseph would be elected governor, Mott expected to have the support of Joseph's friends. He expressed the opinion that Frank J. Longenecker of Portland, who, at the end of the 1929 session, was said to have pledged of about half the members for the 1931 speakership, would be unable to get the speakership for two reasons, failure of a number of his pledges to be returned in 1931 and the belief on the part of Joseph's friends that Longenecker would organize the house against Joseph.

Emmett Howard of Eugene, known for several months to be a candidate for the speakership, has announced his withdrawal in favor of Herbert Gordon of Portland.

ACCIDENT MARS ROUND TRIP OF BROCK, SCHLEE

Plane Hits Fence As Coast-to-Coast Fliers End Round Trip—Delayed By Stop for Gas.

JACKSONVILLE, Fla., June 18.—(AP)—Delayed by a stop in Louisiana for fuel this morning, William S. Brock and Edward F. Schlee, completed their round trip coast-to-coast flight this afternoon landing at the Jacksonville municipal airport 16 hours and 50 minutes after leaving San Diego, Cal., last night. In landing their big monoplane near the five-foot-tall field, crashed into a fence and tipped the plane over on one wing. One wheel was smashed. On arriving here the men disclosed that they had come down at Tallulah, Louisiana at 9 a. m. today to take on 50 gallons of fuel, thus explaining the delay in their arrival.

SAY SANDINO ON WARPATH AGAIN

MEXICO CITY, June 18.—(AP)—General Augustino Sandino's representative here issued a statement today saying the insurgent leader had returned to Nicaragua and had defeated the United States marines in two encounters. The representative, Pedro Jose Zepeda, declared Sandino's men had captured a marine sergeant and an aviator and in addition had taken 10,000 rounds of ammunition and many guns.

FACTORY COSTS ON IMPLEMENTS TO BE PROBED

Senate Orders Investigation As Means of Fixing Flexible Tariff On Farm Tools and Shoes.

WASHINGTON, June 18.—(AP)—The senate today adopted a resolution by Senator Borah of Idaho directing the tariff commission to make its first production cost investigations under the flexible clause of the new tariff act. The resolution was adopted without debate. It especially directs the commission to find the difference in cost of production between foreign and domestic shoes, furniture, cement and farm implements, including hoes, shovels, spades, scoops, forks, rakes, scythes, sickles, grass hooks, corn knives and drainage tools.

ENVOY DELIVERS TALK ON POWER

BERLIN, Germany, June 18.—(AP)—Frederick M. Sackett, American ambassador, this afternoon delivered before the world power conference an unexpurgated version of his speech on power costs which had been reported eliminated at the behest of Samuel Insull, Chicago corporation magnate.

G. O. P. ASKS UNPLEGGED DELEGATES

Meeting to Name Joseph's Successor to Be Held in Latter Part of July—Metschan Urges Open Mind—Questions Raised.

PORTLAND, Ore., June 18.—(AP)—Phil Metschan, chairman of the retiring state Republican committee, said today that the state committee will not be called to pick a Republican gubernatorial candidate for the November elections until the middle or latter part of July. Upon this committee devolves the task of selecting a successor to Senator George W. Joseph, nominee, who died suddenly at Camp Clatsop Monday.

Meanwhile, Metschan said that new members elected to the state central committee were being urged to come to the convention with an open mind and unpledged to anyone.

Of the committee, 25 have been elected. Eleven counties have not organized, but all had meetings scheduled this week.

Questions Raised. In the interim technical questions are being raised regarding the power of the old or new committee to select the successor to Joseph. Metschan has asked the state attorney-general to rule on the question and the attorney-general said a decision would be forthcoming within the next few days.

A second technical question, Metschan said, which is being raised is whether county committees which did not organize within 20 days of the primaries could be legally organized after that time. A dozen or more counties would be affected by the ruling that the committees must be organized within the 20-day limit. It would then be necessary for Metschan to name a temporary chairman in the interim.

SALEM, Ore., June 18.—(AP)—The state supreme court has ordered abated proceedings which would have disbanded Senator George W. Joseph, Republican nominee for governor. The court ordered that announcement of his disbarment, which was made last month, shall not be published in the Oregon records.

HAWLEY WILL RETURN HOME EARLY IN JULY

SALEM, Ore., June 18.—(AP)—Representative W. C. Hawley has informed friends here that he will not return from Washington to his Salem home until early in July. He expects to remain in the capital city for about 10 days after adjournment of congress.

On Fryer Es As 10,000 Chickens Smother

TACOMA, June 18.—(AP)—Fire starting from a short circuit in a motor truck swept through the lower floors of a five-story building here late yesterday, doing \$50,000 damage. Ten thousand spring chickens belonging to the Tacoma and Poultry and Egg company were smothered to death but one escaping. The frier, with singed legs, flew through a window to the street, where it was picked up by boys.

CANNON IN CHALLENGE TO ACCUSER

Dares Tinkham to Make Charges Where Prosecution for Libel Is Possible—'Blustering, Cowardly Congressman,' Is Charge

WASHINGTON, June 18.—(AP)—Representative Tinkham of Massachusetts was challenged by Bishop Cannon to repeat his charges against the dry leader in a way which would make him subject to prosecution for libel. Speaking in the house, Tinkham late yesterday said the southern churchman "will stand convicted in the eyes of all honest men of having appropriated" to his own use money given to him to prosecute the Anti-Smith campaign of two years ago. This assertion was made after he had reviewed Cannon's refusal to tell the senate lobby committee of the disbursement of \$4,500 given him by E. C. Jameson of New York to promote the Hoover cause in the south.

PUBLIC MKT. WILL CLOSE JULY FIRST

Council Votes to End Operation As Economy Measure—Siskiyou Height Sewer Contractors Forfeit Deposit Account Error.

The Medford Public Market, operated on South Riverside, will close July 1, with expiration of the period for which appropriations for its continuance were included in the 1930 budget, arranged by the budget committee, according to action taken at last night's meeting of the city council. The market problem was introduced by E. M. Wilson, acting mayor during the absence of Mayor A. W. Pipes. After a brief discussion of the matter, during which it was brought out that the market has been operating at a loss, members of the council voted to close the building July 1.

No action was taken regarding disposal of the property, where the market is located. This will be considered at an early meeting of the body.

A meeting of the committee working on plans for the city manager form of government, which was not discussed at last night's session, was called for tonight in the office of Judge W. E. Crews. Contractors Forfeit The deposit of Yunker and Wieck Co., contractors of Corvallis, who were successful bidders on the Siskiyou Heights sewer project will be forfeited to the city of Medford and the contractors released from their bid, according to action taken by the council last night. C. R. Yunker, president of the company appeared before the group asking that the company be released from the bid in view of the fact that the bid submitted was, through an error, made \$6000 under the original estimate. Consideration of the project, he pointed out, would cost the company several thousand dollars. The cost of several hundred yards of rock was not included in the bid. The council voted to release the company from the bid and to hold the accompanying deposit. Other bids will be considered as soon as possible in order to avoid delay in the installation of the sewer system.

Austin Reports C. W. Austin, milk inspector, who returned Sunday evening from the conference for state inspectors held at Oregon State college, Corvallis, appeared before the council to inform the members that the new milk ordinance is working out satisfactorily. Considerable praise was voiced of Medford during the conference, he stated, because of this city's adoption of the standard milk ordinance. Medford and Portland were cited as the two most progressive cities in the state in the campaign to insure the safety of the public through a pure milk supply.

A petition for opening of Twelfth street, presented at the meeting, was referred to the streets and roads committee. Petition for installation of a street light at the corner of Fir and Thirteenth streets was referred to the building and light committee.
