PACT PLEA DELIVERED BY HOOVER

Message to Special Senate Session Says Misinformation Spread By Foes of Navy Reduction—Debate Opens Tomorrow.

WASHINGTON, July 7.—(AP)—Meeting especially to judge the London naval treaty, the senate heard it advocated today in a message from President Hoover and adjourned.

"This is especially necessary," he wrote, "because of misinformation and misrepresentation which has been widespread by those who in reality are opposed to all limitation and reduction in naval arms."

The president's views commanded senate attention after a vote had shown 58 members, nine more than a quorum, to be present.

"If we fall now," Mr. Hoover wrote, "the world will again be plunged backward from its present program toward peace."

Among those who heard were senators who have denounced the treaty as unfair to the United States. All of the known party opponents, except Senator Shipstead, a farmer-labor, Minnesota, were present. Should they decide to break a quorum at any time it would almost be in their power.

Opposition Named.

The opposition includes Senators Johnson, California; Hale, Maine; Moses, New Hampshire; Robinson, Indiana; and Oddie, Nevada, all Republicans, and McKellar, Democrat, Tennessee.

The galleries were filled. Sitting alone in the diplomatic gallery was Mrs. Henry L. Stimson, wife of the secretary of state. Stimson headed the American delegation to London.

Senator Reed, Republican, of Pennsylvania, a member of the delegation, was on floor, but his colleague on the delegation, Senator Robinson, of Arkansas, the Democratic leader, was unable to be present from the opening roll call.

As soon as the president's message was read, Chairman Borah of the foreign relations committee, called up the treaty and went through the formality of having it read. He then moved adjournment until tomorrow when Senator Swanson, Democrat, Virginia, will open the debate in behalf of the pact.

McKellar Leads Fight.

Before adjournment was taken, however, Senator McKellar, Democrat, Tennessee, an opponent of the pact, led the assault on the treaty by introducing a resolution to have the senate members relating to Hoover's documents regarding the preliminary negotiations surrounding the pact. The president declined to give these to the senate foreign relations committee.

Senator Reed replied the whole row over the documents related only to cablegrams exchanged between Ambassador Dawes and the state department prior to the London parley. He said those cablegrams had been given to members of the delegation in confidence. He volunteered to show them to any member of the senate if they were kept confidential.

"If the senators will accept this offer they will readily see why the papers ought not to be made public," added Reed.

Senator Johnson, Republican, of California, jumped to his feet to assail this offer.

DISMISS ACTION AGAINST GOLD SEAL ON DRINK

Coca Cola Co. and Local Creamery Settle Argument Over Alleged Infringement of Trade Mark

PORTLAND, Ore., July 7.—(AP)—The suit of the Coca Cola company against the Gold Seal Creamery company, started, charging infringement of the "Coca Cola" trademark, was dismissed by Federal Judge Bean today when a consent decree, settling the case out of court, was filed by the litigants.

The above action has been pending for the past three years, and was based upon the allegation by the Coca Cola company, that the Gold Seal Creamery, then the Jackson County Creamery, manufactured a soft drink called "Ryola," which it was asserted infringed "Coca Cola" in color and container.

The Coca Cola company made 13 separate allegations in their complaint against the local concern, in which they alleged discrimination and unfair competition, and infringement upon the Coca Cola rights in trade.

No money consideration was involved in the consent decree.

GAYLAND THREATENS REPORTER

Chicago Daily News Crime Writer Tells of Attempt to Wreck Car—Warned of Violence—Traveling With Armed Bodyguard.

CHICAGO, July 7.—(AP)—Leland H. Reese, crime reporter for the Chicago Daily News, today asserted in a signed story dispatched from DeKalb, Ill., to his paper, an automobile in which he was driving Friday night with a bodyguard was sideswiped and crowded from the road deliberately by another car which followed for ten miles. He said he had been warned of violence.

Reese and two companions, Ed Braun and Allen Finlay, were in Gilman Memorial hospital at DeKalb, with bruises and cuts, and Braun and Finlay suffered broken ribs as well.

In his dispatch he referred to an article published July 2 in the St. Louis Star, which said a reporter for the Chicago Daily News was soon "to get his."

"I was told by numerous persons that I was the reporter, and because of previous warnings given me I thought it probable that I was meant," Reese wrote.

Other Warnings.

He also had been warned, he said, after the killing of Julius Rosenberg, an underworld tipster said to have been used by Reese, and again after the killing of "Alfred" Lingo, Tribune reporter.

"This," he explained, "is why I have been accompanied night and day by Allen Finlay, who was engaged for that purpose by the Daily News. Finlay bore a commission as special policeman and was licensed to carry a revolver."

The author of the St. Louis Star article to which Reese referred, Harry Drummond, will be summoned to Chicago to be questioned by an inquiry board concerning his stories of racketeering. State's Attorney John A. Swanson announced today.

Nab Suspect.

Patsy Tardil, west side hoodlum, who tallies in some respects with the description of Lingo's slayer, was apprehended by police today and held incommunicado for examination.

Witnesses have said the killer of Lingo was a blond, and a silk glove he is said to have discarded in flight was for the left hand. Tardil is a left-handed blond.

Col. Robert R. McCormick, publisher of the Tribune, took cognizance yesterday of the rumors reflecting upon newspapermen generally when, in a letter to State's Attorney John A. Swanson, he suggested a thorough investigation.

Klamath Falls '49 Saloon Had Touch of Real Thing

PORTLAND, Ore., July 7.—(AP)—Too much realistic local color was the way federal authorities described today a raid on the "Last Chance Saloon," a '49 production at the Klamath Falls Fourth of July celebration, where J. Flynn, Art McKee and George Rice were arrested on liquor charges.

Complaints were filed against the three men at Klamath Falls. Three gallons of liquor and a truck belonging to Flynn were seized.

Field Chief Shirley of the state prohibition forces, said the celebration was the scene of the most flagrant violations ever witnessed by him personally. Shirley said he and his squad arrived at the Forty Niner village and that his men commented on the number of intoxicated men and women.

Shirley said the city jail, built to accommodate 12 prisoners, held 50 before the night was well along.

At the "Last Chance," Shirley said they found punch being served over the bar, but also noticed the back room was doing a thriving business. Customers who passed into the back room, Shirley said, were first passed on by the man at the door.

PAIR SEEK DEATH FOR HAPPINESS

Violinist and Champion Girl Swimmer in Suicide Pact—Refusal of Wife to Agree to Divorce Believed Cause of Deed.

PATERSON, N. J., July 7.—(AP)—Suffering from a bullet wound in the head, Roderick Meikle, 28, concert violinist and son of a Paterson, N. J., banker, was under arrest in a hospital here today, charged with the murder of Miss Jennie Brauer, 22, who won prizes as a swimmer before coming from Germany two years ago. Meikle's condition is extremely serious and he is unconscious most of the time.

Police accused Meikle of killing the girl, then shooting himself in a suicide pact into which the couple entered because another woman stood in the way of their marriage.

Miss Brauer's body was found Saturday in an automobile parked in a lane between Butler, N. J., and Pompton Lakes. Meikle was discovered yesterday wandering in a dazed condition through the woods nearby.

Two notes found in the car indicated that the couple had agreed to die together.

Secretly Married.

Police said they had learned that Meikle had been married secretly to Miss Jennie Murphy, 26, a school teacher in Paterson, at Bridgeport, Conn., Sept. 3, 1926, and that she had refused to agree to a divorce so he could marry Miss Brauer.

Bernard Stafford, counsel for Meikle's family, confirmed the report of Meikle's marriage. Miss Murphy was at her home today, and members of her family said she was prostrated.

One of the notes, written on stationery of the Hotel Niagara at Niagara Falls, said:

"I am glad to see the privilege of happiness in life so we go happily to death. We hope our friends can realize the existence of true love."

It was signed "Roderick and Jennie."

CREATOR OF HOLMES IS DEAD AT 71

Sir Arthur Conan Doyle, Author and Spiritualist, Succumbs After Two Months' Illness From Heart Disease—End Is Sudden.

LONDON, July 7.—(AP)—Sir Arthur Conan Doyle, creator of "Sherlock Holmes" and widely known spiritualist, died at his home here today of heart disease. With him were Lady Doyle, two sons and a daughter. Sir Arthur was 71 years old.

The great novelist and exponent of the occult was stricken seriously

ill about two months ago and his condition had become more aggravated recently.

Sir Arthur's sudden death took his family greatly by surprise. He had been under a physician's care during the last six or eight months. His weakened condition was thought to have been brought on by his series of lectures last October in Scandinavia, in behalf of the cause of spiritualism. Two days ago he contracted a severe cold. His end was peaceful, the family announcement stated.

Sir Arthur was born at Edinburgh, May 22, 1859, the son of Charles Doyle, grandson of John Doyle, best known as "H. P.", and a nephew of Punch's celebrated Richard Doyle. All three of these were widely known artists and caricaturists.

Arthur Conan Doyle, latterly Sir Arthur, played many roles in his life and most of them famously. He was a physician in the 80's, and a sensation-brilliant novelist in the 90's.

After the dawn of this century Sir Arthur exerted his literary efforts in placing before Europe the facts of the Boer war and for this he was made a knight of the realm.

In the World war, when his own son lost his life, Sir Arthur delved deeply into spiritualism, through that medium seeking to detect the world beyond with all the zeal he had put into his previous fictional writings.

FORECASTS FOR AVIATION COVER BIG TERRITORY

Bureau Provides Frequent Check On Conditions Over Nearly 13,000 Miles of Airways.

The weather bureau is organizing a notable expansion of its service in aid of aviation, which will provide frequent and regular weather reports covering approximately 13,000 miles of airways. Effective soon, these reports will provide sufficient detail to meet all existing needs, the U. S. Department of Agriculture announced.

On about 8,000 miles of these airways teletype lines will provide 24-hour communication with exchange of reports once each hour. The remaining 5,000 miles will be served by reports transmitted by telephone or telegraph and at such intervals as will best meet current needs. On nearly 3,000 miles of airways, over which there is as yet comparatively little flying (one or two daily flights each day), the bureau will provide a limited service.

Bulletins and short-period forecasts will be sent by teletype from seven centers to other airports and to landing fields and will also be broadcast to aircraft in flight.

Outside of continental United States, the bureau is increasing its airways service in Alaska, where a new first order station is being organized at Nome.

Service in the Hawaiian Islands will include a chain of inter-island stations from which reports will be transmitted by radio to Honolulu.

The weather bureau also announces that it is continuing its investigations with kites, captive-pilot and sounding balloons and airplanes (through cooperation with the navy departments), and is now engaged also in studies of ice formation on aircraft, turbulence or gustiness and other problems. The bureau's appropriation for all phases of its airways forecasting and study is \$1,400,000.

GOODYEAR ZEP WINS BALLOON RACE IN TEXAS

Pilot Blair Keeps Bag in Air for Drift of 850 Miles—Safe Landing Accomplished.

HOUSTON, Tex., July 7.—(AP)—The Goodyear Zeppelin entry from Akron, Ohio, piloted by R. J. Blair with E. A. Trotter as aide, was indicated today as the winner of the national elimination balloon race which started here late Friday.

Blair and Trotter landed at Greensburg, Ky., approximately 850 miles from Houston yesterday evening and outdistanced the fourteen other contestants. All landed safely.

The Detroit Times bag and the United Van Service entry of Cleveland ran a close race for second place and a chance to compete in the international event at Cleveland September 1, with the Detroit aeronauts apparently victorious by a few miles.

Pilot E. J. Hill and his aide, A. C. Schlosser, landed the Detroit Times near Russellville, Ky., at 2:55 p. m. Sunday. The United Van Service balloon was brought down at Kirksportville, Ky., Sunday afternoon.

GUNS SHEATHED BY ALABAMANS IN RACIAL WAR

EMELLE, Ala., July 7.—(AP)—Rifles and pistols were sheathed today in this strife-torn village completed the burial of its dead—two white men and four negroes—slain in disorders arising from an independence day debt dispute.

Four other negroes, each with a prize of \$300 on his head, were still at large, but virtually all of several hundred white possiblen had given up a three-day manhunt.

Officials' records, which have been posted for the four negro fugitives, Governor Bibb Graves said at Montgomery, "are not merely for negroes who killed white men" but would be paid "for the arrest and conviction of anybody, white or black, responsible at Emelle."

An unidentified negro man and Viola Dial, a negro woman, were the last two killed. They were shot to death yesterday when the commands of white searchers were not obeyed.

First Lady Returns After Illness To Take Up White House Activities

WASHINGTON, July 7.—(AP)—Mrs. Hoover presided again today over the social and domestic affairs of the White House.

After more than a month's absence from the executive mansion and three months of virtual seclusion as a result of an injured back suffered in a fall, she returned late yesterday with the president from their Rapidan river lodge.

Her coming was unexpected. Although Captain Joel T. Boone, the White House physician, had said last week that she had sufficiently recovered, it had been assumed that she would remain in the coolness of the mountains most of this month.

Well and strong again, however, and able once more to take up the chain of activity which she enjoys, Mrs. Hoover decided to recover.

As she stepped from the car onto the front porch of the White House, she smiled warmly and stood momentarily chatting with Senator and Mrs. McNary, who also had driven back in the president's car.

MOONEY DECISION READY TOMORROW

LOS ANGELES, July 7.—(AP)—Governor C. C. Young, through his secretary, said today he has reached a decision on the application for a pardon for Thomas J. Mooney, convicted of a part in the preparedness day bombing in San Francisco in 1916.

The governor declined to be interviewed. His secretary explained the governor planned to spend the day in writing his statement, which might be released late today, but more probably tomorrow.

GOP CHAIRMAN DISCLAIMS IDEA OF RESIGNATION

WASHINGTON, July 7.—(AP)—Claudius Huston has no intention of resigning as party chairman at the conference of Republican leaders here Thursday.

He conferred with President Hoover an hour and a half last night.

Asked about their meeting Huston declined to comment. He said he was not going to give any credence to the many stories published recently about his intentions of resigning by either affirming or denying them.

There was a very definite indication, however, he was going ahead as national chairman at least for the time being. It was pointed out if he intended to resign, this action would not be in order at Thursday's meeting of national committee officers.

CARDINAL VANNUTELLI HAS UREMIC POISONING

VATICAN CITY, July 7.—(AP)—Cardinal Vannutelli, dean of the sacred college, today was reported in a serious condition with an attack of uremic poisoning.

Cardinal Vannutelli, who is 93 years old, was reported ill on June 6. At that time it was said his condition was not serious, but that he had been ordered to take a complete rest.

The cardinal was said to have overtaken his strength at Ascension day ceremonies on May 29.

UNOCCUPIED CASKET PUZZLES JOSEPHINE

GRANTS PASS, July 7.—(AP)—A peculiar mystery faced Josephine county authorities today.

Their one clue was an unoccupied casket found in a cabin in a remote retreat.

Authorities said the casket had not been purchased at a Josephine county mortuary and the cabin had not been occupied for many years.

FEDERAL FARM AIDERS URGING LESS ACREAGE

Hyde and Legge Carry Campaign for Readjustment of Wheat Growing Into Nebraska.

HASTINGS, Neb., July 7.—(AP)—The government's two chief agricultural spokesmen, Secretary Arthur M. Hyde of the department of agriculture and Chairman Alexander Legge of the federal farm board, today carried their campaign for wheat acreage reduction to producers of the hard winter variety of the grain.

Accompanied by a small group of department of agriculture economists and extension workers, the secretary and the farm board head set out on a swing through the heart of the hard wheat belt which will take them into five states for half a dozen meetings with growers.

Hyde is urging on growers his theory, which is, extensive adjustment in wheat acreage and substantial reduction in production cost must be made if wheat production is to be profitable to growers generally in the next six to ten years.

Would End Gas War.

SAN FRANCISCO, July 7.—(AP)—The Retail Service Station Dealers' association of San Francisco was formulating plans today to end the price war. Gasoline was selling at between 12 and 13 cents here today.
