# BARBERS SPLIT ON MERITS OF PROPOSED BILL

The Medford barber and journeyman barbers are divided in opinion as to the merit of the new state barber bill fostered by the organized groups of Oregon barbers. It is believed that the bill will be asked to pass, although in general the organized barbers favor it. The unorganized barbers of the city are unanimous in opposition. The provisions and amendments to be incorporated in the bill are set forth by the Oregonian as follows:

Amendments to the present barber law of Oregon, requiring that a clean laundered steam towel must be used on a man's face before shaving and providing for the licensing of all barber shops by the state with a \$1 shop tax fee, will be asked by the two organized barber groups in the state, according to Frank P. Penner, secretary-treasurer of the Oregon State Master Barbers' association, who described the proposed legislation here yesterday.

Both amendments, which will be presented in a bill at this session of the state legislature, were approved by the Oregon State Master Barbers' association at its annual convention in La Grande June 2 and 3, and by the Journeymen Barbers' association at its annual convention at Medford on October 6. The latter association went further in suggesting that each barber be required to pay a \$1 fee also.

The sanitary clause in the proposed legislation, which covers in detail clean linen, antiseptics and sterilization, is sponsored by the Associated Master Barbers of America, and the Journeymen Barbers International Union of America.

"Barber shops are not licensed

now so that there can be no check on them.

"The Oregon barber law of 1927, due to an error, had no penalty specified so that enforcement was impossible. This also will be remedied by the proposed legislation, according to Mr. Penner.

"The opposition to the bill comes from the unorganized barbers who do not wish to shoulder the additional expense of sanitation," he said.

"R. Z. Baxter of La Grande is the president of the Oregon State Master Barbers' association and Clarence Townsend of Salem is the president of the journeymen group."
