

'KID BANDIT LOOKS OLD TO NORTON

Six Young Men in Medford Escapades Face Judge—Car Thief Is Given Year in Prison—Others Have Chance to Escape Bars

Six young men appeared before Circuit Judge H. D. Norton this morning for sentence upon pleas of guilty. One was sentenced to state prison, one was paroled, one had his case continued, pending payment of expense incurred by Jackson county, in returning him here for trial, another had sentence deferred until tomorrow and two—the cigarette pistol bandit—had the final disposition of sentence delayed until Thursday morning.

Victor C. Marcelle, who claims to be 14, though the court said, "you look nearer 15 to me," and George Stone, 20, dressed in naval uniform, charged with a series of service station holdups 10 days ago; appeared and pleaded guilty. Marcelle told the court he was 14, although in his confession he admitted 18 years. The authorities telegraphed back to York, Neb., his birthplace for statistics on his age and his case was transferred to the juvenile court, with power to refer the case back, if it is shown the defendant is falsifying about his age.

Stones, who was on furlough from his ship at San Diego, was to learn his fate at the same time. His mother, a resident of Portland, Ore., was in court. Both youths are confident of parole. The "cigarette pistol," with which they intimidated local service station and hamburger stand attendants, was introduced.

Paul Payne, 19, on parole from the juvenile court at Los Angeles, was sentenced to a year in state prison. He pleaded guilty to stealing a Ford roadster belonging to Hubbard brothers, June 25. He was captured at Grants Pass. The youth said he had no parents, and was hitch-hiking north. He had "nothing to say."

The court in administering a year's sentence at Salem, said "I hate to send a young man to prison, but it will enable you to determine whether you want to spend most of your life in penitentiaries." The lad wept at the court's word.

Mother Makes Plea. Kenneth Babington, also 18, who on July 3 "borrowed" H. A. Johnson's Ford so he could "take his girl to the Ashland celebration," was paroled to the district attorney, with the condition that he work and contribute to the support of his mother. The latter told the court "Kenneth has always been a good boy, and contributed to the family support. He always worked when he had a chance, and gave his money to me." It was the first mis-step, authorities said.

Looked Suspicious. The court said that the fact the pair had left for Yakima, Wash., after the checks were cashed "looked suspicious," but ruled that if Thompson would reimburse the county in the sum of \$40 what it cost to bring him from Yakima, Wash., where he was arrested, a parole would be granted on condition that Thompson return to Oklahoma. Thompson was given until next Monday to raise the money.

John Davidson, charged with entering an unoccupied dwelling at 424 Cathlamet street, was given until tomorrow to plead and receive sentence.

The entire morning session was devoted to hearing the pleas.

KANSAS GAS RATE FIGHT TO COURTS

Governor Refuses Further Negotiations With Utility Magnate—Barring City Service Company Shares From Sale Brings Protest

TOPEKA, Kan., July 7.—(AP)—Governor Harry H. Woodring said today his negotiations with Henry L. Doherty, utilities magnate, for lower gas rates in Kansas were ended and that the controversy will be fought out in the courts.

The governor said he would not reply to a telegram from Doherty attacking Woodring for the action of the Kansas banking department in barring from sale in the state all Cities Service company curb stocks, except the company's first preferred issue.

The New York utilities magnate, in a telegram to the governor yesterday, placed on the Kansas City Star responsibility for the action of the Kansas banking department.

Share Ban Halved
The banking department temporarily has been restrained by the Shawnee county, Kansas district court from putting into effect its order barring sale of the Cities Service securities in the state. A hearing is set for July 13 in Topeka.

Doherty described as "nothing less than vicious" the action "in having your banking department issue without warning and without cause and immediately after and undoubtedly because we had failed to comply with your demand for a reduction in gas rates, the order prohibiting the sale of Cities Service securities."

Governor Arbitrary
Doherty said Governor Woodring had "in some ways been peremptory and arbitrary." He announced that he had wired Postmaster General Brown urging that the Star be barred from the mails and Robert P. Lamont, secretary of commerce, calling attention to what he called Governor Woodring's threat to throw certain Cities Service subsidiaries into receivership.

Governor Woodring recently asked the Cities Service company to reduce its gas rate from 40 cents for 1000 cubic feet of gas to 39 cents.

SING SING CON SECOND VICTIM KNIFE WIELDER

Guards Search All Cells for Hidden Weapons—Privileges for Inmates Cancelled by Warden

OSISING, N. Y., July 7.—(AP)—The second fatal stabbing of a prisoner within the walls of Sing Sing prison today resulted in the cancellation of all convicts' privileges, while a picked squad of guards made a cell to cell search for hidden weapons.

The latest victim of what Warden Lewis E. Lawes termed an inmates' feud was John de Luca, 24, of Brooklyn, serving a term for a holdup. He died last night in the prison hospital.

Lawes said De Luca had been stabbed Saturday night while attending the prison motion picture show. Shows have been suspended pending the outcome of the warden's inquiry.

John Mulvaney, another convict from Brooklyn, was accused by Warden Lawes of killing De Luca as a reprisal for the killing of Frank Doyle, another prisoner, last Tuesday. Mulvaney was placed in solitary confinement.

William Hook, a convict, was stabbed last month while in the prison yard. He was not injured seriously. His assailant was not disclosed.
