ed in this batch must be in the county agent's office by 3 p. m. Wednesday. All thermometers counting in after that time may wait until the next testing is done, probably a week later.

Mr. Rogers, who tested a large number of thermometers last week, wants to test all the straggling instruments still out — and there are many of them — at one time, and cautions orchardists that the deadline for bringing in thermometers for this test is 3 p. m. Wednesday.

Messrs. Rogers and Wilcox point out that although the orchard situation as regards frost is approaching a serious stage, a small percentage by this morning were ready to smudge, and that all orchardists should hasten their general preparations for smudging.

Only about half the orchards which smudge are already prepared, it was estimated this morning.

As annually the frost forecasting will be made early in the evening over the KMEM broadcasting station. The cold temperatures of last night an dthis morning and of Saturday night and Sunday morning fortunately halted temporarily the rapid development of the clusters on pear trees. Sunday's minimum was 35 above.

steel slab doors and the steel bars of the cell-room to free the prisoners, then used the torch to cut through still another steel door into the store room where the liquor recovered from the wreck of the Sea Island was stored.

Hurriedly the men loaded the liquor onto the trucks, which, each now carrying two men and preceded by the sedan with six men in it, started for Portland over the coast highway.

Late Saturday, however, officers at Tillamook had received a mysterious warning that something was likely to happen down the coast, and when this warning was later repeated, they left for Toledo. Before reaching here they met Sheriff McIlwain who told them the news. They wheeled about and hurried after two trucks they had passed on the way down.
