

THOUGHTLESS BOY ASSESSED \$2 FOR ACID CAST ON DOG

George Higgins, 15, Junior high school boy charged with throwing acid on a wire-haired terrier dog in a thoughtless moment, appeared before County Judge C. B. Lamkin in juvenile court Saturday morning and was fined \$2 and given six months in which to pay.

"I want it strictly understood," said Judge Lamkin in passing sentence, "that if this fine in any way interferes with the necessities of life in the home, it will not be collected."

Teachers of the boy testified that he "was an exceptionally good boy without a vicious tendency."

ASHLAND TYPISTS CAPTURE LAURELS; MEDFORD FOURTH

In the southern Oregon typewriting and shorthand contest conducted at Medford high school, the loving cup for the highest team average in typing went to Ashland high school, with Klamath Falls second, Grants Pass third, and Medford fourth.

With a team average of 98.29, Grants Pass won the loving cup for first place in the shorthand division, the first time since the annual contests have been held.

Mary Chambers, novice in the shorthand competition, representing Medford, had the highest rate in both divisions, winning a gold medal for the novice division and a fountain pen for the highest contest rate.

Ashland's team average in typing, which won first place, was 99.16. The other schools rated: Klamath Falls, 97.62; Grants Pass, 92.50; Medford, 90.69. Gold medals in the amateur division were won by Blanche Hayden of Klamath Falls, the silver by Lois Goetz of Ashland, and the bronze by Betty Dean of Ashland.

The team winning for Ashland included Lloyd Arant, Lois Goetz, amateurs; Thelma Good, Betty Dean, novices. Klamath Falls was represented by Frances Gybers, Blanche Hayden, amateurs; Lenora King, Mildred Fraser, novices. Bervadine Christian and Lois Myers were amateurs from Grants Pass, with Betty Springer and Ruth Ellis, novices.

Helen Edmiston and Lilyan Milhoan were Medford's amateur representatives, and Helen Wilson and Harold Barton, novices.

A number of secondary schools also participated, with several high rates being recorded in the group. Central Point, with Vivian Jones and Mary Jane Beebe, amateurs and Edna Shaver, Avis Ayers, novices, rated 49.35.

Phoenix had a rate of 44.08. From the school were Mary Hight and Winifred Irman, amateurs; Pauline McAbee and Helen Glover, novices. Talent had 27.78 as the team average. Nina Pepper and Thelma Stevens were the amateur contestants and Doris Work and Fay Estes, novices.

Gold Hill amateurs rated 24.55. The team included Opal Hayes and Zella Smith.

The girls representing Grants Pass' shorthand classes were Mary K. Nelson and Betty Springer, amateurs, Mary Treadgold and Lola Myers, novices. Klamath Falls, rating 97.75 as a team average also took some awards. Gertrude Quistad and Hazel Hillman, amateurs, won the gold and silver medals, respectively in their division.

Hasting third place, one of Ashland's novices Rachel Forsythe, took the silver medal in that division. Eunice Coats was the other novice, with Edith Arnold and Beulah Herry as amateurs.

Medford's team was composed of Mary Chambers and Cecil Sullivan, novices, and LaDonna Calder, Carvel Reames, amateurs. The local high school's average was 94.69. Zella Smith, an amateur from Gold Hill represented her school and had an average of 98.75.

The contest was in charge of Mrs. Laveria Moe Gotschell, who was chairman. Mrs. Elizabeth Jerome, Medford high school typing instructor, conducted the tests throughout the schedule.

JACKSON COUNTY VOTER REGISTRY SETS HIGH MARK

Jackson county registration for the May 20 primary and the general election total 16,305 names with every indication that the total will exceed the 17,000 mark ere the month. This is the highest registration in the history of the county. In previous years the high mark was approximately 13,500.

Republican registrations augmented the past week, up to Friday by 644, now total 10,848. Democratic registrations for the same period were 442, with a grand total of 4,943— the largest number of Democrats ever listed in these parts.

Total registration by party is as follows: Republicans 10,848; Democrats 4,943; Progressives 17; Prohibitionists 25; Socialists 61; Miscellaneous 411.

The Socialists gained a long vote and "miscellaneous" eight votes, in the registration.

The list includes many first voters who have recently reached their majority and a number of citizens who have not taken the trouble and time to vote for periods ranging from four to 33 years.

The major portions of the past week's registrations were from this city and Ashland.

It is expected that Monday and Tuesday, the final days, will see a rush of registrants. The county clerk's office will be kept open noons until then to accommodate voters.

ROAD HOG CHARGE BRINGS \$19 FINE

J. Merrill Smith, Portland sales supervisor, was fined \$19.50 in Judge Taylor's court Saturday, after pleading guilty to not giving sufficient clearance to an approaching car.

The offense occurred about 8:30 a.m. Saturday when Smith, in a truck, met a sedan on the turn the other side of Central Point and narrowly escaped striking it. State Policeman Sheridan, from a distance of a few hundred feet, witnessed the episode and placed Smith under arrest.

It was testified, too, in court, that State Policeman Baucum had warned Smith only the day before for similar driving on the overhead bridge at Tolo.

"It is just such driving that causes so many bad accidents all over the state," said Judge Taylor in imposing the fine and costs on Smith, who had made the assertion that he had been driving a car over the highways of Oregon the past six years and never yet had met with an accident.

STIMSON ARRIVES FOR GENEVA DUTY

GENEVA, April 16.—(AP)—Secretary of State Stimson arrived here today and plunged into the work of acquainting himself with the problems and personages of the disarmament conference. At luncheon with Sir John Simon, British foreign secretary, he discussed disarmament and the issues raised by the Sino-Japanese conflict.

Subsequently he visited Giuseppe Motta, president of Switzerland, received Tewfik Ruzhdi Bey, Turkish foreign minister, and then called on Sir Cedric Drummond, secretary-general of the league of nations, and on Arthur Henderson, president of the conference.

The governor's speech in St. Paul Monday will be his first since Smith unleashed a yelled attack on him for a "demagogic attitude."

With him as he speeds westward tonight the governor will have six drafts of the address he is to deliver. His close friends here say Smith is not mentioned by name in any of them.

WASHINGTON, April 16.—(AP)—The Glass banking reform bill tightening the national banking and federal reserve systems against speculation and intended to protect depositors was approved today by the senate banking committee.

The far reaching legislation was modified to meet the almost unanimous approval of the committee and to satisfy to a great degree suggestions of federal reserve and banking officials.
