

TRICKS ADOPTED TO GAIN PENSION INFLUENCE VETO

Hoover Cites Soap Eating to Produce Anemic Look—One Lost Leg in Street Car Accident, Not War

WASHINGTON, April 28. — (AP) — President Hoover yesterday vetoed a bill granting an increase in pensions to soldiers and sailors, and in some cases granting new pensions.

Mr. Hoover said the measure contained 387 items establishing "special pensions and increased allowances to persons who have not been able to comply with the general laws."

He added it also contained some meritorious cases but he vetoed the bill because of a number of undesirable ones.

Most of these, he added, had been previously rejected by the pension bureau.

Malingering Cited.

"As I do not wish to reflect upon any individual," the veto message said, "I cite some instances in the bill without mentioning names, the facts as to which have been furnished to me by the government agencies."

He cited proposed pensions to "a man who was discharged without honor because of chronic alcoholism"; a man guilty of desertion and dishonorably discharged; a man who inflicted injuries on himself in an attempt to secure a pension.
