A promoter of an alleged cancer cure . . . recently sued the American Medical Association for a half million dollars in damages for so-called libelous statements made in Hygeia, and in the Journal of the American Medical Association."

The case came to trial in federal district court in Davenport, Iowa. The trial lasted four weeks. The decision was in favor of the association.
