UNIFORM FEES AT OREGON COLLEGES LISTED BY BOARD

\$17 at Normal Schools and \$38 Per Term at Oregon Or O. S. C.—Outstate Students Pay \$50 Per Term

SALEM, Aug. 24.—(P)—A uniform rate of fees applicable to all undergraduate students, regardless of what course of study they are pursuing, has been established by the state board of higher education. The rates announced are \$17 at the Oregon normal schools, and \$38 per term at the University or State College, in a statement by the board today.

Of the initial charge of \$38, \$24 will go to the state, the remainder being required for the self-supporting student health services and for operating the associated student organizations on the various campuses. Get Health Service.

Thus at the college and university, \$3.50 per term is appropriated to the health service, and the student is to be provided with unlimited consultation, advice and treatment at the campus dispensary, and limited hospitalization, the announcement stated. Five dollars of each term fee at these institutions goes, as in the past, to the associated student organization, entitling the student to admission to all athletic or other events sponsored by the students on the campus, and a subscription to the campus daily newspaper. An additional student building fee of \$5 is contained to provide and maintain certain projects and care for other obligations initiated and voted by the students.

Out-of-state students will continue to pay \$50 per term additional, all of which goes to the state. At the normal schools, \$9 of the \$17 per term goes to the state, while the remainder pays for student health privileges and finances associated activities. Students at the Oregon medical school will be assessed a flat term fee of \$80 and in addition will pay certain deposits and laboratory fees. Graduate students at the college or university will pay a flat fee of \$25 per term, of which \$20 will go to the state.

Must Make Deposit. The matter of deposits for loss or breakage of institutional property has also been simplified and standardized under the plan to be started this fall. Hereafter each student at the university and college will deposit \$10 on registration to cover all such items heretofore levied by from one to a half dozen schools or other divisions of each institution. In the case of students living in the dormitories, the \$5 room deposit will apply on this same \$10 general deposit. The entire amount is returnable in case no breakage or similar damage occurs, the board announced.

CHAMBER CENTER FOR CIVIC EFFORT SPEAKER ASSERTS

Rotarians Hear W. G. Harding, Manager Roseburg C. of C. in Talk On Need United Effort by Citizens

Emphasizing the value and the need of coordinated activity on the part of citizens of our various communities in the solution of the many community problems constantly arising, W. G. Harding, manager of the Roseburg chamber of commerce and president of the Oregon Commercial Secretaries' association, spoke to the Rotary club at its meeting Tuesday, taking as his topic "Community Service."

The value of service clubs as necessary adjuncts to community life, and the part they should play in community affairs was outlined by Mr. Harding, who has had nearly 50 years experience in civic work. "It is the province of the service club to teach men to serve, and it is the province of the chamber of commerce to make use of that service. Both of these valuable organizations supplement each other when they thus play into one another's hands. Otherwise, they are divergent, and finally engender rivalries, bitterness, strife and jealousies," he said, in approaching the subject of united community effort.

That all community efforts worthy of the action of the business interests should center through the chamber of commerce, was the opinion of the speaker, recognizing the chamber as the community clearing house for constructive ideas. "I want to declare in unmistakable terms that every service club in your community and mine should and must subordinate itself to the chamber of commerce. Service clubs may and should develop ideas and offer valuable suggestions for the public good, but these should all be passed upon by the chamber of commerce directorate, and then referred to the proper committee for final action. Unless these divisions are observed, we will find divided and overlapping authority. We find the service club abrogating to itself prerogatives that do not properly belong to it, and a chamber of commerce that is weakened in consequence," he said.

Declaring that the state of Oregon should unite the efforts of the various communities in the solution of three major problems, Mr. Harding extended his remarks to cover more than just the community field. The three problems mentioned were the solution of the unemployment problem, the fair and economical adjustment of the automobile license tax question, and the organization of an efficient and functioning state chamber of commerce.

Mr. Harding decried the many attempts being made in some communities to implant radical doctrines among the younger generation, as one of the most destructive tendencies of modern times. "Some of these people are out-and-out Reds," he said. "Many of them of foreign extraction, who know little, and care less, about our Anglo-Saxon principles, but with foreign traditions of a thousand years and the traditions of a few years of serfdom and ignorance, yearn for a change to atheistic and iconoclastic Bolshevism. The obligation of us, right-thinking Americans is to stamp out these tendencies," he declared.

In closing his address, which was prepared for the Rotary club meeting today, Mr. Harding said, "This service we most surely owe to our own land. Let us acquit ourselves like men should, and meet the test. Let us never stop until every racketeer, every cowardly gunman, every 'pink' and every Red is on the scaffold or behind the bars, or safely at home in Soviet Russia. This is your community service and mine."

In addition to Mr. Harding's address, Harry Moore, head of the local unemployment relief work, asked for the support and active cooperation of the Rotarians in this city, and stated that only a portion of the unemployed had found work in the orchards and packing houses.

Visiting Rotarians at today's meeting were R. H. Bolyard of Lafayette, Louisiana, and E. R. Ristine of Mount Vernon, Iowa. Guests included Rev. Howell of Spokane, Wash., and E. R. Ristine and C. T. Baker of Medford.

SALEM HALTED IN PLAN FOR WATER

SALEM, Aug. 24.—(P)—The city of Salem late yesterday again was halted in its efforts to become owner of the city water system when Judge L. C. Lewelling sustained the demurrer of the Oregon-Washington Water Service corporation to the city's complaint in a test suit on the legality of a charter amendment providing funds for securing the water system. The amendment, carried by a vote of the people on December 15, 1931, provided a \$2,500,000 bond issue for buying and adding to the Oregon-Washington Water Service system. The decision does not invalidate the charter amendment, but does prolong the water company's business term. City Attorney W. H. Trindle said.
