Comment on the Day's News

By FRANK JENKINS HERE are three headlines from the market pages of yesterday: "Buying Sends All Grain Prices Up," "Cattle and Hog Markets Are Higher," "Butter and Egg Markets Are Firm."

These are significant developments in the news. WHY are they significant? Well, if you want an answer to that question, suppose you ask yourself THIS question: "When is business going to get better?"

You will find that this is about the only answer that will fit: "When people begin to get a little more money to spend."

HIGHER grain prices will put more money in the pockets of those who have grain to sell. Higher hog and cattle prices will put more money in the pockets of those who have hogs and cattle to sell. Firmer butter and egg markets will help to put more money in the pockets of those who produce butter and eggs.

With a little more money in their pockets, the producers of these commodities will be able to spend a little more.

"BUT," you may say, "I am not a farmer. I have no grain, no hogs or cattle, no butter and eggs to sell. I am a working man, and I am out of a job."

"How will higher prices for these things, which the farmer has to sell and which I must BUY, help me to get a job?"

THAT is a reasonable question. Here is the answer, which is a reasonable answer:

Higher prices for grain and cattle and hogs and eggs and butter will put a little more money in the pocket of the farmer than he has had in the past. When the farmer begins to GET a little more money, he will begin to SPEND a little more. In that, he is just like the rest of us. We are ALL that way.

When the farmer begins to spend a little more money, he will create an additional demand for the products of industry—such as lumber. As additional demand is created for the products of industry, it will be possible to put more men back to work.

Thus new jobs will be created. See how it works?

BUT that isn't all. As the farmer, by reason of somewhat higher prices for what he has to sell, begins to spend a little more money and so creates additional demand for the products of industry, more men are put back to work in the mills and factories, and these men who are put back to work begin to get a little more money in their pockets, whereas before they had none.

So they are able to buy MORE FOOD, and as they begin to buy more food the market for the farmer's products begins to expand, and as the market begins to expand the price, in response to the law of supply and demand, goes up still more.

NOW let's see what that means. As the farmer's price gets better, he has STILL MORE money to spend and by spending it he creates an ADDITIONAL demand for the products of industry, thus making it possible to put MORE MEN back to work. As more men are put back to work, they buy more of the products of the farm. And so on.

WHEN you throw a pebble into a still pond, waves begin to spread. THEY KEEP ON spreading, until in time they reach the farthest edges of the pond. And so it is when the pebble of improved prices is thrown into the business pond. The waves that are started keep on spreading until after a while they reach everybody.

BUSINESS has a habit of running in circles.

Back in 1929, when prices began to crash, people began to discover that they had LESS money in their pockets than they had before. So of course, they began to spend less. THEY HAD to. You can't keep on spending very long if you haven't GOT IT TO SPEND. As people spend less, there was less and less demand for the products of industry and of the farm. With less

PORTLAND GANGS USING BOMBS IN FIGHT FOR REIGN

Underworld Forces Seek to Control Organized Vice, Is Revelation After Latest Outrage — Thirteen Held

PORTLAND, Ore., Aug. 30.—(AP)—Factional strife between opposing forces of the underworld who seek to control organized vice in Portland is blamed by District Attorney Lotua L. Langley for the bombing yesterday of a Fourth street rooming house, an allegedly disorderly resort.

A nitro-glycerine bomb was exploded in the stairway of the place. The explosion was so great that windows in buildings across the street were blown out and the entire district shaken.

"We now have evidence," Langley declared today, "that the bombing is part of a definite campaign for establishment of gang control of Portland's underworld."

Thirteen persons are being held for questioning in connection with the affair, the fourth bombing in the city since March. None of those held was admitted to bail.

Included among those held in the county jail are Billy Ryan, prize fighter; Bob Weaver, Hyman Weinstein and Abe Weinstein, Jack Carson and Henry Stern.

Police were looking for Ray and Nick De Pinto, who were questioned when Frank Laverdie, reputed gambler, was shot five times a short time after Portland's last bombing, that of a gambling resort. Police said the De Pintos were seen in the vicinity of the rooming house blast shortly after the explosion.

"The bombing is believed to be part of the factional fight between the opposing forces seeking to assume control," the district attorney continued. "We have information which leads us to believe a local group has set out to establish a super government of the underworld and proposes to control underworld operations here without interference of established government, and to measure out its own punishment of violations of the gang code."

'MA' FERGUSON'S LEAD INCREASED

DALLAS, Texas, Aug. 30.—(AP)—Mrs. Miriam A. Ferguson's lead over Governor R. S. Sterling in the sensational Democratic gubernatorial race was increased to 1297 votes on the second compilation of votes cast in Saturday's election, made today by the Texas election bureau.

The tabulation, made at 11 a. m., from all of the 254 counties, 224 complete, gave the following standings: Ferguson, 474,530; Sterling, 473,233.

The latest tabulation gave Mrs. Ferguson, the only woman who ever served as governor of Texas, the greatest lead she had compiled against the incumbent since early in the counting of votes.

KEYSOR ON TRIAL FOR OUT-OF-STATE LICENSE

Trial for Kermit Keysor, arrested Saturday by state police officers for improper license plates, was being conducted this afternoon in the council chambers of the city hall, with Judge Glenn O. Taylor presiding.

Keysor was represented by his attorney, Don Newbury. The charges filed against Keysor showed that he was employed in Oregon, but maintained California plates on his car. Two witnesses were called by the defense.

THIRD SUSPECT IS ARRESTED IN ASHLAND CRIME

Virgil (Dodo) Burnett, 16, was arrested by the state police and the city police of Ashland yesterday afternoon as the third member of the burglars who allegedly entered the J. C. Penney store July 29 and made off with approximately \$500 worth of merchandise.

Burnett, the state police say, admitted entering the store, and when arrested wore some of the loot. The youth, the authorities say, has been in hiding for two days and came out yesterday afternoon.

Leslie (Buck) Wilson, who last January was released from the state prison at Salem on a prior burglary charge, and Bobby Mansfield, 22, an Ashland girl, were arrested yesterday. The woman will be charged with receiving stolen property, the state police say, and Wilson with burglary.

Wilson denies any part in the Penney robbery and claims to be a victim of circumstances. A second girl, 19 years of age, detained by the state police, was released after questioning. Her trouble was attributed to "bad associations."

HITLERITES SCORE WITH ELECTION OF REICHSTAG LEADER

Hermann Goering, War Hero of Famous Flying Squadron, Wins Chair — Nazis Held Silent During Scene

BERLIN, Aug. 30.—(AP)—Adolf Hitler's national socialists won their first important office in the national government today with the election of Hermann Wilhelm Goering as president of the new Reichstag.

Goering has been with Hitler since the "beer cellar putsch" of 1923. He served his country during the war and was cited for valor as commander of the famous Von Richthofen flying squadron.

It was a foregone conclusion he would be chosen speaker, for the nominee of the largest party always gets the job. His margin was 397 votes to 218.

Through the preliminaries of this opening meeting the Nazis, under stern admonition from Hitler, sat in silence even while Clara Zetkin, 75-year-old "grandmother of the revolution" demanded in her address as temporary speaker the impeachment of President von Hindenburg and the whole von Papen cabinet.

But when Goering's election was announced they burst into tumultuous applause and cheered their leader. Every one of them rose and stretched out his arm in the Nazi salute while Goering, in a short, crisp speech, promised to act impartially but asserted he would stand for nothing derogatory to the national honor.

MR. VEATCH JOINS JUDGE COLVIG IN PIONEER STORIES

Indian wars, congressional events, and the early settlement of southern Oregon, leaped into dramatic tales today when S. P. Veatch of Portland, conductor on the old Oregon-California railroad, when it was taken over by the Southern Pacific in '87, met Judge Wm. M. Colvig here this afternoon.

Mr. Veatch, who came south to address the Rotary club at luncheon at the Hotel Medford, motored over the Skikyou route this afternoon as guest of A. S. Rosenbaum, general agent for the Southern Pacific, accompanied by Judge Colvig.

Seated in the tonneau of the car, the two "grand old men of Oregon" relived the days when distance was less easily conquered and time, perhaps, of less importance.

"There was just one house over yonder when I came through here first in 1880," Mr. Veatch declared with a gesture in a southeasterly direction. "It was a large white one. I came through by stage en route to Lakeview to get a Chinaman, who had been selling or giving whiskey to the Indians. I was deputy United States marshal then. I got the Chinaman and took him to Portland to appear before M. P. Dady. Someone was evidently put him wise. He pleaded guilty and was fined \$10. He had to pay me more than that for going after him."

"I was conductor on the railroad for 40 years, starting in 1886, when it was owned by the German company. I was retired January 1, 1927. "And the name S. P. Dady, someone for Southern Pacific," he added with a twinkle. "Just plain Sam, that's the name."

"All train work was done by hand then, I remember. Yes, the Nash hotel was here about that time, I know. I lay there for two weeks when I got hurt."

While doing the switching on a cold, rainy night, Mr. Veatch caught his foot in a "frog." The car started backward. He wrestled his foot from the track just as the car approached, but was knocked down by it, he said today, and went to the Nash for hospitalization.

Answering Judge Colvig's questions, as he ran through the list of Veatches who played a prominent part in the history making of Oregon, Mr. Veatch revealed that his father, H. C. Veatch, fought in the Indian war in '55 and '56, being located chiefly at Glendale.

DOUBLE CROSS BY WILKINS CHARGED IN BATES AFFAIR

FARMER STRIKE MOVF RUMPLES BEFORE BIG PUSH

Produce Moves Into Des Moines Unhindered — Sheriff's Deputies, Armed With Clubs, Clear Path

DES MOINES, Aug. 30.—(AP)—Farm produce was brought unhindered into Des Moines today with the collapse of the last strong farmers holiday picket line.

Shortly before noon Sheriff Charles F. Keeling, a force of deputies, and truck drivers, all armed with clubs, moved on Highway 45, north of the city, and forced their way through members of the farmers holiday association, who seek to force higher agricultural prices by keeping produce from the markets.

The "big push" against the blockade, after starting at a point five miles from Ames, resulted in the free movement of produce into this capital city.

Sheriff Keeling and his deputies continued their surveillance of most highways into Des Moines, for pickets remained at camps north, east, and southeast of the city. Holiday workers awaited the outcome of a meeting with members of the Des Moines Cooperative Dairy Marketing association tomorrow.

SEN. DAVIS DENIES GUILT IN LOTTERY

NEW YORK, Aug. 30.—(AP)—United States Senator James J. Davis of Pennsylvania pleaded not guilty today to two indictments charging him with distribution and sale of lottery tickets and with conspiracy. Bail was set at \$100,000.

A plea of not guilty was also entered by Theodore G. Miller, co-defendant with Davis in the two indictments.

Miller is a publicity man and an executive of the Loyal Order of Moose, of which Davis is the national head. The indictments refer to alleged lotteries said by federal investigators to have been conducted by the fraternal organization in connection with its benevolent undertakings for disabled members and dependents of members.

TROPICAL STORM DOES NO DAMAGE

MIAMI, Fla., Aug. 30.—(P)—Advices reaching the Miami weather bureau today indicated the tropical storm passed out into the Gulf of Mexico south of Fort Myers about noon, after crossing the southern tip of Florida.

Seat on "Change" Worth \$185,000

NEW YORK, Aug. 30.—(AP)—Arrangements were made today for the sale of a Stock Exchange seat at \$185,000. This is an advance of \$15,000 over the last sale. This is the highest price at which a seat has sold in 1932 and compares with a previous record price for the current year of \$175,000 in February.

Sour Note Sounded in Rudy Vallee's Romance

NEW YORK, Aug. 30.—(AP)—A sour note sounded today in the matrimonial music of the Rudy Vallee's. "Yes, there is a rift. They just can't seem to get along together," said a statement by Hyman Bushel, attorney, who said he represented both the orchestra singer-leader and Mrs. Vallee.

The lawyer said Mrs. Vallee, the former Fay Webb, whose father is police chief at Santa Monica, Cal., would leave New York at the end of the week. Reports that her destination would be Reno were without confirmation. Bushel said the domestic difficulties had not reached the point of divorce. He added: "While neither has started divorce proceedings as yet, I cannot answer for Mrs. Vallee's plans. If I can't patch things up—and I am not sanguine of my ability to do it—divorce will follow. I cannot discuss what the grounds for divorce may be. "They just haven't been hitting it off well. He is away much of the time. He is on tour now. He will return Thursday, and I expect to make a further announcement the following day. "There is no other woman and no other man in the case." Mrs. Vallee is at the Vallee apartment with her father and mother.

HEAVY BALLOTING BY CALIFORNIANS MARKS PRIMARY

SAN FRANCISCO, Aug. 29.—(AP)—The political fortunes of William G. McAdoo, general of the democratic Roosevelt-Garner ticket on the western front, and of Senator Samuel Shortridge, republican and friend of the administration, were at stake along with many others in California's state primary election today.

Throughout the campaign, both McAdoo and Shortridge were in the sector where the firing was the hottest—the many-sided contest for the United States senatorial nominations.

Echoes of the rivalry in the democratic national convention sounded within the democratic ranks, with McAdoo and Justus B. Wardell, both candidates for the democratic senatorial nomination, heading the factions.

A last minute report, said by Wardell managers to have been brought from New York by David P. Supple, local Smith supporter in the California presidential primary, quoting Alfred E. Smith as having suggested that democrats who supported the "happy warrior" in the presidential preference balloting, support Wardell, was denied in New York by Smith.

ROOSEVELT HAS RIGHT TO OUST MAYOR WALKER

Supreme Court Rules Governor Has Authority for Removal if Desired—Conduct of Quiz Not Bound

ALBANY, N. Y., Aug. 30.—(AP)—The fight of Governor Franklin D. Roosevelt to remove Mayor James J. Walker from office has been established by a court decision.

Supreme Court Justice Ellis J. Staley ruled last night that the governor had the authority to remove the mayor, and that in conducting the hearing he was not bound by the courts to adhere to any rules of judicial procedure.

Justice Staley cited precedents by which he observed the governor might be said to be in error in three instances in his conduct of the proceedings, but he pointed out that the courts have no right to interfere.

"Courts have no power over his (the governor's) person," he wrote, "and they cannot commit him for a disobedience of judicial process. "For errors, if any, of law or of fact in the proceedings now before him he is responsible, not to the courts, but to the people and his own conscience."

In reply to Mayor Walker's contention that he is not being given a fair hearing because, instead of calling before him all the witnesses who testified against the mayor before the Hofstadter legislative committee, Governor Roosevelt has admitted the committee's records as evidence, Justice Staley, after quoting previous interpretations of the law, observed: "Testimony Not Required. "The requirement for a fair trial and the provisions of section 84 of the public officers' law do not countenance, in my judgment, wholesale receipt and use of testimony taken by an investigating committee. . . . The relator in this proceeding (Mayor Walker) as a matter of common justice, is entitled to receive that full measure of protection which has been accorded to others."

RANCH DESTROYED IN MIDNIGHT FIRE

Fire at midnight last night destroyed all of the buildings on the Pennington place on Willow creek near Butte Falls. It was learned here this morning by the Rogue River national forestry office. Only a few clothes and two mattresses were saved from the fire, according to information.

The residence, said to have broken out in the barn, and spread to the other houses on the place. The cellar, wood house and residence were still burning early this morning, and the water pump belonging to the forestry service was dispatched to the scene.
