

STOCK EXCHANGE POLITICAL WIRES DUE FOR PROBING

NEW YORK, Sept. 16.—(AP)—The New York Stock Exchange today ordered its members to furnish the exchange's committee on business conduct with "all telegraphic communications dealing in any way with topics of a political nature, sent or received by them between September 12 and September 15, 1932, inclusive."

This period covers the date of the Maine elections and the three days following. During this period, there was a sharp break in prices of stocks. The order specified that all messages sent during the period be turned over today to the business conduct committee by members having offices in New York. Out-of-town members were given until next Monday to furnish their files.

The instruction was issued by Ashbel Green, secretary of the exchange, who stated that "a reply is desired from every recipient of this communication." The order did not state the reasons for which the information is desired. Members of the exchange said, however, that the break in the market had doubtless prompted a special investigation.

Frequently, the exchange calls on individual houses, particularly those with wide networks of wire systems, to furnish files of their telegraphic communications. This was done during the exchange's inquiry into short selling. The present case is one of a few, however, in which the exchange has issued a blanket order of that kind. The scope of the September 12-15 break, as measured by price averages, was roughly 16 1/2 per cent.

Harry Moore, now serving as business manager of the Medford Unemployment Relief association, filed today for office of city treasurer. Petitions were presented at the recorder's office, carrying more than 100 names. No other petitions were filed by candidates today.

Mr. Moore, who came to Medford in 1924 from Grants Pass, was accountant for the California Oregon Power company from 1924 to 1931. He left the power company to become salesman for the Empire Holding corporation, which has since ceased operation. He has had 20 years' experience in corporation accounting and stated today that he seeks the office on his qualifications, alone, as indicated in past experiences.

He is a member of Medford post, American Legion, having served a year and a half in the United States army air service during the World War. In the race for treasurer he will oppose J. O. Grey, who is completing a long term of commendable service on the city council, and Gus H. Samuels, incumbent.

SLOVER ASSAULT CASE CONSIDERED

Ralph C. Slover, son of Mrs. Sadie Pierce of Central Point, who was placed in the county jail Wednesday evening, following an alleged assault upon a four-year-old Central Point girl, is still held in custody, awaiting developments in the case.

He appeared before County Judge Lamkin yesterday for a preliminary hearing and the regular hearing will be held as soon as the little girl's condition is definitely determined. It is believed at the present time that she was not seriously injured.

State police and the county sheriff's office conducted an investigation on Wednesday evening and reported that Slover had admitted the assault and that charges of assault with attempt to rape would probably be brought against him. Other recommendations, however, are being considered by the county court, it is understood.

SERVICE TOURNEY OPENS TOMORROW

Golf tournament scheduled by the four service clubs of Medford—Rotary, Kiwanis, Lions and Active—will open tomorrow at the Rogue River Valley Golf club. It was announced today by August P. Johnson, chairman of the Rogue River club's tournament committee.

Qualifying rounds will be started tomorrow, and a week will be allowed for such play, Mr. Johnson said. This will be followed by the various match plays, according to flights, for the two weeks following. Teams will then be selected from each club to compete for the lovely trophy donated by the directors of the Medford chamber of commerce from their personal fund.

Mr. Johnson said that 12 Rotarians, 13 Activists, 12 Kiwanians and 10 Lions had already registered for play.

WOODY ARCHER SUED FOR COLLEGE LOAN

Suit has been filed here by the United States Bank of Portland, trustee for the Crawford student loan fund, against Woodward R. Archer, former University of Oregon student, for the collection of \$150, loaned and advanced Archer April 16, 1928, according to the complaint.

When the money was loaned, the complaint states, Archer gave, in return, a promissory note on the terms that it would become due immediately after his graduation from the university, or at any time he ceased to attend the school. He left the university some time ago.

Archer was a member of Kappa Sigma on the campus and a prominent football player in Medford high.

County Commissioners Victor Bursell and John Barneburg, accompanied by R. G. Fowler, county agent, left Medford this morning for Klamath Falls, where they will make a survey of general conditions, in view of relief work here and there. Conference will be held with the Klamath county court regarding the various activities underway there.

50 COUNTY HORSES DIE FROM MALADY

According to a report made yesterday by Dr. G. A. Giltzen, veterinarian, approximately fifty horses have died in the county during the past six weeks from encephalo-myloma, a form of paralysis which affects horses and mules. There is a total of 3170 horses and mules in Jackson county, according to the assessor's office.

The disease, which killed about eight horses in the valley last year, has been prevalent in California for the past three years. Dr. Giltzen said it affects the animals during the summer and early fall, generally from June until October.

Seldom more than one horse in a pasture and never over two at a place are afflicted with the ailment, for which no preventative has been found, the doctor said. Vaccination, he said, had proved futile.

Dr. Giltzen stated that among the horses he has been treating, about seventy per cent have been cured. Horses located in the eastern part of the valley were more seriously affected.

Four men in California are employed by the government to study the disease, in an attempt to find a cure, he stated.

VALLEY VETERANS BACK FROM MEET

A large delegation of Medford Legionnaires attended the national convention in Portland, many of them returning today. Medford received recognition in the 40 et 8 parade when Louis P. Older and John C. Deavers entered with a bugle and drum, and a sign, "Medford's Worst Drum Corps."

WINNIPEG SHIFT HITS WHEAT PRICE

CHICAGO, Sept. 16.—(AP)—Buying for houses with eastern connections gave firmness to wheat prices late today, but follow-up orders were less numerous than yesterday. A bullish construction was placed on reports the largest concentrated interest in wheat at Winnipeg had been transferred from the October delivery to May. It was contended this transfer removed an influence menacing to the world's market.

Wheat closed unsettled at the same as yesterday's finish to 1/4 higher, corn at 1/4 decline to 1/4 advance, oats 1/4-1/2 up, and provisions unchanged to a rise of 10 cents.

ROOSEVELT USED LOCAL TRICK IN FARM AID SPEECH

WASHINGTON, Sept. 16.—(AP)—Senator Arthur Vandenberg of Michigan, in a statement through the Republican national committee, said today Governor Roosevelt "grossly" misquoted President Hoover in the Democratic candidate's farm speech at Topeka, Kansas.

The committee said Vandenberg's statement had been telegraphed from his Michigan home. It said in part: "Governor Roosevelt's program for agriculture... defines an impossible theory which contradicts itself in its own terms and for which neither he nor anybody else can produce a practical formula."

"Meanwhile, he makes a bad matter worse by grossly misquoting the President through the ancient and familiar trick of removing words from the context."

"Governor Roosevelt erroneously continues," The President and his supporters insisted in 1928 that we were importing \$3,300,000,000 of farm products." The President made no such statement.

MERGER OPONENTS OF VALLEY MEET

Representatives of the southern Oregon organization to oppose passage of the Zorn-MacPherson bill met at the Hotel Medford last evening with a few Medford folk, in an effort to establish a Medford branch of the organization.

G. M. Green of Ashland, chairman of the meeting, told briefly the plans of the group, and what had already been accomplished by the Ashland members. John Fuller, appointed to contact civic groups in southern Oregon, is now working in the Coos and Curry county areas.

Mr. Green said that funds were being raised in Ashland to mail circulars to all folks in the rural areas, in order that they might have information concerning the bill, and its demerits.

Miss Regina Johnson, also a member of the committee, pointed out that a large percentage of the Ashland Normal school payroll was spent in Medford, and that the local citizens should be willing to aid in seeing that the schools of higher learning are maintained as at present.

DIEHL FINED ON YEAR OLD CHARGE

J. L. Diehl of Grants Pass, for whom a warrant for arrest was issued about a year ago and a half ago on a charge of allowing four people to ride in the front seat of an automobile, was fined \$15 in Judge Glenn O. Taylor's court yesterday afternoon.

Diehl, who attacked the arresting officer, Traffic Patrolman B. M. Baucum, was not apprehended until this week. A warrant was forwarded to Grants Pass and State Police Officer Thomas Sheridan arrested Diehl.

He was unable to pay his fine and was lodged in the county jail. Eleven dollars of the fine was suspended today, making it necessary for Diehl to serve only two days.

AUGUST EXPORT TRADE INCREASES

WASHINGTON, Sept. 16.—(AP)—An increase of \$2,150,000 in the value of merchandise exported from the United States in August as compared with July, and an increase of \$11,560,000 in imports was announced today by the commerce department. The month ended with a favorable trade balance of \$18,000,000.

The merchandise exported during last month was valued at \$109,000,000 as compared with \$106,842,000 in July while the imports were valued at \$97,500,000 as compared with \$86,000,000 the previous month.

The increase in exports was due to the greater exports of cotton during August when the value of such shipments amounted to \$18,112,608 as compared with \$15,853,880 the previous month.

The department gave no reason for the increased activities in the imports, but it was pointed out that increased activities in manufacturing probably caused an increase in importations of material.

The department statement showed that during August imports of gold had exceeded exports by \$6,103,000, with exports of \$18,967,000 and imports of \$24,170,000. Silver exports were \$443,000,000 and the imports were \$1,121,000,000.
