INDIANA THROG HEARS F. D. FLAY HOOVER POLICIES

Candidate Declares Coast Water Power And Orient Trade Suffers By Reason "Pernicious Policy" GOP.

INDIANAPOLIS, Ind., Oct. 20.—(AP)—A throng covering every inch space in this city's wide monument circle, Governor Franklin D. Roosevelt, shouted the assertion today that the nation is "remaining calm in the face of organized and ruthless propaganda of eleven-hour political desperation which dangles the old ghost of panic before our eyes."

After remarking about the "great outpouring" estimated at more than 50,000 and endorsing candidacies of the Democratic senatorial and gubernatorial nominees, Governor Roosevelt told his hearers:

"It is my belief that this campaign marks the beginning of a new era in American politics, and in the conduct of American government."

He spoke from a balcony of the Hotel English, following a tumultuous reception and a parade through the city streets.

When the governor referred to "organized and ruthless propaganda," a whoop went up from the crowd.

"The 'unwise policies of the administration,'" Mr. Roosevelt said, "have permitted also the uncouth riches of our mines to lie unused, while those who stand ready to work the mines . . . starve in the very presence of riches."

Departing from his advance text, he interjected:

"I say that with my own eyes yesterday going down the Ohio river from Pittsburgh."

"A selfish policy of pernicious private monopoly," Governor Roosevelt said, "has permitted water power that might bring happiness to millions of homes to remain unused."

"A great population facing the orient is unable to trade with that orient because of the unsound policy sponsored by men so narrow and localized in Washington that they were too selfish or too indifferent to realize the need of people so far away."

More than 100 children in search of aid, which may enable them to find happiness in the years to come, through mended bodies and minds, were examined by the Portland doctors, brought to Medford through the efforts of the Jackson County Public Health association, with the aid of the Kiwanis club, which is assisting in the payment of the transportation and X-ray costs, the two doctors donated their services to the clinic, free of charge, beginning Tuesday morning and continuing until 8 o'clock, with a half-hour recess at noon.

Sixty-five children were examined by Dr. Dillehunt and 35 by Dr. Dixon, psychiatrist. Each one calling at the clinic was given personal attention and recommendations regarding aid needed, if any, and how to obtain it.

Two were referred to go to the Shrine hospital at Portland for treatment.

Conferences were held with local physicians on several problems and interviews with Miss Louise Bassford regarding the instruction and progress of instruction in Medford schools for handicapped children.

100 HANDICAPPED CHILDREN AIDED AT HEALTH CLINIC

Largest in History County—Portland Child Specialists Render Service Sponsored By Health Association.

The largest clinic in the history of Jackson county, conducted for handicapped children, was held at the Alex Sparrow memorial clinic yesterday under the direction of Dr. Richard B. Dillehunt and Dr. Henry Dixon, Portland child specialists of national reputation.

More than 100 children in search of aid, which may enable them to find happiness in the years to come, through mended bodies and minds, were examined by the Portland doctors, brought to Medford through the efforts of the Jackson County Public Health association, with the aid of the Kiwanis club, which is assisting in the payment of the transportation and X-ray costs, the two doctors donated their services to the clinic, free of charge, beginning Tuesday morning and continuing until 8 o'clock, with a half-hour recess at noon.

Sixty-five children were examined by Dr. Dillehunt and 35 by Dr. Dixon, psychiatrist. Each one calling at the clinic was given personal attention and recommendations regarding aid needed, if any, and how to obtain it.

Two were referred to go to the Shrine hospital at Portland for treatment.

Conferences were held with local physicians on several problems and interviews with Miss Louise Bassford regarding the instruction and progress of instruction in Medford schools for handicapped children.

The work done in Medford's special room for handicapped children was highly commended by Dr. Dillehunt, who was also generous in his praise of the preparatory work done by the local health unit before his arrival to conduct the clinic.

Superior by the Jackson County Health association, he described as an aid to all other clinics of the state, with the exception of the special hospitals in Portland. The equipment and arrangement of the clinic, he pointed out, enabled Dr. Dixon to work with greater speed, accomplishing more than they had anticipated as possible.

Assisting the two specialists in the clinic yesterday were the following members of the Jackson County Public Health association, which has made possible this special promotion of child health: Mrs. Leonard Carpenter, Mrs. P. Corning Kenly, Mrs. Lewis Ulrich, Mrs. George Howard Hill, Mrs. Alex Sparrow, Mrs. Howard Hill, Mrs. David Rosenberg, Mrs. F. E. Wagner of Ashland, Mrs. Everett Faber and Mrs. Chas. Taylor of Central Point, Mrs. O. H. Wilcox of Phoenix, Miss Helen Bullis and Mrs. Robert Browne of this city.

Miss Harriet Sparrow, acting as transportation chairman, made trips to various sections of the county bringing in the children who would otherwise be denied the service offered at the clinic. She continued the work throughout the day, going as far as Rogue River and Wimer for the young patients.

Following the clinic a list of new donors to the Sparrow memorial clinic was announced by the health association secretary, Mrs. Ulrich. The list includes the Central Point W. R. C., Mrs. Porter J. Neff of this city, Christian Sunday school of Central Point, and Colonel Sargent camp, U. S. W. V.

REGISTERED VOTE OREGON 465,219 FOR ALL PARTIES

Democrats Gain 49,543 With Largest Increase In Multnomah — Lane, This County Lead New Voters.

SALEM, Ore., Oct. 20.—(AP)—Registration for all parties in Oregon, with five small counties yet to report, shows a gain of 49,543 voters over the totals for the same counties in 1928, figures on file at the secretary of state's office today reveals. Jackson Lane and Multnomah counties were the latest to report official totals.

The Democratic gain is better than two and half times that of the Republicans. They added 36,801 to their lists while the Republicans added 14,739. Registration from minor parties showed a slight decrease.

The Democratic total is 147,843, an increase of 31,094 over all counties four years ago. So far minor parties have reported 11,992, a small loss in this year's registration. Total figures give 465,219 voters in Oregon so far reported. In 1928 the 36 counties reported 436,190 voters, or 29,029 less than reports already in.

It is estimated the increase will be about 50,000 voters over the previous presidential election. The counties yet to report to the secretary of state are Crook, Grant, Harney, Lincoln and Wasco.

While Multnomah county reported the largest Democratic increase as well as the largest increase in Oregon, it reported a loss of nine Republicans. The Democratic increase there was 12,880. Counting a small loss in registration from other parties, the total increase was 12,616 voters. Multnomah's figures are: Total 160,947; Republicans, 107,810; Democrats 50,550; from other parties 3,187.

Both Lane and Jackson counties reported the largest proportionate increase in total registrations. Lane county leads the state in Republican gain with 2,891 over four years ago.

Lane county reports show a total registration of 32,072, a boost of 6,920 over the 1928 figure. Republicans listed 19,742 while minor parties numbered 1,333. The Democrats totaled 10,997 or an increase of 3,999 in the past four years.

Jackson county gives 19,139 voters, or 8,210 more than were listed previously. Of this total 12,114 were Republicans, an increase of 2,518; Democrats listed 6,801, an increase of 2,800.

It is expected by the secretary of state that the other counties will have reported by the end of the present week.

DILLARD GIVEN GRADING JOB ON DIAMOND LK. ROAD

PORTLAND, Ore., Oct. 20.—(AP)—The United States bureau of public roads opened bids this morning on three highway projects to cost about \$200,000. Two of the jobs are in Oregon and one in Washington.

A section of the Canyon City-Burns route, extending from Burns north about 11 miles, is to be graded. Of the five contractors competing, the Newport Construction company, Portland, tendered the lowest bid, \$30,558.

F. C. Dillard of Medford, with a bid of \$24,428, was low on the grading of about 5 1/2 miles of the Cascade Lakes highway north of Crater Lake park to Diamond lake. This highway extends from the northern boundary of the park, north, along the slope of the Cascade mountains, past many lakes of that region, to Bend. G. H. Pfeiffer of Eugene was second on this work with a bid of \$24,924, and Johnson Brothers company of Klamath Falls, third, at \$26,519.

Seek Innuity Cash
NEW YORK, Oct. 20.—(AP)—A complaint filed in United States district court today in an action to recover securities pledged with banks and others, charged that Innuity Utilities Investment, Inc., borrowed \$27,400,000 in yet unpaid sums from banks and \$500,000 from the General Electric company.

Another Probe
SALEM, Ore., Oct. 20.—(AP)—Further investigation of stock transactions of the Pacific Stock Corporation and the American National corporation of Portland is not warranted by facts, James W. Mott state corporation commissioner, said here today when he was cited to appear before the circuit court in answer to a mandamus proceeding calling for investigation of the corporations.

FRAME ON STAND IN BALM ACTION DENIES PROMISES

With many admissions of love and affection voiced, but "not in view of marriage" accepted by Robert W. Frame of Phoenix, defendant, the breach of promise suit of Marguerite Smith of Seattle, asking \$25,000 heart balm, continued in circuit court this morning.

Frame was called to the stand with the opening of court and was still on when the noon recess was called. He denied that any marriage arrangement had been entered into with Miss Kirksmith, but admitted that he had taken her about in Seattle for more than three years before marrying his present wife in southern Oregon, and that the "intimacies" claimed by the plaintiff were true.

The court room was filled, as yesterday, when he told his story. Testifiers of property to his wife, mentioned by Attorney Ralph Hammer for the plaintiff, Mr. Frame described as "a wedding gift." He also stated that he had given his wife his car, because hers was worn out. He denied that he had called the car "ours," when discussing it with Miss Kirksmith in Seattle; admitted writing the letters presented by the plaintiff, but stated that he had destroyed those written by Miss Kirksmith to him.

He said he knew she was in love with him, that he did want to receive her letters, but did not like her "well enough to marry her."

He was questioned by his attorney, Don Newbury, and by the plaintiff's attorneys this morning, and arguments in the case were expected to be finished this afternoon.

Calm and reserved, but a trifle hesitant, Miss Kirksmith took the stand yesterday afternoon. She gave her age as "nearly 29" while reviewing the incidents relative to her alleged engagement to Mr. Frame; described trips to the tailor and the changing of a wedding ring she never wore. She said that Mr. Frame frequently assured her "they were the same as married." Four letters were introduced as evidence by the plaintiff's attorney, and Gertrude O'Connor, sister of the plaintiff, another suitor, was called as witness to testify to statements allegedly made by Frame, indicating that he intended to marry Miss Kirksmith.

RASKOB DONATES \$25,000 TO DEMOS

NEW YORK, Oct. 20.—(AP)—Democratic National Chairman James A. Farley announced today that John J. Raskob, his predecessor, had given \$25,000 to the Roosevelt-Garner campaign.

Farley made his announcement at a luncheon of Democratic leaders attended by Raskob, who had not previously appeared in the political spotlight since he was succeeded by Farley.

FRANCE PROMISES TO PAY WAR DEBT IN DECEMBER

However, Will Seek Cut Or Cancellation of Balance— Payment For Munitions —Premier Answers Query

PARIS, Oct. 20.—(AP)—France plans to pay promptly the December installment of the \$400,000,000 French "commercial" war debt to the United States, Premier Herriot was quoted by Paris newspapers today as saying, but she will continue efforts to secure cancellation or reduction of the rest of the debt by negotiation.

The declaration ascribed to the premier was reported to have been made last night at a session of a committee of the chamber of deputies. The "commercial" debt is for army stocks bought during the war.

The question whether France intended to pay her war debts to the United States was asked by Deputy Henry Hays, it was reported.

L'Echo de Paris added the following to the premier's reply:

"But I make a distinction between the commercial debt and the political debt. Regarding the latter, whatever the result of the (American) presidential election, we will negotiate, trying, as far as we are able, to obtain more favorable treatment."

"If we could secure cancellation, it would be most desirable, but it's not dependent on me. It's up to the government."

Deputy Hays was said to have asked the premier whether, since Germany was paying France nothing, France shouldn't cease paying her creditors. M. Herriot was quoted as answering emphatically:

"Not being swindlers, we will pay scrupulously our commercial debts."

WASHINGTON, Oct. 20.—(AP)—Administration officials refused today to discuss Premier Herriot's statement, quoted by the Paris press, that he will continue efforts to secure cancellation or reduction of that part of France's war debt to this country which is not a "commercial" obligation.

President Hoover's statements in his speech accepting the nomination and in his Des Moines address were official as the administration position. These statements stood flatly against cancellation of war debts, but did not close the door to negotiations for readjustments.

ROGERS COMES OUT FOR GIGOLO TARIFF

BUENOS AIRES, Oct. 20.—(AP)—Will Rogers, who was the guest of the American colony at a dinner last night, said he was "America's" gift to those who didn't see the Prince of Wales.

"I'm here to lower the tariff" the humorist said. "Argentine exports wheat, meat and ginigole, and the United States puts a tariff on the wrong two."

He recalled how he came to Argentina in 1901, why money he earned selling cattle, and found himself unable to hold a job as an Argentine cowboy. He lived in Buenos Aires until his money was all gone, he said, then worked his way to Africa on a cattle boat and joined a wild west show.

Introducing Manuel Adrada, Argentine polo star, he predicted the Argentine team would win the international matches next month.

"What," he asked, "can a bunch of Yale boys do against this gorilla?" Rogers left by airplane today for Brazil on his way home.

RIOT BREAKS ANEW IN CANADA CELLS, TROOPS TO SCENE

Gunfire And Explosion Heard Behind Walls At Ports- mouth Prison — Soldiers Guard In Battle Regalia.

OTTAWA, Ont., Oct. 20.—(AP)—A detachment of royal Canadian horse artillery was rushed to the prison after persons outside the walls heard the report of what seemed to be a muffled explosion, followed by gunfire.

The troops carried full field equipment and wore steel helmets. They were transported to the penitentiary by trucks.

The soldiers were marched inside the walls, on which the guard contingent had been doubled.

Details of guards were posted on the roads about the penitentiary to prevent civilians from approaching. But 300 feet away from the walls it was possible to hear the shouts and howls of the rioting inmates.

The soldiers, numbering about 100, were sent directly to posts on top of the wall. They stood there, prepared for any eventuality.

HOLDOVER SOLONS FAVOR AUTO CUT, JOE DUNNE SAYS

SALEM, Ore., Oct. 20.—(AP)—A majority of the members of the next legislature who are holdovers or are sure of election have pledged themselves to support a 25 percent cut in the automobile tax in Oregon, State Senator Joe E. Dunne said today.

Dunne declared he had the personal pledges of 32 members of the lower house and 25 members of the state senate, more than enough to assure passage of such a measure to reduce present license fees.

Dunne further said he would go to court to enjoin construction of the Wolf Creek highway from Portland to the sea, the route recently agreed upon by the state highway commission, should any contract on this project be let. He did not divulge what his argument would be, but he believed he could halt construction of the highway over that particular route.

Organization of the next state senate is freely tentatively under way, with Fred E. Kiddle of La Grande as president, Dunne commented. He indicated several committee chairmen have already been selected.

HOOVER PROMISES AID FOR SILVER

BUTTE, Mont., Oct. 20.—(AP)—President Hoover today telegraphed to republican headquarters here his assurance that as a condition to the participation of the United States in the world economic conference to be held late this year, "the whole silver question" would be "fully dealt with."

The president's message also said that he would appoint, as a member of the American delegation to the conference, a representative of the silver interests of the United States. Interpreting statements of Franklin D. Roosevelt, democratic candidate for president, in his address here September 19, and of Senator T. J. Walsh as indicating the president remained obstinate to the appeals for relief of the silver producers and had done nothing toward calling a conference on the silver question, Paul D. Hudstoll, chairman of the Silver Bow county central committee, asked the president for a statement on the matter, pointing out that "the people of Montana as well as all of the citizens of other mining states are gravely concerned about and vitally interested in the rehabilitation of silver."

RANGER STOEHR'S PANTS IGNITED

A cigarette, carelessly thrown into a loaded car yesterday afternoon was blamed today for the fire in a pair of corduroy pants, which caused considerable excitement on 81st street yesterday afternoon.

The smoke, evolving from the car, driven in from the mountains by Ranger Al Stoehr, was discovered by Mr. and Mrs. W. S. Gilmore. They investigated, found the trousers which were burning, and had put out the flames, when the owner was found.

MILLS TO ANSWER PITTSBURG SPEECH OF MR. ROOSEVELT

Treasury Leader Says "Still Dodging" Bonus Issue— Ford Endorses Hoover As "Best Man," Presidency.

WASHINGTON, Oct. 20.—(AP)—Secretary Mills today would reply to the speech last night by Franklin D. Roosevelt, objecting to the administration's fiscal policies and expressing himself on the bonus on next Tuesday night in Cincinnati.

The treasury secretary asserted the Democratic nominee was "still dodging" on the bonus issue.

Roosevelt indicated, he told newspapermen, "that if there was a surplus in the treasury he would pay the bonus next week. He hasn't met the issue. He is still dodging. He hasn't indicated whether as President he would sign a bonus bill or not."

NEW YORK, Oct. 20.—(AP)—United States Senator Felix Herbert of Rhode Island, in a statement released today through the eastern division of the Republican national committee, described Gov. Franklin D. Roosevelt's statement on the bonus in Pittsburgh last night as "lethargic."

"It is not a courageous statement of his position on the bonus," the eastern director of the committee said, "it can easily be inferred that if these were the boom times of four years ago, he would be perfectly willing to allow this huge dispensation of public funds to a particular group of citizens for whom Republican congresses have already made ample provision."

OMAHA, Neb., Oct. 20.—(AP)—Secretary of War Patrick J. Hurley today said Governor Roosevelt was "dodging the issue" and resorting to "flagrant misrepresentation" in his presidential campaign speech at Pittsburgh last night.

Discussing the Democratic nominee's governmental economy program in an interview before starting for Chicago, Secretary Hurley cited points on which, he said, Roosevelt "failed" to declare himself.

"His Pittsburgh speech on economy computes him on political cowardice," Hurley said, adding that his discussion of governmental expenditures "was another example of the evasion which has characterized all of his campaign speeches. He was afraid to meet the issue squarely for fear of offending various groups."

DETROIT, Oct. 20.—(AP)—Disavowing any interest in party politics, Henry Ford today was enlisted as a campaigner on behalf of President Hoover.

In a radio address last night—his first of that nature—the automobile manufacturer said that "I support the best man for the job. If Herbert Hoover were a Democrat, with his record during the last four years, I should have to support him."

Much of a money system devoted to the need of "a money system managed as our weather bureau is, for the protection of the people's business," and he said he would "like to see it done by a man of practical experience like Mr. Hoover."

"Congress," he said, "fanned out the national money system to private hands" and "should take back full control of money and give the United States a public service money system as opposed to a private profit money system."

He said President Hoover "is carrying a greater burden than Abraham Lincoln carried—and he is carrying it in a way that places him beside Lincoln in sacrificial service."

"The President," he said, "kept his head when others lost theirs. No act of his has been dictated by panic or politics. And the result is that"
