

HOLD GRAND JURY TO CONSIDER TWO PENDING MATTERS

The present grand jury, of which Thomas N. Bell, Jr., of Talent is foreman, has been continued by the court for the October term of court, which started Monday, October 23. No date has been set for the next session of the grand jury. No matters are at present pressing.

Two cases will be referred to the present grand jury, the court has indicated for consideration. One is the case against Joe Cave, city policeman, indicted by the so-called "Grieve grand jury," for involuntary manslaughter, after a special and a regular grand jury had failed to return a true bill. It is an echo of the "Daback case," which was a political football in the last campaign. The court granted a demurrer to the indictment on the grounds that it did not specifically state sufficient cause.

The defense also claimed that Agitators Banks and Fehl, now serving prison sentences, had appeared before the grand jury as witnesses but had not signed their names to the indictment, as required by law. The two agitators, from their prison cells, made affidavit they had not testified. Two members of the grand jury made affidavit that while Banks and Fehl appeared in the grand jury room, and might have talked about the Cave case, nothing they said was considered as evidence. The other case is that against C. H. Brown, former secretary of the "Good Government Congress," indicted for slandering a bank. The first indictment was ruled defective by the court because of faulty language stating the charge, and referred to the grand jury again by the court.
