WASHINGTON, Nov. 15.—(AP)—The administration today fixed the price of domestic newly mined gold at a point far below the dollar figure abroad.

The dollar, meanwhile, fell from \$5.27 1/2 to the pound at the London opening to \$5.37 1/2. This in turn carried the dollar value of gold at London from \$34.03 to \$34.68.

By contrast, the price of RFC purchases of new mined gold was set at \$33.50, unchanged from yesterday.

The drooping dollar was carrying government bond quotations downward with it. This trend, if continued, would make it extremely embarrassing for the treasury when the time comes to borrow more than \$6,000,000,000 it must obtain in the next year to carry on the recovery program.

GOLD PRICE HOLDS AT TUESDAY MARK

WASHINGTON, Nov. 15.—(AP)—The administration today fixed the price of domestic newly mined gold at a point far below the dollar figure abroad.

The dollar, meanwhile, fell from \$5.27 1/2 to the pound at the London opening to \$5.37 1/2. This in turn carried the dollar value of gold at London from \$34.03 to \$34.68.

By contrast, the price of RFC purchases of new mined gold was set at \$33.50, unchanged from yesterday.
