PERTINENT FACTS FOR AGE PENSION APPLICANTS GIVEN

Must Be 70 Years Or Older Without Kin Legally Responsible—Must Be Oregon Citizens 15 Years

Persons eligible must be 70 years of age or over, without other means to provide for their needs...

Persons applying for pensions must present birth certificates or other convincing evidence...

Maximum payment allowed is \$30 per month. The administering board may use its discretion...

Property limit \$3000. An applicant must not have derived himself, directly or indirectly, of property in order to qualify...

Property owned by an applicant, or jointly by husband and wife, may not exceed \$3000 in value...

The pension board may require that all or part of the property be transferred to the county as condition of granting a pension...

The county may claim the total amount of pension paid, plus 3 per cent interest, from any estate left on death of a pensioned person...

A pension will be revoked if the recipient leaves the state, if he receives property or additional income after granting the pension...

When a pensioner is an inmate of a charitable, fraternal or benevolent institution, the pension shall be paid to the governing authority...
